Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

## NOTES TO FINANCIAL STATEMENTS December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of the Children's Heart Center 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan, which has been adopted by William N. Evans M.D., Ltd dba Children's Heart Center (the Company), became effective January 1, 1999 and consists of the following: (1) a defined contribution employer-matching plan covering all employees of the Company and, (2) an Internal Revenue Service (IRS) Section 401(k) Plan, which is a salary-deferral arrangement covering all employees who elect to participate upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

The Plan provides that participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. Effective February 17, 2022, the Company elected to use a discretionary match of elective deferral contributions of eligible compensation. Previously, the Company suspended matching contributions for the year ended December 31, 2021. As of January 1, 2022, the match was reinstated. The match is 100% of employee deferrals up to 3% and 50% of employee deferrals over 3% up to 5% of eligible compensation. Participants have the option to designate all or any portion of their future contributions as Roth elective deferral contributions.

#### **Vesting**

Participants are immediately vested 100% in all elective deferrals, Company matching contributions, and any earnings thereon.

#### **Participant Accounts**

Each participant's account includes the following amounts: the participant's elective deferral; the Company's matching contribution; any rollovers deposited from other qualified plans; and an allocation of Plan earnings or losses and expenses, which are allocated based on the participant's selection and balance of investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Payment Of Benefits**

A participant is eligible to receive a distribution upon termination of employment, death, disability, or retirement through a mandatory distribution of the participant's total vested balance. If the participant's vested balance is between \$1,000 and \$5,000 and the participant does not elect to have such a distribution paid directly to a qualified retirement plan specified by the participant in a direct rollover (in accordance with the direct rollover provisions of the Plan) or to receive the distribution directly; then the Plan Administrator shall, without the participant's consent, pay the distribution in a direct rollover to an individual retirement account designated by the Plan Administrator.

**In-Service Withdrawals**

Active participants who reach age 59-1/2 may withdraw all or part of their vested accounts.

Active participants who experience a qualifying financial hardship may withdraw all or part of their vested account balance. Hardship withdrawals will be approved only if they conform to the Plan and established IRS safe harbor provisions.

**Administrative Expenses**

The Company pays a portion of administrative expenses incurred by the Plan. The Plan also permits the payment of Plan administrative expenses to be made from the Plan's assets. The expenses are allocated among the assets of all participants in the Plan. Certain other expenses of the Plan are assessed against the individual participants' accounts based on use of particular Plan features by the participants (e.g., distribution fees).

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Contributions Receivable And Credit Loss Policy**

The Accounting Standards Codification Topic 326, *Financial Instruments – Credit Losses* requires entities to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. This estimate must include consideration of historical experience, current conditions and reasonable and supportable forecasts. The standard applies to the Plan's employer contributions receivable.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Investment Valuation And Income Recognition**

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses on investments bought and sold during the year.

**Payment Of Benefits**

Benefit payments are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Financial Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Principal Life Insurance Company and Principal Trust Company (collectively, Principal) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

**4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/Collective Trust And Pooled Separate Accounts**

Valued at the NAV of units, or NAV equivalent, of the individual funds. The NAV, as provided by the trustee of each of the invested funds, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. All of the pooled separate accounts and the common/collective trust held by the Plan are redeemable daily, and all file an annual report on Form 5500 as a direct filing entity. There were no unfunded commitments at December 31, 2024 or 2023.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

## 5. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

## 6. Income Tax Status

The Plan was amended and restated effective February 17, 2022 through the adoption of a pre-approved plan document sponsored by Principal Financial Group. Principal Financial Group received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**7. Party-In-Interest Transactions**

Certain Plan investments are shares of short-term fixed income contracts and pooled separate accounts managed by Principal. Principal is the Custodian as defined by the Plan, and therefore, these transactions qualify as exempt party in interest transactions.

**8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities that changes in the values of investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.
