Independent Auditor's Report

To the Board of Trustees of
1199SEIU/Employer Child Care Fund

Opinion

We have audited the financial statements of 1199SEIU/Employer Child Care Fund (the Plan or Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and Plan's benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in Plan's benefit obligation for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, information regarding the Plan's net assets available for benefits and Plan's benefit obligations as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in Plan's benefit obligation for the years then ended, in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Basis for Opinion

(1) Description of the Fund

The following description of the 1199SEIU/Employer Child Care Fund (the “Fund” or “Plan”) provides only general information. For more detailed information about the Plan and benefit provisions, consult the *Summary Plan Description* available from the Plan Administrator. Full details of the Plan are contained in the official Plan documents, which are available for inspection at the office of the Plan Administrator.

(a) General

The Plan was established by an agreement and declaration of trust dated December 12, 1991. The Plan is a noncontributory, multiemployer (Taft-Hartley), collectively bargained, defined employee welfare benefit fund subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is sponsored by the 1199SEIU United Healthcare Workers East (the “Union or 1199SEIU”), and each of the participating hospital and health care institutions.

(b) Plan Benefits and Eligibility

The Plan provides reimbursements for childcare services, including childcare vouchers, day care centers, summer day camps, after school programs, holiday programs, weekend programs, community service programs, and childcare resource and referral services. An individual becomes eligible for participation in the Plan, if he/she is a member of a bargaining unit represented by the Union, and if the collective bargaining agreement between the individual’s employer and the Union provides for contributions to the Plan for that bargaining unit.

The 1199SEIU/Employer Child Care Corporation (“the Corporation”) provides day care center services to children, including children of certain eligible participants of the Plan that have been selected to receive a childcare center benefit. Benefit payments for program service fees on behalf of eligible participants are made from the Plan to the Corporation.

(c) Funding

The Fund receives contributions pursuant to a number of collective bargaining agreements entered into with contributing employers by the Union. Contributions from employers are based on a percentage of the participating employers’ monthly payroll for covered employees.

On March 9, 2023, the current Memorandum of Agreement, which was effective October 1, 2021 through September 30, 2024, was extended through September 30, 2026. This contract did not change contribution rates.

The Fund also receives revenues from participant co-payments (“program revenue”).

(2) Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Cash and cash equivalents

Cash consists of funds held at TD Bank and Amalgamated Bank in commercial checking accounts and highly liquid short term investment funds consisting of JP Morgan Chase Money Market Fund that are considered cash equivalents.

As of December 31, 2024 and 2023, the Fund held noninterest bearing cash of \$4,994,092 and \$4,142,276 and money market funds of \$6,678,604 and \$5,399,454 respectively. As of December 31, 2024 and 2023, the money market fund is classified as level 1 under the hierarchy leveling criteria under the hierarchy leveling criteria under ASC 820, *Fair Value Measurement*. The valuation methodology of the money market funds is based on unadjusted quoted prices for identical assets in active markets that the Fund has the ability to access.

(c) Depreciation and Amortization

Furniture and equipment are stated at cost, net of accumulated depreciation, and depreciated on a straight-line basis over their estimated useful lives. Leasehold improvements are stated at cost, net of accumulated amortization, and amortized on a straight-line basis over their estimated useful lives or the remaining term of the sublease, whichever is shorter. Expenditures for maintenance and repairs are expensed as incurred, while additions and improvements that extend the life of the asset are capitalized.

(d) Program Expenses

Program expenses are benefit payments to participants and are recorded when paid. Direct program expenses also include expenses that result in the services to eligible members that fulfill the purpose or mission for which the Fund exists, which include expenses associated with the delivery of child care benefits. Indirect program expenses are wages, taxes and benefits paid to staff in support of the programs. Indirect program expenses are recorded on the accrual basis.

(e) Employer Contributions

The Fund recognizes contributions based on the latest executed collective bargaining agreement on an individual employer basis. Accordingly, contribution revenues are recorded based on the rates of the latest signed agreement between the Union and such Employer. Contributions from employers are based on a percentage of the participating employers' monthly payroll for covered employees, and are payable to the Fund during the subsequent month. The Fund recognizes contributions as revenue in the same period in which the wages were earned by the covered employees.

Periodically, the collective bargaining parties may make allocation of contributions to other 1199SEIU Funds, otherwise payable to the Fund. Because the diverted contributions are never received by this Fund, they do not appear on the financial statements. This may result in significant differences from year to year in contributions received. For the years ended December 31, 2024 and 2023, contributions diverted to other 1199SEIU Funds totaled approximately \$3.0 million and \$6.7 million, respectively.

(f) Receivables and Liabilities

The carrying value of receivables and liabilities approximate their fair values.

(g) Allowance for Doubtful Accounts

Management of the Fund evaluates employer contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. As of December 31, 2024 and 2023, the allowance for doubtful accounts consists of the following:

(h) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“US GAAP”) requires management to make estimates and assumptions that affect the reported amount of assets, liabilities and changes therein and disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements and accompanying notes. Actual results could differ from those estimates.

(3) Benefit Obligations

Benefit obligations consist primarily of amounts payable at the end of the year related to certain childcare expenses provided by the Fund for eligible members in accordance with US GAAP. Each of the programs is governed by specific rules as described in the summary plan description.

(4) Tax Status

The Plan is qualified pursuant to section 501(c)(9) of the Internal Revenue Code (“IRC” or “Code”) and, accordingly, is exempt from income taxes. The Internal Revenue Service has determined and informed the Plan by a letter dated May 12, 1994, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, Fund management and legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Termination of the Plan

Although they have not expressed any intention to do so, the Plan’s Board of Trustees has the right to amend or terminate the Plan subject to the provisions set forth in ERISA. Furthermore, the Union and a majority of employers may terminate the Plan pursuant to a mutual agreement.

(7) Related-Party Transactions and Administrative Expenses

(a) *Related Parties*

On October 20, 1998, the Corporation was incorporated under the New York State Not-For-Profit Corporation Law. The Corporation is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code. The Corporation's purpose is to establish and operate Day Care Centers and other childcare related services. The Plan is the sole member of the Corporation.

The Corporation operates a day care center called the 1199 Future of America Learning Center ("FALC"), located at 2500 Creston Avenue, Bronx, New York. FALC provides a full day of age-appropriate learning activities, meals/snacks and playtime. Program service fees from eligible parents are determined using a sliding fee scale. Various grants, including from the Department of Education, provide general funding for the entire center. Plan payments for eligible participants cover the remaining costs for eligible parents. Ineligible parents are required to pay program service fees or apply for additional grant funds covering total costs of the program. Acceptance is determined by established eligibility guidelines and availability of space based on the child's age.

In addition, the Corporation administers an overnight summer camp program, a youth mentoring program and the selection and distribution of scholarships as part of its Youth Services Program ("YSP"). Further, the Corporation develops and administers direct programs such as Workforce 2000 and Summer Day Camp programs for Corporation and Plan participants.

In October 2002, the 1199SEIU/Greater New York Child Care Fund ("Greater CCF") was established by an agreement and declaration of trust. It is a plan created to provide and maintain childcare services and program options to assist participants with their childcare needs. Greater CCF is subject to the regulations of the U.S. Department of Labor and the provisions of ERISA. It is a Taft-Hartley employee benefit trust fund. Greater CCF is sponsored by the Union and the Greater New York Health Facilities Association.

(b) *Shared and administrative expenses*

For some central administrative operations, the Fund and certain other 1199SEIU related funds (collectively the “Related Funds”) are administered by the same personnel and share the same office space and other administrative services.

In addition, certain central administrative expenses attributable to all the Related Funds are paid by the 1199SEIU National Benefit Fund for Health and Human Service Employees (“NBF”) for all the Related Funds. Expenses are then pooled and allocated among the Related Funds based on an allocation study reviewed by an external consultant. The 2024 allocations were based on an allocation study that was approved on December 13, 2023 and the 2023 allocations were based on an allocation study that was approved on December 11, 2021.

In addition, certain other administrative expenses are allocated among the Fund, Greater CCF and the Corporation. First, shared expenses are allocated to the Corporation based on employee time studies. Then, after allocating these shared expenses, the remaining shared operations expenses are allocated between the Fund and the Greater CCF. These allocations are subject to the approval of the respective Boards of Trustees of the Fund and Greater CCF and of the Board of Directors of the Corporation. For the years ended December 31, 2024 and 2023, total shared operations expenses charged by the Plan to Greater CCF based on the allocation methodology amounted to \$261,769 and \$624,427, respectively.

As of December 31, 2024, the Fund had amounts due from related parties of approximately \$1.6 million of which approximately \$794,000 is due from 3BF Partners, approximately \$661,000 is due from NBF related to commingled contributions, and approximately \$121,000 from the Corporation related to shared costs and interfund settlements, and approximately \$3,000 due from other related entities. As of December 31, 2023, the Fund had amounts due from the related parties of approximately \$2.9 million which includes approximately \$2.6 million due from NBF primarily related to commingled contributions, and approximately \$260,000 due from NBF for administrative expenses, approximately \$121,000 due from GNYCCF for shared costs and interfund settlements.

As of December 31, 2024, the Fund had amounts due to related parties of approximately \$504,000 due to Greater CCF related to shared expenses. As of December 31, 2023, the Fund had amounts due to related parties of approximately \$31,000 due to CCC related to shared expenses, and \$3,000 due to TUF.

(8) Commitments and Contingencies

All rent expense at the Headquarters Building is paid by NBF. These expenses are then pooled and allocated among the Related Funds based on the allocation study reviewed by an external consultant. Rent expense allocated by NBF to the Fund and included in shared administrative expense was approximately \$0.9 million for the years ended December 31, 2024 and 2023, respectively.

Additionally, the Fund is the subtenant for certain space at 259 Monroe Avenue, Rochester, New York effective May 1, 2022 to October 31, 2027.

(9) Participation in Multiemployer Plans

Defined Benefit Pension Plan

The Fund provides benefits to its employees through participation in the 1199SEIU Health Care Employees Pension Fund (“NPF”) which is a multi-employer defined benefit plan. The risk of participating in multiemployer defined benefit pension plans, from the perspective of an employer, is different from single employer plans. Assets contributed to a multiemployer defined benefit pension plan by one employer are pooled with the assets contributed by other employers to provide benefits to employees of all such participating employers. If a participating employer stops contributing to the Plan, the unfunded obligations of the Plan may be borne by the remaining participating employers.

Pension contributions are made monthly based on a percentage of eligible salaries paid by the Fund. The NPF contribution rate applicable to the Fund is 11.30% of gross payroll.

The Fund’s participation in NPF for the years ended December 31, 2024 and 2023, is outlined in the table below. Unless otherwise noted, the Pension Protection Act (PPA) zone status noted below is for the Plan years beginning January 1, 2025 and 2024, respectively. The zone status is certified by the Plans’ actuaries. Among other factors, plans in the red zone are generally less than 65% funded, plans in the yellow zone are less than 80% funded, and plans in the green zone are at least 80% funded. The “FIP/RP Status Pending/Implemented” column indicates plans for which a financial Improvement plan (FIP) or a rehabilitation plan (RP) is either pending or has been implemented. The “Surcharge Imposed” column indicates whether a surcharge has been imposed on contributions to the Plan. The last column lists the expiration date of the collective-bargaining agreement to which the Plan is subject. There have been no significant changes that affect the comparability of 2024 and 2023 contributions.

Deferred Contribution Retirement Plan

All full-time employees of the Fund are also eligible to be participants in the 1199SEIU National Benefit Fund and Affiliated Organizations 401(k) Plan (the “401(k) Plan”). The 401(k) Plan is a defined contribution, participant-directed account plan. Participants may elect to make pretax contributions to the 401(k) Plan, through regular payroll deductions, in amounts from 1% to 100% of their base salary (as defined by the 401(k) Plan) subject to the maximum allowable under the Code. The Fund currently does not make any employer matching contributions. Participants are always fully vested in their contributions plus actual earnings thereon.

Welfare Plan

The Fund’s employees are covered by NBF which provides medical benefits to eligible employees and its dependents. Contributions to this plan for the years ended December 31, 2024 and 2023 totaled approximately \$1.6 million and \$1.7 million, respectively.

(10) Concentration of Credit Risk

Financial instruments that subject the Fund to concentration of credit risk consist of cash and cash equivalents. The Fund maintains accounts at high quality financial institutions. While the Fund attempts to limit any financial exposure, its cash deposit balances may, at times, exceed federally insured limits. The Fund has not experienced any losses on such accounts. Short-term investments are not covered by the Federal Deposit Insurance Corporation.

(11) Risks and Uncertainties

Preparing financial statements requires management to make estimates and assumptions about current, and for some cases future, economic and market conditions which affect reported amounts and related disclosures in the financial statements. Although current estimates and assumptions contemplate current conditions and how management expects them to change in the future, as applicable, it is reasonably possible that in the near term those estimates and assumptions could change which would have a material impact on amounts currently reported. These changes would impact future financial statements in accordance with US GAAP.

Examples of some of the more significant assumptions and estimates are as follows:

Benefit obligation is reported based on projected benefit payments payable during the subsequent year based on eligibility at December 31, 2024, all of which are subject to change. Due to uncertainties inherent in the estimations, it is reasonably possible that changes in these estimates would be material to the financial statements.


