## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The Weather Shield Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Weather Shield Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **NOTE 1 - Description of Plan**

The following description of The Weather Shield Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan, as adopted effective December 1, 1989, and restated January 1, 2021, covering all employees of Weather Shield Manufacturing, Inc. (the "Company") who have met the eligibility requirements to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Participants may elect to contribute a portion of their compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently has automatic enrollment for newly hired or rehired employees who are not participating in the Plan, except for employees who have affirmatively elected in writing not to participate. The automatic enrollment feature provides that, unless elected otherwise by the employee, a salary deferral of 8% will be contributed to the Plan as a designated Roth contribution. Employees contributing via the automatic enrollment feature will have their deferral percentage increased annually by 1% until they reach a deferral percentage of 15%.

The Company may make a discretionary matching contribution. Additionally, the Company may also make discretionary profit-sharing contributions. Participants who worked 1,000 hours and are employed on the last day of the Plan year will share in the discretionary profit-sharing contributions based on relative compensation. The Company made discretionary matching contributions of \$603,246 and \$668,659 to the Plan for the years 2024 and 2023, respectively. There were no discretionary profit-sharing contributions made to the Plan for 2024 and 2023.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's discretionary matching contributions, (b) the Company's discretionary profit-sharing contributions, and (c) Plan earnings. Participant accounts are charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting** - Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after 6 years of credited service. Participants who are employed on or after their normal retirement age (65), or are terminated due to death or disability, are automatically 100% vested in all employer contributions.

**Payment of Benefits** - Benefit payments may commence upon termination of employment, death, disability, or attainment of normal retirement age. A participant with an account balance exceeding \$5,000, may elect to receive the value of his or her vested account balance in the form of a lump-sum distribution, direct rollover to an eligible retirement plan, or partial payments as defined by the Plan. Participant accounts with an account balance up to \$1,000 are paid in a lump sum as soon as feasible. Participant accounts with a value greater than \$1,000 (including amounts attributable to rollover contributions) and not exceeding \$5,000 will be directly rolled over into an individual retirement plan

designated by the Plan administrator, unless the participant elects to have the distribution paid directly (in a direct rollover) to an eligible retirement plan.

**Participant Loans** - Effective September 9, 2005, loans to participants are no longer permitted. The Plan will continue to administer existing loans in accordance with Plan provisions.

**Forfeited Accounts** - Non-vested portions of participants' accounts will be forfeited upon termination of employment. These amounts will be used to offset administrative expenses or reduce future employer contributions. Forfeitures will be restored if the employee resumes participation before five consecutive one-year breaks in service, and in the case of participants receiving a distribution of vested benefits, only upon their repayment of the full distribution within five years of resuming participation in the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$55 and \$56,250, respectively. During 2024 and 2023, forfeitures from nonvested accounts of \$169,655 and \$103,025, respectively, were used to offset Plan expenses and employer matching contributions.

**Administrative Expenses** - All administrative expenses, including fees and expenses connected with providing administrative services by external service providers, may be paid out of the Plan unless paid by the Company. During 2024 and 2023, both the Plan and Company paid expenses.

**NOTE 2 - Summary of Significant Accounting Policies**

A summary of significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedule is as follows:

**Basis of Accounting and Presentation** - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with the accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. As of December 31, 2024 and 2023 all outstanding notes receivable from participants were in default status and a corresponding allowance for uncollectible accounts was recorded for the remaining balance of any outstanding notes receivable. Defaulted loans will continue to be included as part of participant account balances until a distributable event occurs, upon which the participant's defaulted loan balance will be offset against their account balance.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Use of Estimates** - The preparation of financial statements in conformity U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

**NOTE 4 - Fair Value Measurements**

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- **Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - Information Certified by the Plan Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from the information furnished to the Plan administrator and certified as complete and accurate by Newport Trust Company, the trustee of the Plan.

**NOTE 6 - Tax Status**

The Plan obtained its latest determination letter dated November 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 7 - Transactions With Parties-in-Interest**

Fees for legal and professional services rendered to the Plan may be paid for by the Company at its discretion. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**NOTE 8 - Amounts Owed to Participants Withdrawing from the Plan**

Amounts owed to participants who had elected to withdraw from the Plan, but had not been paid totaled \$5,000 and \$0 as of December 31, 2024 and 2023, respectively.

**NOTE 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.
