Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kevane Grant Thornton Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Nationwide Trust Company, FSB and Nationwide Life Insurance Company, (qualified institutions), the custodians of the Plan, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kevane Grant Thornton Retirement Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of plan:

The following description of the Kevane Grant Thornton Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

(a) General –

Effective October 1, 2007, Kevane Grant Thornton LLP (the Sponsor) adopted a defined contribution retirement plan, for the purpose of providing retirement benefits to substantially all employees who have attained twenty-one (21) years of age and who have completed six (6) months of service. As of December 31, 2023 and 2022 there were 200 and 179, respectively, active participants with account balances in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Partners of the Sponsor serve as the trustees of the Plan. Nationwide Trust Company, FSB and Nationwide Life Insurance Company (Nationwide) are the Plan's custodians of assets. Nationwide Trust Company, FSB also serves as the recordkeeper. Trust administrative services are managed by Pension Services, Inc.

(b) Eligibility –

The Plan covers all employees of Kevane Grant Thornton LLP, after completing six (6) months of service and attaining a minimum age of twenty-one (21).

(c) Contributions –

Each year, participants may contribute up to \$15,000 of pretax annual compensation, as defined by the Plan. Participants with at least fifty (50) years of age at the end of the plan year are eligible to make catch-up contributions up to \$1,500.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct all or a portion of the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and fixed annuities as investment options for participants.

(d) Participant accounts –

Each participant's account is credited with the participant's contribution and Plan's earnings (losses). Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) Vesting –

Participants become immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based in accordance with the following schedule:

1 year	0%
2 years	20%
3 years	40%

(f) Payment of benefits –

On termination of service due to death, disability, or retirement, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution, or annual installments equal to the participant's vested account balance. In addition, hardship distributions are permitted if certain criteria are met.

- (g) Notes receivable from participants – Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's accounts and bear interest at prime plus one (1) percent. The prime rate was 7.50% and 8.50% at December 31, 2024 and 2023, respectively. Principal and interest is paid through payroll deductions. A loan origination fee may be charged to the participant's account.
- (h) Forfeited accounts – Forfeited non-vested accounts are to be used to reduce future employer contributions. As of December 31, 2024 and 2023, the forfeited non-vested account totaled \$62,645 and \$48,025, respectively. During 2024, no forfeitures were used to reduce employer contributions.

(2) Summary of significant accounting policies:

- (a) Basis of accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- (b) Basis of presentation – The Plan's fiscal year ends on December 31st of each year. All references to years in these notes to the financial statements represent calendar years unless otherwise noted.
- (c) Use of estimates – The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (d) Investment valuation and income recognition – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- (e) Risks and uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of certain investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
- (f) Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.
- (g) Excess contributions payable – Amounts payable to participants for excess contributions allowed by the Plan are recorded as a liability with a corresponding reduction in contributions.

(h) Benefits payments recognition –

Benefits paid directly to participants are recorded when paid.

(i) Plan administration and expenses –

The Sponsor is responsible for the general administration of the Plan and for carrying out the provisions thereof. The investments of the Plan are administrated by a third-party administrator appointed by the Trustees of the Plan. Most of the administrative expenses are paid and absorbed by the Sponsor. Investment related expenses are included in net appreciation of fair value of investments in the accompanying statement of changes in net assets available for benefits.

(3) Information certified by qualified institutions:

Certain information disclosed in the accompanying financial statements and supplemental schedule of assets, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Trust Company, FSB and Nationwide Life Insurance Company, the Plan's custodians of assets.

(4) Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Fully benefit-responsive investment contract:

The Plan invests in a fully benefit-responsive investment contract with Nationwide Life Insurance Company (Nationwide Life). The investment was identified by the Plan as a fixed select contract which is maintained by Nationwide Life in a general account. The fixed interest account issuer, Nationwide Life, is contractually obligated to repay the principal and the specified guaranteed interest rate to the Plan. The fixed select contract does not have a maturity date. The provisions do not provide for a distribution at book (contract) value at some specified future date. A contract holder can request a lump sum distribution with a market value adjustment, or an installment payout, at book value, over a period of years. The fixed select contract continues in force until all assets have been distributed, or no further payments are due.

As described in Note (2)(d), because the fixed select contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed select contract. Contract value represents contributions, plus earnings, less participant withdrawals.

As of December 31, 2024 and 2023, the Plan reported the fixed select contract at contract value of \$169,438 and \$1,348,096 respectively, in the statements of net asset available for benefits. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield for the year ended December 31, 2024 was 1.61%, and is reviewed on a quarterly basis for resetting. The net rate, crediting rate and average yield earned are the same.

The Plan's ability to receive amounts due is dependent on Nationwide Life's ability to meet its financial obligations. Nationwide Life's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with Nationwide Life. Such events include the following: (1) amendments to the Plan documents (included complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Sponsor or other Sponsor's events that cause significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from income taxes or any required prohibited transactions under ERISA.

Furthermore, certain events and circumstances that may permit Nationwide Life to terminate the contract and settle at amounts that differ from contract value including: (1) to protect Nationwide Life from adverse financial impact due to an amendment or modification of the Plan, changes in the administrative practices adhered to by the Plan, or the action of any legislative, judiciary, or regulatory body which impacts this contract, (2) when, in the opinion of Nationwide Life, it is unable to fulfill its obligations under the contract, (3) willful fraud or misrepresentation on the part of the contract holder, and (4) when, in the opinion of Nationwide Life, the contract is no longer viable for economic reasons. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants or with Nationwide Life are probable of occurring.

(6) **Party-in-interest transactions:**

Pension Services, Inc., Nationwide and its affiliates receive an administrative fee for administration, custodial, investment management and recordkeeping services provided to the Plan. In addition, certain administrative functions are performed by the officers or employees of the Sponsor. The Plan allows for loans to participants which are secured by the balances in the participant's accounts.

(7) **Prohibited party-in-interest transactions:**

During the year ended December 31, 2019, participants' contributions amounting to \$24,369 were not timely remitted to the Plan as required by the Department of Labor's Regulation 29 CFR 2510.3-102. Those late contributions were remitted to the Plan before December 31, 2019. Applicable lost earnings of \$102 are in process for payment.

(8) **Administrative expenses:**

Pension Services, Inc. and Nationwide, receive an administrative fee for the services performed under the Plan Agreement associated with administration, custodial, investment management and recordkeeping services. Total administrative fees for the year ended December 31, 2024 paid directly by the Sponsor to Pension Services Inc. amounted to \$11,025. In addition, other administrative expenses amounting to \$12,696 paid directly from the Plan to Nationwide are included in the statement of changes in net assets available for benefits. Certain administrative functions are performed by the officers or employees of the Sponsor. No such officers or employees receive compensation from the Plan.

(9) **Plan termination:**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, the rights of all affected participants in their accounts, up to the date of such termination, shall become no forfeitable.

(10) **Tax status:**

The Plan intends to be exempt from Puerto Rico income taxes as per the 2011 Puerto Rico Internal Revenue Code which was approved effective for taxable years starting after December 31, 2010. The Sponsor filed the required documentation with the Puerto Rico Treasury Department (PRTD) on November 18, 2015 and received a determination letter dated April 4, 2017 in which the PRTD stated the Plan is designed and is currently being operated in compliance with the applicable requirements of the PRTD and the trust established thereunder is entitled to exemption from local income taxes.

Management has evaluated the Plan's tax positions and concluded that the Plan has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The plan administrator believes it is no longer subject to income examination for years prior to 2020.

(11) **Excess contributions payable:**

The accompanying statement of net assets available for benefits discloses \$2,737 as excess contributions payable, due to an involuntary error in eligibility requirements of a participant during the year ended December 31, 2023. This amount was subsequently paid to the participant on January 5, 2024.

(12) **Subsequent events:**

The Plan has evaluated the impact of subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Effective on January 1, 2025 the Plan changed its custodian and recordkeeper of plan assets to Empower Trust Company, LLC and Empower Annuity Insurance Company of America, respectively. Following a transitional blackout period the Plan's assets were transferred on January 6, 2025 to the new custodian and converted into
