**NOTE 1 – PLAN DESCRIPTION**

**Plan Description**

The following description of the Blue Crab Corporate Services, LLC 401(k) Plan (the “Plan”), established in 2017, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is sponsored by Blue Crab Corporate Services, LLC and includes other participating employers, Bay Clinical Laboratories, LLC, Project Chesapeake, LLC, and University Psychological Center Inc. (the “Companies”).

**General**

The Plan is a defined contribution profit sharing plan covering substantially all employees of the Plan sponsors. Participant must be 21 years of age to participate in the Plan. Employees are eligible to participate in the Plan on the first day of the month coinciding with or the next following date of the completion of three months of service. Employees are automatically enrolled in the plan upon eligibility. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Economic Growth and Tax Relief Reconciliation Act of 2001 (“EGTRRA”).

**Participant Contributions**

Participants may contribute pretax annual compensation as defined by the Plan, up to a maximum of \$23,000 during the 2024 plan year. Participants over the age of 50 are also allowed additional catch-up contributions up to \$7,500 for 2024. The Plan also permits Roth 401(k) contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Distributions from other qualified retirement plans can also be contributed to the Plan and retained as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Employer Contributions**

The Companies make safe harbor matching contributions equal to 100% of the salary deferrals that do not exceed 1% of compensation plus 50% of salary deferrals between 1% and 6% of compensation. The Companies may make discretionary profit-sharing contributions. This contribution, if any, is determined by the Companies with respect to each Plan year. There were no discretionary profit-sharing contributions made during 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Individual accounts are maintained for each participant and include participants' salary deferral contribution, rollover contributions and distributions, plus an allocation of the Plan Sponsor's safe harbor contributions and profit-sharing contributions, Plan earnings (losses), including realized and unrealized gains and losses on investments, and Plan administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their salary deferral, including Roth 401(k) deferrals and catch-up contributions, rollover contributions, and related earnings. Participants who retire, die, or become totally and permanently disabled are entitled to the full amount in their account. Participants who terminate employment prior to 100% vested are entitled to a percentage of their profit sharing contributions and employer match contributions accounts depending on their years of service based on the following schedule:

Safe harbor contributions become fully vested after two years of service.

**Investment Options**

Participants may direct Reliance Trust a Fidelity Information Services, LLC Company (the "Trustees"), as to the investment of their account balances into various investment options offered by the Plan. The Plan currently offers various annuities and guaranteed portfolio funds as investment options for participants. Participants may change their investment directions at any time, subject to such restrictions and procedures as established by the recordkeeper, and the Plan.

**Notes Receivable from Participants**

Participants may borrow not less than \$500 from their fund accounts up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Loan transactions are treated as transfers between the investment fund and the participant loan fund. Loan terms are not to exceed five years, unless the loan was for the purchase of a primary residence, which can be for a term up to thirty years. The loans are secured by a fifty percent security interest in the participant's vested account balance and bear interest at a fixed rate for the life of the loan. As of December 31, 2024 and 2023, interest rates ranged from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

The Plan allows for distributions upon termination of service, death, disability, attainment of age 59 ½ or in certain hardship situations while actively employed. A participant may elect to receive a lump sum payment or installment payments, rollover the value of their account into another qualified plan, or a combination.

Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed by the employee may be withdrawn for a hardship purpose. Hardship withdrawals are subject to IRC restrictions and penalties.

**Forfeitures**

Forfeitures of the non-vested portion of a participant's employer matching account are primarily used to pay plan administrative costs or to reduce the employer's matching contribution. Alternatively, forfeitures may be allocated to participants as an additional matching contribution. In December 31, 2024 and 2023 non-vested employer contribution forfeitures were \$79,012 and \$82,235, respectively.

**Plan Administrative Costs**

The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are paid either directly by the Plan Sponsor or by the account of the participant. Plan participants paid \$29,194 of administrative costs for the year ended December 31, 2024.

**NOTE 2 –SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared in accordance with U.S. generally accepted accounting principles (“U.S. GAAP”) on the accrual basis.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded when earned. Net change in fair value includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year. See Note 9 for discussion of fair value measurements.

**Risks and Uncertainties**

The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**Deferred Payment of Benefits**

Net assets available for plan benefits include \$761,400 and \$801,501 at December 31, 2024 and December 31, 2023, which represent deferred vested benefits for participants who have withdrawn from the Plan but have not been paid. Benefit deductions are recognized when paid. Benefits paid to participants are recorded when paid.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Allowance for credit losses**

In accordance with ASC Topic 326 – Financial Instruments – Credit Losses, the Companies assess the need to record an allowance on financial assets. The Companies evaluate the collectability of its financial assets by considering various factors, including historical loss experience, current economic conditions, and reasonable and supportable forecasts of future conditions. The allowance for credit losses is determined using the current expected credit loss (CECL) model, which requires the Companies to estimate expected credit losses over the life of the financial asset. The Companies consider the following factors in estimating credit losses:

- The historical credit loss experience of similar financial assets
- Current and future economic conditions and forecasts, including customer creditworthiness and industry-specific risks
- The aging of accounts receivable and other outstanding balances
- The nature and credit risk of individual receivables and loans

The provision for credit losses is recorded in the period in which the estimated credit losses are recognized, and adjustments are made to the allowance for credit losses based on changes in the estimate of expected credit losses. As of December 31, 2024 and 2023, there was no material impact to the financial statements in regard to the allowance for credit losses.

**Subsequent Events**

Events that occurred subsequent to December 31, 2024 have been evaluated by the Company's management for potential recognition or disclosure in the financial statements through the date of the independent auditor's report, which is the date the financial statements were available to be issued. The Company did not have any material recognizable subsequent events during this period. Management has determined no events occurred that would require recognition.

**NOTE 3 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and assets of the Plan will be distributed in accordance with the Plan's provisions.

**NOTE 4 – TAX STATUS**

The Plan is qualified pursuant to Section 401(a) of the Internal Revenue Code and, accordingly, the net investment income is exempt from income taxes. The Plan obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving its latest determination letter. However, the plan administrator and the Plan’s management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**NOTE 5 – EXCESS PARTICIPANTS’ CONTRIBUTIONS**

At December 31, 2024 and 2023, the Plan had no accrued payables for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service. If applicable, excess contributions outstanding at year-end will be repaid to the respective participants in the subsequent period.

**NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

The administrator of the Plan is Automatic Data Processing, Inc., who receives fees from Plan participants (see Note 1). The custodian of the Plan is Reliance Trust Company a Fidelity Information Services, LLC, who acts as the Plan’s trustee and who receives fees as a reduction of the return earned on each fund. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**NOTE 8 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 9 – FAIR VALUE MEASUREMENTS**

The Company accounts for the fair value of its investments under the Fair Value Measurement topic of the FASB Accounting Standards Codification (“ASC”) 820, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under this guidance are described as follows:

**Level 1** – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

**Level 2** – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

**Level 3** – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Registered Investment Companies (Mutual Funds)**

Mutual funds represent investments (mutual funds) held with various investment managers. The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. There have been no changes in the methodologies used at December 31, 2024.

CCT’s are public investment vehicles valued using NAV to estimate fair value provided by the underlying administrator of the fund.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
