INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of
Gardiner & Theobald Inc. 401(k) Profit Sharing Plan**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gardiner & Theobald Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF PLAN

The following description of the Gardiner & Theobald Inc. 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) Profit Sharing Plan under the Internal Revenue Service (“IRS”) Code Section 401(k) effective January 1, 2000. The Plan was last amended and restated effective October 1, 2023. The Plan covers substantially all employees of Gardiner & Theobald Inc. (the “Company”) who are not covered by a collective bargaining agreement under which retirement benefits were the subject of good faith, not considered leased employees, interns, and are not nonresident aliens who do not receive any earned income from the Company. Participants must be 21 years of age to participate. The effective date of participation for contributions is the first day of the month coincident with or following the completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan allows for pre-tax Salary Deferrals and Roth contributions. Participants who have attained age of 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may rollover eligible amounts from other qualified plans to the Plan which are fully vested and non-forfeitable. Participants direct the investment of their balances into various investment options offered by the Plan. If no election is made by the participant, then the contributions are automatically invested in the Plan's Qualified Default Investment Alternative (“QDIA”). The Plan has elected the T. Rowe Price Retirement Fund series as its QDIA. The Company may currently make matching contributions and non-elective contributions to the Plan. The Company made a discretionary employer matching contribution equal to the sum of 100% of the amount of the participant's elective deferrals up to \$3,000. For the year ended December 31, 2024, the Company contributed a discretionary employer matching contribution of \$412,720 to the Plan. The Company did not make any other employer contributions to the Plan. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided

from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and legacy safe harbor contributions plus actual earnings thereon. Vesting in the Company's non-elective and matching contributions portion of their accounts is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The interest rates on outstanding loans range from 4.25% to 10.50% per annum. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account or a partial withdrawal of vested accounts. Participants shall be entitled to receive in-service withdrawals upon attainment of age 59 1/2, when the participant reached Normal Retirement Age, as defined, or as a hardship distribution, as defined.

Forfeitures

The Company uses forfeited amounts to reduce employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$52,496 and \$76,363, respectively. During the year ended December 31, 2024, \$72,532 of forfeitures were used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and employer contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

3. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, investments at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust

Collective Investment Trusts are not publicly quoted and are priced at net asset value ("NAV"). ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value.

5. GROUP ANNUITY CONTRACT

On June 23, 2009, the Plan entered into a fully benefit-responsive guaranteed investment contract with ING Retirement Insurance and Annuity Company (now, Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The contract value of the investment contract at December 31, 2024 and 2023, was \$414,493 and \$414,103, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 2%. The crediting rate is reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contract obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

On October 1, 2023, the Plan entered into an arrangement where Fidelity Workplace Services LLC serves as the current recordkeeper and Fidelity Management Trust Company serves as trustee of the Plan. In connection with the transfer of Plan assets and records, the Plan initiated a spread payment option in connection with the guaranteed investment contract with Voya. This option ceases further contributions to the investment and provides for equal installment payments of principal and interest through 2028. During such time, requests for additional withdrawals will be limited according to the contract terms and conditions.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fidelity Workplace Services LLC is the recordkeeper of the Plan and therefore certain transactions qualify as party-in-interest transactions. \$20,446 in administrative fees were paid to Fidelity from the Plan during the year ended December 31, 2024.

UBS Financial Services Inc. is the Plan's investment advisor, and therefore, certain transactions qualify as exempt party-in-interest transactions. Advisor fees of approximately \$37,300 were paid to UBS Financial Services Inc during the year ended December 31, 2024.

Executive Retirement Plans is the Plan's third party administrator, and therefore, certain transactions qualify as exempt party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contribution.

8. TAX STATUS

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended and restated to include an eligible automatic contribution arrangement (“EACA”). New employees who meet the eligibility requirement on or after the effective date, will be automatically enrolled into the Plan with an elective deferral rate of 6% of compensation if the employee does not make an affirmative deferral election. Under EACA, automatically enrolled participants will have their deferral rate automatically increased in increments of 1% per year up to maximum of 15%, unless a participant affirmatively elects otherwise.
