**NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 And 2023**

**1. General Information**

**Description Of The Plan**

The following description of the Quapaw Tribe of Oklahoma (O-Gah-Pah) Commercial 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for more complete information.

**General**

The Plan is a defined contribution plan sponsored by Downstream Casino, Eagle Creek Golf Club, and Saracen Casino Resort (collectively, the Company) for the benefit of eligible employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Under the terms of the Plan, all employees are eligible to participate in the Plan upon completing 90 days of service.

**Contributions**

Eligible employees may contribute up to 100% of pretax annual compensation, as defined by the Plan Agreement. Participants age 50 or older may also contribute amounts representing catch-up contributions. The Plan allows participants to make after-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution and defined benefit plans (rollover). Contributions are subject to certain limitations as defined by the Internal Revenue Service (IRS).

The Plan was amended to change the Company matching contribution to be a safe harbor matching contribution of 100% of participant contributions up to 3% of compensation plus 50% of participant contributions that exceed 3% of compensation but do not exceed 5% of compensation. For plan years 2024 and 2023, the safe harbor matching contribution was \$1,798,935 and \$1,792,540, respectively.

The Company can also make a discretionary profit sharing contribution, which is determined by management on an annual basis, subject to certain limitations. For the Plan years ended December 31, 2024 and 2023, the Company made no discretionary profit sharing contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company discretionary matching, safe harbor matching, and profit sharing contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Investments**

Participants direct their deferral and Company contributions to any of the available investment fund options. Participants may change their investment options at any time throughout the year.

**Vesting**

Participants are immediately vested in their elective deferral contributions, discretionary matching contributions, discretionary profit sharing contributions, and related investment earnings.

**Forfeitures**

Participants who terminate their employment and are less than 100% vested in their account will forfeit their nonvested portion. Forfeitures are used to reduce Company contributions or pay administrative expenses. Forfeitures of \$10,141 were used to pay administrative expenses during 2024. No forfeitures were used to reduce Company discretionary matching contributions or pay administrative expenses during 2023. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,757 and \$3,844, respectively.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term of the loans can not exceed five years, and participants may not have more than one loan outstanding at any time. Loans are secured by the participant's vested account balance and bear interest at rates which are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment Of Benefits**

Upon the participant's death, retirement or separation from service, the participant may elect to receive a lump-sum amount equal to the participant's vested interest in his or her account, as defined by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained the age of 59½.

**Participant Hardship Withdrawals**

A participant is permitted to withdraw from the Plan a portion of their account in the event of undue financial hardship.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net change in the fair value of investments.

**2. Summary Of Significant Accounting Policies**

**Basis Of Presentation**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Use Of Estimates**

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States. Those estimates and assumptions affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could vary from those estimates.

**Investment Valuation And Income Recognition**

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment consider historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for expected credit losses was necessary at December 31, 2024 or 2023.

**Payment Of Benefits**

Benefit payments to participants are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Investment Information**

The Plan Administrator has obtained certifications from BOKF and Reliance that the information provided to the Plan Administrator related to the following information is complete and accurate to the best of their knowledge and belief.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule of assets held at end of year related to the following assets as of December 31:

#### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

**Mutual Funds**

Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and have been classified within Level 1 of the fair value hierarchy.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodology used at December 31, 2024 or 2023.

**5. Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan and the Plan Sponsor.

During the years ended December 31, 2024 and 2023, certain administrative expenses were paid directly by the Plan.

**6. Income Tax Status**

Effective June 1, 2022, the Plan was restated by adopting a pre-approved 401(k)/profit sharing plan document sponsored by Bank of Oklahoma Financial Corporation. Bank of Oklahoma Financial Corporation received an opinion letter from the IRS dated June 30, 2020, which states that the pre-approved 401(k)/profit sharing plan document satisfies the applicable provisions of the Code. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**7. Party In Interest Transactions**

Certain Plan investments are mutual funds managed by an affiliate of BOKF. Additionally, certain participants in the Plan have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as allowable party in interest transactions under ERISA.

**8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.
