Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. PLAN DESCRIPTION

The following brief description of the MBS OPCO, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan, which began in 2000 was established by Wicks Broadcast Solutions, LLC, subsequently through merger and reorganization became MBS OPCO, LLC 401(k). Prior to the year ending December 31, 2018 the plan name was Marketron Broadcast Solutions, LLC 401k Plan. The Plan is a defined contribution plan covering substantially all employees of MBS OPCO, LLC (the Sponsor). Ascensus Trust Company serves as the trustee and third party administrator for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Pension Protection Act of 2006. The investment committee of the Sponsor control and manage the operations and administration of the Plan. Ascensus Trust Company (Trustee) serves as the trustee of the Plan.

##### Eligibility and Entry Date

Employees may enter the Plan on the first day of the month following the date on which the employee is hired provided they have attained the age of 21.

##### Contributions

Participants may elect to have the Sponsor contribute their eligible pre-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulations. The Plan also permits the automatic enrollment of eligible employees in the Plan with a contribution of 3% of eligible compensation, unless the employee affirmatively elects otherwise. Effective January 1, 2015, the Plan permits an automatic escalation of 1% each year up to a maximum of 10% unless the employee affirmatively elects otherwise. Participants who elect to have the Sponsor contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

The Sponsor is allowed to make matching contributions as defined in the Plan and as approved by the Board of Directors. The Plan adopted a safe-harbor match where participants receive 100% of their first 1% deferred, and 50% of any additional deferrals up to 6%. The Plan also allows for a discretionary profit sharing contribution. No discretionary profit-sharing contribution has been made for the years ended December 31, 2024 and 2023.

##### Participant Accounts

Each participant's account is credited on an ongoing basis with (a) the participant's contribution; (b) the Sponsor's matching contribution; and (c) Plan investment income and unrealized gains or losses. The Sponsor's matching contribution is allocated based upon participant contributions. Earnings are allocated based upon individual accounts. The benefit to which a participant is entitled is the vested account balance of the participant.

Note 1. PLAN DESCRIPTION (continued)

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investments covered by the Plan. The Plan offers a federal money market fund, registered investment companies, and a separately managed money market account (SMA) as investment options for participants. Vanguard acts as custodian of the plan and holds all Plan assets.

Vesting

Participants are immediately vested in portions of their accounts attributed to elective deferrals and employee contributions plus actual earnings thereon. Participants become 100% vested in employer contributions after the second year of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at one percent above the prime rate, as defined by the Wall Street Journal. Principal and interest is paid ratably through monthly payroll deductions.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive their vested benefit in a single lump-sum payment or have the payment paid as a "direct rollover" to an individual retirement account. Participants are allowed to withdraw employee account balances prior to termination of their employment under certain conditions specified in the Plan. Benefit payments are recorded when paid.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10 and \$2,080, respectively. These accounts are used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$22,991 and \$60,392 from forfeited nonvested accounts.

Note 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payments of Benefits

Benefits are recorded when paid. There were no amounts allocated to the accounts of participants who have elected to withdraw from the Plan but have not been paid as of December 31, 2024 and 2023.

Administrative Expenses

All significant administration expenses are paid by the Plan's sponsor; certain other expenses are paid by the participants of the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such change could materially affect participants' account balances and the amounts in the statements of net assets available for benefits.

Reclassifications

Certain amounts presented in the prior year financial statements have been reclassified to conform to the current year presentation.

Subsequent Events

The Plan's management has evaluated subsequent events for recognition or disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3. INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Asensus Trust Company (the trustee of the Plan).

Note 4. PLAN TERMINATION

Although the Sponsor has expressed no intent to do so, the Plan gives the Sponsor the right to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 5. TAX STATUS

The Plan is a non-standardized prototype profit sharing plan. The IRS has determined and informed the provider of the prototype Plan by a letter dated January 1, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 6. RELATED PARTY TRANSACTIONS

Certain plan investments were managed by The Vanguard Group, Inc. The Vanguard Group, Inc. is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Amounts paid to parties in interest amounted to \$7,652 during the year ended December 31, 2024, and \$5,551 during the year ended December 31, 2023. These amounts are included in administrative expenses on the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 respectively.

Note 7. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable input and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Federal Money Market Fund and SMA Money Market Fund:* A money market fund aims to maintain a net asset value (NAV) of \$1 per share. Any excess earnings that get generated through interest on the portfolio holdings are distributed to the investors in the form of dividend payments.

*Self-Directed Accounts:* Allow participants to invest all or a portion of their contributions into investments of their choice. The fair value is based on the underlying investments, which may include common stock, mutual funds, debt securities and common/collective trusts
