**NOTE 1 - DESCRIPTION OF PLAN**

General: The following description of the Tots In Tow LLC 401 (k) Plan (the "Plan") is provided for general information purposes only. The Plan is sponsored by Tots In Tow LLC (the "Plan Sponsor"). Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan, established January 1, 2019 and restated on February 1, 2020, is a defined contribution plan covering substantially all employees of the Company who have completed at least three months of credited service and attained age twenty-one. Credited service requires a minimum of one hour of service per month. Employees are eligible to become a participant in the Plan on the first day of the month following the completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The purpose of the Plan is to encourage the Company's employees to systematically save and invest a portion of their current compensation so that they and their families may have a source of additional income upon their retirement or in the event of death.

Contributions: Participants may elect to make voluntary contributions up to 90% of their pre-tax annual compensation as defined by the plan document. The Plan allows for an automatic enrollment feature whereby all eligible participants will be automatically enrolled in the Plan at an automatic deferral rate of 1% unless a participant specifically opts out. Roth elective deferrals are permitted in the Plan. Participant contributions are subject to certain annual limitations as prescribed by the Internal Revenue Code (the "Code") which is \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the end of the year are eligible to make catch-up contributions in accordance with, and subject to, the limitations imposed by the Code which is \$7,500 for both years. Participants may make a rollover contribution to the Plan from another qualified plan. The Company matches 100% of the employee's deferral up to the first 3% of compensation that a participant contributes. The Plan also allows for non-elective contributions. For the years ended December 31, 2024 and 2023, no non-elective contributions were provided. All contributions made by the Company are invested based upon participant account elections.

Participant Accounts: A separate account is maintained for each participant and is credited with the participant's voluntary contributions and an allocation of (a) the Company's contributions, and (b) Plan earnings, net of any administrative expenses applicable to the participant. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Forfeitures: Forfeitures may be used to pay plan expenses or to reduce amounts otherwise required to be contributed to the plan. In some cases forfeitures will be reallocated to participants as though they are additional contributions. There were no unallocated forfeitures as of December 31, 2024 and 2023, respectively.

Administrative Expenses: Expenses incurred in administration of the Plan, including costs relating to asset charges and recordkeeping, are paid by the Plan and allocated to all participant accounts on a pro-rata basis, or are charged directly to participant accounts for fees associated with establishment of a loan or a benefit payment. Certain expenses incurred in the administration of the Plan may be paid directly by the Company.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service. Participants become 50% vested after one year of service and fully vested after two years of service or the occurrence of death, disability, or retirement.

Vesting in any Company non-elective contribution portion of their accounts is based on years of service. Participants become 20% vested after two years of service, increasing 20% per year thereafter until they are fully vested after six years of service or the occurrence of death, disability, or retirement.

Notes Receivable from Participant Loans: Participants may borrow from their accounts and may have no more than one outstanding loan at any time. Such loans must be a minimum of \$1,000 and may not exceed the lesser of \$50,000, reduced by the highest loan balance in the previous 12 months, or 50% of the participant's vested account, less any outstanding loan balance. Loan transactions are treated as a transfer to (from) the investment accounts and from (to) the loan account. Loan terms may not exceed five years, unless used to purchase a participant's primary residence which may be repaid within a period of no more than 25 years and must be secured by the participant's vested account balance. Loans must bear interest at a reasonable fixed rate, which is defined as the Prime Rate, as stated in the *Wall Street Journal*, plus 2%. As of December 31, 2024 and 2023, the loans bear interest at the rates of 5.25% - 10.50%. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$1,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum or in installment payments over a 10-year period. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements of the Plan are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains on investments bought and sold as well as held during the year.

Contributions: Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan Administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Notes Receivable from Participant Loans: Notes receivable from participant loans are recorded and measured at the unpaid principal balance plus accrued interest, which approximates fair value.

Delinquent participant loans occur when a participant misses a loan payment and fails to make it up by a specified date, or the term for repaying a loan expires without full payment. Delinquent participant loans, if any, are reclassified as distributions based upon the terms of the Plan document. Notes receivable from participant loans are considered uncollectible in the period they are deemed distributions and, accordingly, no allowance has been established.

Payment of Benefits: Benefits are recorded when paid.

Plan Expenses: Employees of the Company perform certain administrative functions for the Plan with no compensation from the Plan. In accordance with the provisions of the Plan, the Company pays a portion of the expenses incurred in the administration of the Plan, including costs relating to asset charges and recordkeeping, and such expenses are not reimbursed by the Plan nor reflected in the accompanying financial statements.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 - CERTIFIED INVESTMENTS AND NOTE RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

**NOTE 5 - INCOME TAX STATUS**

The IRS issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. ADP, Inc. is a service provider to the Plan and Reliance Trust Company is the trustee, therefore, transactions and the Plan's payment of fees to these entities qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions. Plan assets would be distributed to the participants at the discretion of the Company or continue to be held in a trust fund to be distributed to each participant upon retirement, death, permanent disability, or termination of employment.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan amended certain sections of its Adoption Agreement effective January 1, 2025.

Plan management has evaluated all subsequent events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available for issuance.
