NOTE 1 – DESCRIPTION OF PLAN

CAMS 401(k) Plan (the Plan) is a defined contribution plan adopted by Consolidated Asset Management Services, LLC (the Company) to provide eligible employees with the opportunity to save for retirement on a tax-advantage basis. The Plan was adopted on July 1, 2007, and most recently restated effective October 1, 2024. The Plan covers substantially all employees of the Company and its affiliates (collectively, the Employer or the Plan Administrator) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent related amendments and revisions. The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

Eligibility: Employees are eligible to become a participant in the Plan on their date of hire. Union employees, part-time/seasonal employees, and employees who are non-resident aliens, as defined in the Plan Agreement, are not eligible to participate in the Plan. An employee's entry date will be the date on which eligibility requirements were satisfied.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as salary deferral. Contributions cannot exceed the lesser of \$69,000 or 100% of a participant's annual compensation. There are two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. Total deferrals in any taxable year may not exceed the dollar limit which is set by law. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may make additional catch-up contributions. Participants may revoke their salary deferral elections at any time. Participants may make any other modification to their salary deferral elections on the first day of the plan year or the first day of the seventh month of the plan year. Participants are also permitted to deposit into the plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

The Employer makes matching contributions to the Plan for all participants on a uniform basis. During the year ended December 31, 2024, the Employer made safe harbor qualified matching contributions equal to 100% of elective deferrals that did not exceed 4% of compensation, subject to limits set forth by the Internal Revenue Service (IRS). Furthermore, the Employer may make an additional discretionary profit-sharing contribution to the Plan. Employees are eligible to receive any discretionary profit-sharing contribution if they have completed six months of service and will receive the discretionary profit-sharing contribution if they are employed on the last day of the plan year. For the year ended December 31, 2024, the Employer made discretionary profit-sharing contributions to the Plan equal to 3% to 9% of eligible compensation as specified in the Plan Agreement. The discretionary profit-sharing contributions totaled is included as employer contributions receivable on the statement of net assets available for benefits as of December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's matching and discretionary profit-sharing contributions and (b) Plan earnings and losses, and (c) forfeitures of discretionary matching contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their contributions and in the Employer's safe harbor matching contributions plus actual earnings or losses thereon. Vesting in any discretionary profit-sharing contributions, including earnings or losses thereon, is based upon years of continuous service. A participant is 100% vested in discretionary profit-sharing contributions after three years of credited service.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers mutual fund, pooled separate accounts, a collective trust and a group annuity contract. Participants may redirect future contributions or exchange existing balances among available investment securities at any time.

Notes Receivable from Participants: Participants are allowed to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance less their highest outstanding note amount during the prior 12 months. The notes are secured by the balance in the participant's vested account balance and bear interest at a rate commensurate with local prevailing rates as determined appropriate by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Note terms range from one to five years or up to fifteen years for the purchase of a participant's primary residence.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan for the following reasons: termination of employment, early retirement, normal retirement, disability, or death. Benefits under the Plan will be paid to participants in cash. If the vested account balance does not exceed \$5,000, then the vested account balance may only be distributed to a participant in a single lump-sum payment. If the vested account balance exceeds \$5,000, then the participant may elect to receive a distribution of their vested account balance in a single lump-sum payment or installments. Participants may be entitled to receive an in-service distribution. Participant may receive a distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59½. Participants may also withdraw money for financial hardship to satisfy certain immediate and heavy financial needs.

Retirement, Death and Disability: A participant is entitled to 100% of their account balance upon retirement, death or disability.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant's accounts will become 100% vested.

Administrative Expenses: Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Forfeitures: Forfeitures of discretionary profit-sharing contributions may be used at the Employer's discretion to pay administrative expenses or to reduce employer contributions. At December 31, 2024, and 2023, unallocated forfeitures totaled \$107,659 and \$30,673, respectively.

Subsequent Events: The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principle and interest are received through payroll deductions and the notes are collateralized by the participants account balances. Related fees are recorded as administrative expense and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded as a reduction to net assets available for benefits when paid.

Risk and Uncertainties: The Plan provides for various investment options in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company and Empower Annuity Insurance Company of America from October 1, 2024 to December 31, 2024 and for the year ended December 31, 2024 and Voya Retirement Insurance Annuity Company (Voya) as December 31, 2023.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs.

The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 inputs) and gives the lowest priority to unobservable inputs (Level 3 inputs). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. Transfers between hierarchy measurement levels are recognized by the Plan as of the beginning of the reporting period.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Pooled Separate Accounts: The fair value of the Plan's interest in the pooled separate account (PSA) is based upon the NAV per unit as determined by the fund manager as of the valuation date. The PSA is valued on the basis of the relative interest of each participating investor at the fair value of the underlying assets. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through sub accounts of a separate account of an insurance company. The investments are redeemable at the NAV on a daily basis and there are no unfunded commitments.

Collective Trust Funds: The fair value of the Plan's interest in collective trusts is based upon the NAV per unit as determined by the fund manager as of the valuation date. They are valued on the basis of the relative interest of each participating investor at the fair value of the underlying assets. The NAV is used as a practical expedient to estimate fair value. There are no unfunded commitments with respect to these investments. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – GROUP ANNUITY CONTRACT

The Plan has a fully benefit-responsive investment contract with Voya, which is called the Voya Fixed Account (the Fund), characterized as a fixed account. Voya maintains the contributions in a general account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract value of the group annuity contract on December 31, 2024 and 2023 was \$11,891,203 and \$13,430,665, respectively.

Since the Fund is fully benefit-responsive traditional investment contract, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed account. The fixed account is presented on the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (1) premature termination of the contract by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, and (6) early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

Voya may not terminate the contract at any amount less than the contract value. Voya is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula agreed upon with Voya. Such interest rates are reviewed on a quarterly basis for resetting.

The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium to long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fixed account over the year.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Other administrative expenses are paid by the Plan to Empower Trust Company, LLC, and Voya, and therefore, qualify as party-in-interest transactions. The Plan invests in a collective trust and a fixed account managed by Empower Annuity Insurance Company of America and Voya, and therefore, qualifies as party-in-interest transactions. Notes receivable from participants also reflects party-in-interest transactions. Investment management and transaction fees are charged to the Plan by investment managers, with these fees being reflected in the investment income reported by the Plan. These investment management fees and fees paid to other service providers qualify as party-in-interest transactions.

NOTE 7 – INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated November 14, 2022, indicating that the non-standardized pre-approved plan adopted by then Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is currently being operated in accordance with the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
