NOTE A - DESCRIPTION OF PLAN

The following brief description of the Specialty Care Pediatrics 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Specialty Care Pediatrics, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the Company, whereby employees of the Company serve as the Administrative Committee of the Plan.

In October 2023, the Plan transferred recordkeepers from Securian Financial to Human Interest, Inc.

Eligibility

Eligible employees may begin participation immediately. To be eligible to participate, the employee must have completed one year of service measured from the employment commencement date.

Contributions

The Plan provides for (a) pre-tax tax employee contributions from 1% up to 90% and post-tax employee contributions from 1% up to 50% of eligible compensation as defined in the Plan document, not to exceed the maximum allowable under the Internal Revenue Code; (b) safe harbor matching contributions (100% of the first 1% and 50% of the next 6% of compensation contributed by the employee); (c) Company non-elective contributions; (d) QNEC contributions; (e) Rollover contributions; and (f) Military service contributions.

The combined total of employee deferrals and Company matching contributions cannot exceed the lesser of \$69,000 during 2024 and \$66,000 during 2023, or 100% of the participant's annual compensation. Participants aged 50 and over as of year-end are eligible to make catch-up contributions to the extent permissible under law and regulations.

Eligible participants who do not affirmatively elect against automatic contributions will have contributions made to the Plan.

Vesting

Participants are immediately vested in their own contributions plus or minus any earnings or losses thereon. Safe harbor employer contributions vest upon completion of two years of service. Non-elective contribution vest at the rate of 20% per year of service, beginning with the second year, until fully vested after six years. Participants automatically become 100% vested upon:

- Normal retirement (attainment of age 65)
- Death
- Termination due to becoming disabled

Participants who terminate for any other reason are entitled to the vested amount of their accounts.

Participant Accounts

Participants have the right to designate the investment of their account balances, including their contributions and deferrals and the Company's matching contributions. Participants may direct the investment of their account balances to more than one option. However, the minimum investment that can be directed to any one option is 1% of their account balance and whole increments of 1% must be used. Investment options are changed from time to time by the Plan Administrative Committee.

Participants may direct the sale or other disposition of securities in their account and may change their investment instructions prior to the processing of any pay cycle. Neither the Company nor Matrix, the Trustee, guarantees the value of investments, nor do they indemnify any employee against any loss that may result from such investments.

All interest, dividends, and other income received by the Trustee and all gains and losses from the sale of securities are credited or charged to the respective participant's account. The cost charged to a participant's account for securities purchased is the average cost for all such securities purchased during the day. Brokerage commissions, transfer taxes, and other charges and expenses in connection with the purchase or sale of securities by the Plan are either added to the cost of the securities purchased or deducted from the proceeds of the sale.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate, as defined.

Payment of Benefits

When benefits become due, distributions are automatically made in a lump sum unless the participant requests payment in the form of installment payments.

Hardship Withdrawals

The Plan provides for participant withdrawals in the event of financial hardship. Financial hardships include the participant's purchase, construction, or repair of a primary residence, including damage that qualifies for a casualty loss deduction, certain educational or medical expenses, payments for funeral or burial expenses for specified deceased members of the participant's family, to prevent eviction or mortgage foreclosure related to the participant's principal residence, and to pay for expenses incurred on account of a federally declared disaster. Hardship withdrawals must be approved by the Plan Administrator.

Administrative Expenses

Administrative expenses incurred in connection with the Plan are paid through the Plan.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES AND USE OF ESTIMATES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual basis of accounting. The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the year. Investments traded in over-the-counter market and listed securities for which no sale was reported on the last day of the plan year are valued at the last reported bid price. Cash is stated at cost, which approximates fair value. All employer and employee contributions are invested under the direction of the participant.

Interest and dividends are recorded on a cash basis.

Gains and losses resulting from the sale of investments are differences between the average cost of specific investments sold and proceeds received. Transactions are recorded on the settlement date basis.

Payments of Benefits

Benefits are recorded when paid.

Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements as of December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE C - TRUSTEE CERTIFICATIONS

The Plan Administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified by Matrix, the Trustee, as of December 31, 2024, and for the year ended December 31, 2024.

The information certified by the Trustee was the annual report and accounting as of December 31, 2024, and for the year ended December 31, 2024, which includes beginning and ending balances of investments, notes receivable from participants, net changes in fair value of investments, dividends and interest, interest income on notes receivable from participants, and the schedule of assets (held at end of year).

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820-10-50-2 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-50-2 are described below:

Basis of Fair Value Measurements

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

NOTE E - TAX STATUS

The Plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the Plan's qualified status. The opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax exempt.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate participation in the Plan at any time subject to the provisions of ERISA. In the event of full or partial termination of the Plan, the participants will become fully vested in the Company's contributions to their account.

NOTE G - RISKS AND UNCERTAINTIES

The Plan provides for investments in various investment securities, which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED-PARTY TRANSACTIONS

Certain plan investments are shares of mutual funds managed by Human Interest, Inc. Human Interest, Inc. is the TPA as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the Code.

NOTE I - PROHIBITED TRANSACTIONS

As required by ERISA Section 2510.3-102, the Plan sponsor is required to segregate employee contributions and loan repayments to the Plan from its general assets as soon as practicable. The Plan has contributions totaling \$48,950, all of which represented employee and employer contributions, that were not remitted timely. These contributions are considered prohibited transactions. The Company will calculate lost earnings and file Form 5330, as applicable, and expects to compensate the Plan for the lost earnings in 2025.

During the year ended December 31, 2023 the Plan sponsor identified prohibited transactions. These have been corrected and employees made whole as of December 31, 2024.
