We have performed audits of the financial statements of TNT Crust LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 2, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the period ended December 2, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institutions as of December 2, 2024 and December 31, 2023, and for the period ended December 2, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of our knowledge and belief.

Opinion

Basis for Opinion

Emphasis of Matter—Plan Merger

As discussed in Note 1 of the financial statements, the Benefit Finance Committee of General Mills, Inc., voted on August 21, 2024 to merge the plan into the General Mills 401(k) Plan effective December 2, 2024. All plan assets were transferred to the control of the General Mills 401(k) Plan on December 2, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

(a) General

The following brief description of the TNT Crust LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan was a defined contribution plan sponsored by TNT Crust, LLC. (the “Company”). The Plan was designed to offer employees of TNT Crust, LLC the opportunity to participate in a savings and investment program and to provide an additional source of income for retirement. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan provided for participant-directed accounts, which permitted participants and beneficiaries to exercise control over the assets in the account and make investment decisions.

Effective December 1, 2022, the Plan was amended to freeze the Plan effective January 1, 2023. No new participants could enter after that date and both employee and employer contributions ceased. Active employees on and after January 1, 2023, were immediately eligible for the General Mills 401(k) Plan. See Note 1(i) below.

(b) Trustee and Administration of the Plan

The trustee and custodian of the Plan is Reliance Trust Company.

The named administrative fiduciary for the Plan was the Vice President, Total Rewards “the Plan Administrator”. The Benefit Finance Committee was the named financial fiduciary for the Plan. The Benefit Finance Committee determined the appropriateness of the Plan’s investment offerings and monitored investment performance with advisory services performed by Merrill Lynch Pierce Fenner & Smith.

(c) Eligibility

All employees of the Company, with certain exceptions, were eligible for participation on the first of the month following the completion of two months of service. Ineligible employees, as defined in the plan agreement, included leased and temporary employees, employees governed by a collective bargaining agreement and certain nonresident aliens who have no earned income from sources within the United States.

(d) Contributions

Participants were allowed to contribute a percentage of pretax compensation as defined by the Plan, subject to the maximum amount allowed by the Internal Revenue Code (“IRC”) up to 60% of the participant’s total compensation. Participants were subject to an automatic deferral amount which required 3% of compensation to be withheld unless the participant elected a contrary election. Notwithstanding any of the foregoing, a participant could elect to defer 0%. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allowed for both Company matching contributions and a discretionary profit-sharing contribution. The Company matching contribution was determined in two levels. The Company matched 100% up to 3% and 50% of the next 2% of the individual’s salary deferrals. Due to the freeze of the Plan, there

were no Company match or discretionary profit-sharing contributions during the year ended December 31, 2023. During the period ended December 2, 2024, employer contributions of \$19,281 were made to the Plan related to corrections for 2021 and 2022 plan year contributions.

(e) Participant Accounts

Each participant's account was credited with the participant's contributions, Company's contributions and allocations of plan earnings. Each participant's account was also charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(f) Vesting and Payment of Benefits

Participants were immediately vested in their participant contributions and rollover contributions. Prior to the amendment to freeze the Plan, participants were vested in Company contributions, plus earnings thereon, after one year of service. Effective January 1, 2023, active participants within the Plan were fully vested.

Benefits were paid to the participant or beneficiary upon death, hardship, retirement, termination of employment or attaining age 70 ½, up to the amount of the participant's account. Benefits were paid in a lump-sum distribution, installment (not longer than one's life expectancy), and partial withdrawal. Once a participant had reached the age of 59 ½, distributions could be made at the participant's election. The Plan allowed for the automatic lump sum distribution of terminated participant's vested account balances that did not exceed \$7,000.

(g) Investment options

Upon enrollment in the Plan, participants could direct their account balance in a common/collective trust ("CCT") or various registered investment companies. Participants were able to change their investment options at any time.

(h) Notes receivable from participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum of equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms ranged from one to five years for loans unless the loan was for the purchase of a primary residence. Notes were payable immediately upon termination. The notes were secured by the balance in the participant's account and bore interest at rates commensurate with a commercially reasonable rate of return, which the Plan's trustee had determined to be the prime rate plus 1%. The number of loans outstanding was limited to two per participant. Principal and interest were paid ratably through payroll deductions.

(i) Plan Transfers Out

The Plan was legally merged with the General Mills 401(k) Plan effective December 2, 2024, when the General Mills plan obtained legal control of the assets of the Plan. All of the assets of the Plan totaling \$5,881,908 were transferred out and into the General Mills 401(k) Plan on December 2, 2024.

(2) Summary of Significant Accounting Policies

(a) *Basis of Presentation*

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with U.S. generally accepted accounting principles ("U.S. GAAP").

(b) *Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for participants and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates and assumptions.

(c) *Investments*

The statements of net assets available for benefits presented the fair value of the Plan's investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Dividend income was recorded on the ex-dividend date. Interest income and administrative expenses were recorded on the accrual basis. The cost of investment securities sold was determined on the weighted average cost. Deposits to and withdrawals from each fund by participating plans were made at fair value determined as of the end of the business day of the transaction. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) *Notes receivable from participants*

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Loan fees were paid by the participant and recorded as administrative expenses and expensed as incurred. No allowance for credit losses had been recorded at December 2, 2024 and December 31, 2023. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant to be in default, the participant loan balance was reduced and a benefit payment recorded.

(e) *Payment of Benefits*

Benefits were recorded when paid.

(f) *Expenses*

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent events have been evaluated through September 5, 2025, the date the financial statements were available to be issued.

(4) Fair Value Measurements

The Plan's estimates of fair value for financial assets are based on the framework established in the fair value accounting guidance. The framework is based on the inputs used in valuation, gives the highest priority to quoted prices in active markets, and requires that observable inputs be used in valuations when available.

The disclosure of fair value estimates in the fair value accounting guidance hierarchy is based on whether the significant inputs into the valuation are observable. In determining the level of the hierarchy in which the estimate is disclosed, the highest priority is given to unadjusted quoted prices in active markets ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The level in the fair value hierarchy within which the fair value measurement is reported is based on the lowest-level input that is significant to the measurement in its entirety. The three levels of the hierarchy under FASB Accounting Standards Codification Topic 820, *Fair Value Measurement* ("ASC 820"), are as follows:

- Level 1 – Unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; or valuations based on models where the significant inputs are observable (e.g., interest rates, yield curves, prepayment speeds, default rates, loss severities, etc.) or can be corroborated by observable market data.
- Level 3 – Valuations based on models where significant inputs are not observable.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes to methodologies used as of December 2, 2024 and December 31, 2023.

Shares of registered investment companies: Investments in registered investment companies traded on national exchanges are valued by the trustee at the quoted market closing price on the valuation date. If not traded on national exchanges, they are valued based on the net asset value, (“NAV”), which is considered to be the readily determinable fair value provided by the investment manager.

Units of a collective investment trust (CCT): The CCT is valued at NAV, as reported by the funds, which is used as a practical expedient to estimate fair value and are therefore excluded from the fair value table. This CCT has a redemption frequency of daily to quarterly and a redemption period of 12 months for a complete liquidation. There are no unfunded commitments to such funds at December 2, 2024 and December 31, 2023.

(a) In accordance with Subtopic 820-10, certain investments that were measured at NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investment from one fair value level to another. The Benefit Finance Committee evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the period ended December 2, 2024, there were no significant transfers in or out of Level 3.

(5) Federal Income Tax Status

Effective October 6, 2020, the Plan adopted a non-standardized form of the prototype plan sponsored by Automatic Data Processing, Inc (“ADP”). The plan provider has received an opinion letter from the Internal Revenue Service (“IRS”) as to the prototype plan’s qualified status. The prototype plan opinion letter has been relied upon by this Plan. The plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax

positions taken by the Plan, and has concluded that as of December 2, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Company believes it is no longer subject to income tax examinations for years prior to 2021.

(6) Parties-In-Interest Transactions

ADP is a party in interest with respect to the Plan. ADP provides recordkeeping services to the Plan. All transactions between the Plan and ADP during the reporting period are exempt from being considered as prohibited transactions under ERISA Section 408(b). There were \$54,756 of fees paid by the Plan for recordkeeping services during the period ended December 2, 2024.

Merrill Lynch Pierce Fenner & Smith is a party in interest with respect to the Plan. Merrill Lynch Pierce Fenner & Smith provides investment advisory services to the Plan. All transactions between the Plan and Merrill Lynch Pierce Fenner & Smith during the reporting period are exempt from being considered as prohibited transactions under ERISA Section 408(b). There were \$24,191 of fees paid by the Plan for investment advisory services during the period ended December 2, 2024.

RSM is a party in interest with respect to the Plan. RSM provides audit services to the Plan. All transactions between the Plan and RSM during the reporting period are exempt from being considered as prohibited transactions under ERISA Section 408(b).

CBIZ is a party in interest with respect to the Plan. CBIZ provides accounting and financial reporting services to the Plan. All transactions between the Plan and CBIZ during the reporting period are exempt from being considered as prohibited transactions under ERISA Section 408(b).

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

(8) Risks and Uncertainties

The Plan provided for investment in a variety of investment funds. Investments in general were exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events such as a pandemic or international conflict which could impact the value of the investment funds. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At December 31, 2023, approximately 34% and 10% of the Plan's investments were invested in the T. Rowe Price Balanced Fund and the Guggenheim Total Return Fund, respectively.
