## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Competitive Esports, LLC 401(K) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Competitive Esports, LLC 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Competitive Esports, LLC 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

1 - DESCRIPTION OF PLAN

The following description of Competitive Esports, LLC 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established as a defined contribution plan for the benefit of the employees of Competitive Esports, LLC (the "Company" or "Plan Sponsor") under Section 401(k) of the Internal Revenue Code (the "Code"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan covers substantially all employees of the Company, who have completed at least three months of service and are 18 years of age or over. The entry dates are the first day of the month following the date the employee meets the eligibility requirements. The Company's management is responsible for oversight of the Plan.

Reliance Trust Company is the asset custodian of the Plan ("Reliance" or "Asset Custodian").

The recordkeeping functions are performed by Automatic Data Processing, Inc. (ADP) ("Third Party Administrator" or "Record Keeper").

Contributions

Participants may elect to make pre-tax 401(k) and/or after-tax Roth contributions between 1% and 90% of their eligible compensation to the Plan each year; however, the total amount of the contribution generally may not exceed the IRS limit of \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 in addition to the IRS limit for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan's provisions allow the Company to make discretionary, non-elective, and matching contributions, although is not required to do so. The non-elective and discretionary matching contributions will be allocated to all employees eligible to participate in the Plan at the end of each Plan year based on eligible earnings within the computation period. All employer contributions are invested in the same manner as the participant directs his or her investments. For the year ended December 31, 2024, the Company made no discretionary contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants must direct their salary deferral contributions to selected investment options as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

The portion of the participant's account attributable to the Company's non-elective matching/discretionary contributions, plus actual earnings, becomes 20% vested following two years of service as defined, and continues to vest at the rate of 20% for each successive year of service until 100% vested after six years of service, attaining normal retirement age, death, or disability. Non-elective safe harbor contributions are 100% vested immediately.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance of the participant's account and bear fixed rate of interest of 2% over the Prime Rate. Principal and interest are paid ratably through payroll deductions. The maximum term for a loan is five years, except if the loan is used to acquire a principal residence, the term of the loan is 30 years. As of December 31, 2024, notes receivable from participants bear interest at the rates of 9.75% - 10.50% with maturity dates through April 2028.

Payment of Benefits

If a participant's employment ceases as a result of termination, normal retirement, death or disability, the participant or the participant's beneficiaries are entitled to the entire proceeds of the participant's vested account balance. Participants or their beneficiaries may receive benefit payments in a lump-sum distribution or in installments not to exceed the participant's or beneficiary's life expectancy.

In-service distributions may be made from any of the participants' vested accounts at any time in the event of a hardship. Events that qualify for a hardship withdrawal are as follows: to cover necessary medical expenses, for costs directly related to the purchase of the participant's primary residence, for expenses related to post-secondary education, for payments necessary to prevent the participant's eviction from or foreclosure of the primary residence, burial or funeral expenses for deceased family members or expenses for repair or damage of participant's primary residence.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant's account balance in the Plan.

Forfeited Accounts

If an employee terminates before his or her account becomes fully vested, an unvested portion of the account balance is forfeited. Forfeitures may first be used to pay for plan administrative expenses and any remaining amount will be used to reduce future employer matching contributions. For the year ended December 31, 2024, no amount was used to reduce employer matching contributions from forfeited, non-vested accounts. There was no forfeiture balance as of December 31, 2024.

2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between the market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments consists of both realized gains or losses and unrealized appreciation and depreciation of those investments.

The Plan's indirect investment in the stable value fund is valued at the net unit value ("NUV") of units held by the Plan at year-end based on information reported in the stable fund's audited financial statements at year-end. The NUV is determined by the total contract value of fund assets divided by the total number of outstanding units of the fund. The Plan uses a practical expedient permitting a reporting entity to measure certain investments using the NAV per share (or its equivalent) of the investment. Because the Plan has an indirect investment in the contracts held by the stable value fund, they are not considered fully benefit responsive.

Note Receivable from Participant

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest earned on note receivable from participant was \$531 for the year ended December 31, 2024.

Benefits Paid

Benefits are recorded when paid.

Administrative Expenses

Certain administration and recordkeeping expenses incurred are paid by the Plan. Fees related to administration of note receivable from participant are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments. Expenses paid directly by the Company are excluded from these financial statements.

3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Registered Investment Companies (Mutual funds)*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

4 - TAX STATUS

The Plan document is a non-standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on April 12, 2022 which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible, given the level of risks associated with investment securities, that changes in value may result in the near term which could materially affect a participant's account balance and the amounts reported in the financial statements.
