Note A - Description of the Plan

The following description of Jim Hinton Oil Company, Inc. ("Company") Profit Sharing Plan & Trust ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan sponsored and administered by Jim Hinton Oil Company, Inc. The Plan covers substantially all of the Company's full-time salaried employees who have one year of service and who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. As of October 10, 2022, the Plan adopted an amendment and restatement. Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan Document. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes a matching percentage of one-half of the first 6 percent of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations.

Participant Accounts. Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings and charged with transaction costs attributable to specific investment options. Allocations of the Company's contributions are based on participant earnings. Allocations of Plan earnings are made based on the investment options selected by each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Investment Options. Upon enrollment in the Plan, a participant may direct contributions in any of the specified investment options, which may be changed on a daily basis.

Payment of Benefits. On termination of service, the participant may elect to receive his or her vested balance in the form of a lump-sum distribution.

Forfeited Accounts. As of December 31, 2024 and 2023, there were no forfeited nonvested accounts. Forfeitures that may occur in the future will be used to reduce employer contributions.

Note B - Summary of Significant Accounting Policies

Basis of Accounting. The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year.

For fully benefit-responsive investment contracts of a defined contribution plan, contract value is the relevant measurement attributable to that portion of the net assets available for benefits, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The investment in the group annuity contract is valued at fair value which approximates contract value. Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive investment contracts represents contributions plus earnings, less participant withdrawals and administrative expenses.

Payment of Benefits. Benefits are recorded when paid.

Note C - Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Voya Investments. Voya Institutional Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. However, the Department of Labor has issued a class exemption for the investment of plan assets in open-ended mutual funds (DOL Regulation PTE 77-4). Fees for investment management, record keeping, audit, and trustee services were absorbed by Jim Hinton Oil Company, Inc. Jim Hinton Oil Company, Inc. also remits participant withholdings and employer contributions and matches to the trustee on behalf of the participants.

The Plan auditor provides audit, tax, and accounting services to the Plan sponsor. The Plan incurred professional fees during the year ended December 31, 2024 in the amount of \$24,587 that were paid by Jim Hinton Oil Company, Inc.

Note D - Plan Termination

It is the present intention of the Company to maintain the Plan throughout their corporate existence. However, the Company reserves the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note E - Costs of Plan Administration

Costs of Plan administration, including legal, consulting, investment management, administrative, and audit fees are absorbed by Jim Hinton Oil Company, Inc. Transaction costs associated with entering certain investment options are charged to the account of the participants electing these options.

Note F - Tax Status

The IRS has determined and informed the Company by a letter dated September 18, 2001, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. During 2024, the Plan restated its Plan Document to meet the qualification requirements of Section 401(a) of the IRC with respect to the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note G - Information Prepared and Certified by Trustee (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Institutional Trust Company.

Note H - Fair Value Measurements

The framework for measuring fair value provides fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted observable quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value and common/collective trust funds.

Mutual funds: Valued at the quoted net asset value of shares held by the Plan at year end.

Group annuity contract: Valued at fair value which approximates contract value, because it is fully benefit responsive, by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note H - Fair Value Measurements, continued

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023, respectively. As required by FASB ASC 820, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

Note I - Group Annuity Contract

At December 31, 2024 and 2023, the Plan invested in a fully benefit-responsive group annuity contract with Talcott Resolution Life Insurance Company ("Talcott"). Talcott maintains this fixed income account in a general account. The account is credited with participant contributions plus earnings and charged for participant withdrawals and administrative expenses. Talcott is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3.00%. Such interest rates are reviewed and may be reset on a quarterly basis. The crediting interest rate was 3.00% as of December 31, 2024 and 2023.

Contract termination may occur by either party upon election and notice. Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain liquidation events may limit the ability of the Plan to transact at contract value with the issuer. The Plan Sponsor does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note J - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

At times the Plan maintains deposits in federally insured financial institutions in excess of federally insured limits. Management monitors the soundness of these financial institutions and feels the Plan's risk is negligible.

Note K - Investments

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$78,648.

Note L - Subsequent Events

In order to determine the need for disclosure or recognition in these financial statements, subsequent events were evaluated through September 19, 2025, which is the date the financial statements were available to be issued.
