Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Vogue Recovery Center 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of Vogue Recovery Center 401K Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section—

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of Vogue Recovery Center 401K Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 – Plan Description

The following description of the Plan provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all employees of CMJ Healthcare Holdings LLC (the Company), and the following adopting employers, who have reached age 21 and have completed 3 consecutive months (360 hours) of eligible service:

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may contribute, both pre-tax and Roth, a portion of their eligible plan compensation up to the maximum allowable by the Internal Revenue Code (IRC) and other applicable legal limits. In any calendar year in which a participant is age 50 or older, an additional “catch-up contribution” (limited to \$7,500 in 2024 and 2023) may be made. The Plan also allows participants to contribute amounts representing distributions from other qualified plans.

The Company may provide a discretionary matching contribution. For 2024 and 2023, the matching contribution was 100% of the amount deferred by the participant up to 2% of eligible compensation. Participants must be employed as of the last day of the Plan year in order to be eligible to receive employer matching contributions, except in the event of death, termination due to disability, or termination after normal retirement age. The matching contribution amounted to \$191,594 for the year ending December 31, 2024.

The Company may also provide an additional discretionary profit sharing contribution. The Company did not make a discretionary profit sharing contribution in 2024.

Participant Accounts – The plan administrator maintains separate participant accounts for each participant. Each participant’s account is credited with their voluntary contributions, the Company’s matching contribution, an allocation of the Company’s discretionary profit sharing contribution and plan earnings. Allocations are based on participant account balances, as defined by the Plan. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the employer matching contribution and discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become fully vested upon completion of three years of continuous service.

Note 1 – Plan Description (continued)

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the vested value of the participant’s account. During active employment, participants may withdraw their contributions for financial hardship upon approval of the plan administrator or upon the attainment of age 59 ½ or attainment of the normal retirement age, as outlined in the terms of the Plan. Terminated employees receive a lump-sum amount of their account balance.

Forfeitures – Nonvested accounts are forfeited upon participants’ terminations. Forfeited amounts may be used to reduce future contributions. Forfeited amounts at December 31, 2024 and 2023 amounted to \$7,614 and \$5,041, respectively. Forfeitures of \$5,244 were used during 2024 to reduce Company contributions.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at one time. Borrowings are considered to be collectible as they are secured by the balance in the participants’ accounts. Interest is charged at a reasonable rate as defined in the plan document. Interest rates ranged from 6.25% to 8.50% at December 31, 2024 and from 3.25% to 8.50% at December 31, 2023. Principal and interest is paid ratably through semi-monthly payroll deductions. Repayment terms may not exceed 5 years unless the loan is granted for the purpose of acquiring the participant’s principal residence.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Contributions – Employee contributions and Company contributions are recognized as additions to Plan assets in the year designated by the employee and Company, respectively.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on loans is recorded on the accrual basis. An allowance for notes receivable from participants has not been recorded as delinquent notes receivable from participants are recorded as a distribution and reduction of the participant loan balance based upon the terms of the plan document.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors determines the Plan’s valuation policies utilizing information provided by the investment advisers and trustee. See Note 8 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses on the sale of investments are determined on weighted average cost which includes transaction expenses. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Note 2 – Summary of Significant Accounting Policies (continued)

Administrative Expenses – Administrative expenses are paid by the Company or Plan, as provided by the plan document.

Benefit Payments – Benefits are recorded when paid.

Note 3 – Certification of Financial Information

For the year ended December 31, 2024, the plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Ascensus, LLC, an authorized representative of Ascensus Trust Company, the trustee of the Plan, as complete and accurate, except for comparing such information certified by Ascensus, LLC to information included in the Plan’s financial statements and supplemental schedule:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024.
- Investment earnings as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

Note 5 – Tax Status

The Internal Revenue Service has determined by a letter dated June 30, 2020 that the Prototype Non-Standardized Profit Sharing Plan used to set the guidelines of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), as amended, and the regulations thereunder, and the Plan is thereby tax-exempt within the meaning of Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan’s tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed. The Plan currently has no uncertain tax positions and, therefore, no liabilities have been recorded.

Note 6 – Related Party and Party-in-Interest Transactions

Certain plan assets are managed by the trustee. Therefore, these transactions qualify as exempt party-in-interest transactions. Certain administrative fees related to the administration of the Plan were paid by the Company. Administrative fees paid by the plan include participant transaction fees. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan. The Plan has notes receivable from participants subject to specific guidelines as defined in the Plan Document. These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the assets or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 8 – Fair Value Measurements (continued)

Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the fair value hierarchy.

Money market fund fair value is obtained by the trustee from the quoted market prices available on active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 11 – Excess Contributions Payable

Contributions received for the year ending December 31, 2024 are net of refunds made in 2025 of \$96,363. These refunds were made to certain active participants to return excess deferral and matching contributions as required satisfying the relevant nondiscrimination provisions of the Plan. Net earnings (losses) on these excess contributions will also be refunded. The amount is included in the plan's statements of net assets available for benefits as excess contributions payable at December 31, 2024.

Note 12 – Nonexempt Transactions

Employee contributions totaling \$50 and \$728 during the years ended December 31, 2024 and 2023, respectively, were transferred to the Plan later than required by Department of Labor Regulations.

Note 13 – Subsequent Events

Subsequent to year end, the Plan was amended to add Oklahoma Recovery Center as a related employer whose employees can participate in the Plan, effective April 1, 2025. Additionally, the Plan was amended to change the Plan name to Aliya Health Group 401(k Plan and to change the limited trustee of the Plan.

The Plan has evaluated all subsequent events through October 15, 2025, the date the financial statements were available to be issued.
