## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Adams Electric Company Employees' 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



**Note A**  
**Description of Plan**

The following description of the Adams Electric Company Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:**

The Plan is a defined contribution plan that provides retirement benefits for eligible employees of Adams Electric Company, Inc. (the Company). Participation in the Plan is voluntary and is offered to all employees, except union employees and nonresident aliens, who have attained the age of twenty-one (21) and completed ninety (90) days of service as described in the Plan agreement. The Administrative Committee is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan was amended and restated effective August 1, 2019, to include automatic pre-tax deferrals for eligible participants. The Plan was amended effective January 1, 2021, to comply with the Internal Revenue Service's ("IRS") Cycle 3 restatement requirements.

**Contributions:**

Each year, participants may contribute from 1% up to 25% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant.

Each year, the Company may make a matching contribution based on, and equal to, 50% of the participants' contribution, limited to 4% of their compensation, as defined by the Plan. The Company may also make discretionary profit sharing contributions. There were no discretionary profit sharing contributions for 2024. Additionally, the Company makes prevailing wage contributions for participants subject to prevailing wage laws to fulfill the fringe benefits requirements of the law. There were no prevailing wage contributions for 2024. Company contributions are maintained separately in a company account within each participant's account. Contributions are subject to certain IRS limitations.

**Participant Accounts:**

A separate account is established in the name of each participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, prevailing wage contributions (if applicable) and their proportionate share of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined.

**Note A**

**Description of Plan (Continued)**

Vesting:

Participants are vested immediately in their contributions and prevailing wage contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 3 years of credited service. Participants who qualify for prevailing wage contributions are 100% vested immediately plus actual earnings thereon under the Davis-Bacon Act.

Notes Receivable From Participants:

Participants may borrow from their fund accounts subject to restrictions imposed by ERISA and the Internal Revenue Code. Loans must be evidenced by a promissory note and repaid within a prescribed period of time. The participant can have no more than one loan outstanding at any time. The loans are collateralized by the balance in the participants' account and will bear interest at the prime interest rate plus 1%. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years.

Payment of Benefits:

Benefits are generally payable to the participants or their beneficiaries at the time of normal retirement (age 65), early retirement (age 60 and 3 years of service), death, or disability while employed with the Company. Subject to certain conditions, including financial hardship and upon age 59 1/2, participants may elect to withdraw contributions and related earnings prior to retirement. Settlement of a participant's account may be made in the form of a lump-sum payment or installment payments.

Forfeitures:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$15,651 and \$7,724, respectively. These accounts will be used to reduce employer contributions or pay plan expenses. No forfeitures were used during the year ended December 31, 2024.

**Summary of Significant Accounting Policies**

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Note B**

**Summary of Significant Accounting Policies (Continued)**

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions:

Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events:

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

**Note C**  
**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three Levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective trust: Units of each fee class of the Fund are valued each day on which the New York Stock Exchange ("NYSE") is open for trading in accordance with the valuation procedures established by the Trustee. The NAV per unit is calculated as of the close of trading on the NYSE (generally, 4:00 p.m. U.S. Eastern time). The NAV per unit is computed by dividing the total contract value of the assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments for these funds, and normal redemptions are unrestricted.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note D**

**Certification by Trustees**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company and American Trust Company (the trustees of the Plan).

**Note E**

**Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Mid Atlantic Trust Company and American Trust Company, the trustees, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

During 2024 and 2023, the Company failed to remit to the trustee certain employee contributions and loan repayments totaling approximately \$142,743 within the period prescribed by Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions. The Company intends to make corrective contributions to the Plan in 2025 to compensate affected participants for lost earnings on the delinquent remittances.

**Note F**

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**Note G**

**Tax Status**

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized profit-sharing plan with CODA adopted by the Plan, as then designated, qualifies under Section 401(a) of the IRC. The Plan administrator timely adopted the approved Plan. The Plan administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note H**

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
