Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 Description of the Plan

The following brief description of the AlphaSights, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. A complete copy of the Plan Document is available to participants upon request.

General

The Plan is a single employer defined contribution and savings plan covering all eligible employees of AlphaSights, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility and Participation

All employees become eligible to make elective deferral contributions and receive matching contributions and profit-sharing contributions on the first day of the calendar month, coincident with or next following the date the employee attains age 21 and has completed six months of service, measured from the date of hire, provided that the employee is an eligible employee at the end of that period.

Contributions

Subject to annual limitations established by the Internal Revenue Code (“IRC”) participants can elect to contribute up to 100% of their eligible compensation on a pre-tax or after-tax (“Roth”) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with the provisions of the IRC. In general, any eligible rollover distribution will be accepted by the Plan; however, the Plan Administrator may establish procedures that regulate the method by which rollover contributions will be accepted.

The Company matches employee contributions in the amount equal to 100% of the participant’s pre-tax or Roth contributions not in excess of 4% of each participant’s eligible compensation, as defined in the Plan Document.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their elective deferral contributions and rollover accounts plus actual earnings thereon. Participants are vested in the employer matching contribution and profit-sharing contributions based on years of service. Such contributions, if any, vest in accordance with the Plan’s vesting schedule. Regarding the employer match contribution and profit-sharing contributions, a participant is fully vested after one year of service.

Note 1 Description of the Plan (continued)

Payment of Benefits

Benefits are recorded when paid. Benefits paid include Plan retirement benefit withdrawals, hardship withdrawals and distributions to participants leaving the Company. On termination of service due to death, disability, retirement or other reasons, a participant or his or her beneficiary with a vested balance greater than \$5,000 may elect to receive either a lump-sum or equal monthly installments over a reasonable time. A participant with a vested balance of less than \$5,000 will receive the value of the vested interest in his or her account as a lump-sum distribution or rolled over to an Individual Retirement Account (“IRA”) set up for the terminated participant, following the termination of employment. If the vested balance is \$1,000 or less, the entire amount will be distributed to the participant as a lump-sum payment. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship Withdrawals

Participants in service may make hardship withdrawals from the vested portion of all their accounts, except for the Qualified Non-Elective Contribution Account, upon demonstrating immediate and heavy financial need. The Company may establish uniform procedures that include, but are not limited to, prescribing limitations on the frequency and minimum amount of withdrawals.

Loans

Loans are not permitted under this Plan.

Investment Elections

The participant contributions and the Company matching contributions are allocated to the various investment options offered by the Plan as the participant directs. Elections will be subject to such rules and limitations as the Company may prescribe. Investment elections made by the participant remain effective until another such election is received. Participants may change investment elections daily.

Plan Expenses

Expenses incurred in the operation of the Plan are paid from the Plan unless allocated to and paid by the Company. Expenses paid by the Company are excluded from the Plan’s financial statements. Fees related to administration of participant accounts are charged directly to the respective accounts and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

Forfeited Accounts

Forfeited non-vested account balances may be applied to reduce future employer contributions, may be used to pay administrative expenses, or may be allocated to participants. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,119 and \$4,046, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$8,119 were used to reduce employer contributions to the Plan.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”). Accordingly, the accounting records of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payments of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan’s valuation policies utilizing information provided by the investment adviser and Trustee. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Note 3 Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 3 Fair Value Measurement (continued)

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

- Mutual funds – valued at the daily closing price as reported by the funds. These funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 Information Certified by the Plan's Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan, Capital Bank and Trust Company.

Note 5 Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances and the net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

Note 6 Tax Status

The Plan is an adoption of the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA sponsored by CCH Incorporated DBA FTWilliam.com. The Internal Revenue Service has issued an opinion letter dated June 30, 2020, that stated that the form of the pre-approved plan was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 Party-In-Interest Transactions

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 1, fees related to the administration of participant accounts are paid from Plan assets. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions.

Capital Bank and Trust Company is the trustee of the Plan and is therefore considered to be a party-in-interest.

Note 9 Subsequent Events

Plan management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.
