### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Savings Plan for Hourly Employees of Ocean Spray Cranberries, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## *Notes to Financial Statements*

### **Note 1 - Description of the Plan**

The following description of the Savings Plan for Hourly Employees of Ocean Spray Cranberries, Inc. (the "Plan") provides general information only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a contributory savings plan, established on September 1, 1974 for the hourly employees of Ocean Spray Cranberries, Inc. (the "Company"). The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments are participant directed.

#### **Plan Administrator**

The Plan is administered by the Pension and Savings Committee, which consists of seven persons appointed by the Board of Directors of the Company.

#### **Trustee of the Plan**

Fidelity Management Trust Company ("Fidelity") is the trustee and custodian of the Plan. Fidelity Investments and Fidelity Workplace Services LLC, which are affiliated companies of the trustee and custodian, are the investment manager and record-keeper, respectively.

#### **Eligibility**

Any employee who is an hourly employee of the Company, excluding seasonal employees, may become a participant in the Plan on his or her start date.

#### **Participant Contributions**

Eligible employees may elect to defer eligible compensation on a pre-tax basis, an after-tax basis ("Roth"), or a combination of both. Participants are eligible to contribute from 1% to 75% of their annual eligible compensation to the Plan. Rollover contributions are allowed. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, thirty-five days after their date of hire, at a rate of 4% within the applicable Fidelity Freedom Blend Target Date Commingled Pool collective trust fund unless they affirmatively elect a different rate, investment or not to participate in the Plan. The Plan includes an automatic deferral increase of 1%, each year on September 1st, for participants deferring between 1% and 5% annually, until a maximum of 6% of eligible compensation is reached. Participants can elect a Fidelity Portfolio Advisory Services managed account option, whereby a Fidelity investment professional will actively manage the participant's account for a fee ranging from 0.05% to 0.65% of the participant's average account balance. Participants whose employee pre-tax contributions are limited by statutory requirements may make additional catch-up contributions starting in the calendar year during which they reach the age of 50.

## *Notes to Financial Statements*

### **Note 1 - Description of the Plan (Continued)**

#### ***Employer Contributions***

The Company makes matching contributions to the Plan once a participant has worked 1,000 or more hours during the initial year of employment or in subsequent plan years. For employees, excluding some employees represented by a union, the Company matches 50% of the participant's pre-tax contributions and Roth contributions, up to the maximum of 3% of the participant's eligible wages. During 2024, the Company made matching contributions of \$1,257,746, net of \$250,000 of forfeitures utilized. Additionally, subsequent to year-end in 2025, the Company made a true-up of \$48,397, funded fully with forfeitures.

In addition to the matching contribution, certain non-grandfathered participants of the Retirement Plan of Ocean Spray Cranberries, Inc., as defined in the Plan Document, excluding some employees represented by a union, receive a Company fixed contribution of the 3% of their eligible wages. Additionally, as part of the Kenosha contract, employees were due a contribution of \$100 for each year of service with a minimum of \$500 for 2024. During 2024, the Company made Company fixed contributions of \$1,154,055.

The Company may also make supplemental matching contributions, which are discretionary. Employees, excluding some employees represented by a union, are eligible for the supplemental matching contributions provided they have met the following criteria: (i) completed one year of eligible service as of the last month of a performance period within the current plan year, (ii) either (a) make pre-tax contributions with respect to compensation earned during the last month of a performance period within the current plan year or (b) have contributed the maximum amount of pre-tax contributions before the last month of a performance period within the current plan year, and (iii) are employed on the date such supplemental matching contributions are paid. All contributions are subject to certain limitations. During 2024, the Company made discretionary supplemental matching contributions of \$1,402,113.

#### ***Other Income***

The Company is party to a revenue credit agreement with the trustee, whereby the trustee makes an annual fixed payment to the Plan and to the Savings Plan for Salaried Employees of Ocean Spray Cranberries, Inc. (together, the "Plans"). The payment is funded quarterly and is allocated between the Plans based on each plan's assets as of the end of each quarter. The payment may be used to reimburse the Plans for fees and expenses. Amounts unused for expenses may be allocated to participants in accordance with the revenue credit agreement. For the year ended December 31, 2024, \$30,009 of credits were received by the Plan. The amount of unallocated credits held by the Plan as of December 31, 2024 was \$83,691. These amounts are included within the mutual funds line item in the Statements of Net Assets Available for Benefits.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, Company matching contributions, Company fixed contributions, Company supplemental matching contributions, and allocations of plan earnings or losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balances. The Plan allocates amounts held in the revenue credit account after paying Plan expenses to participants based on participant balances.

***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by current outstanding loans. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence and bear interest at a fixed rate commensurate with local prevailing rates as determined periodically by the Pension and Savings Committee. Principal and interest are paid ratably in equal installments, generally through payroll deductions.

***Investments***

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and collective trust funds as investment options for participants.

***Vesting***

If a participant's employment is terminated due to retirement, disability, or death, the full amount of the participant's account is vested. If employment is terminated for reasons other than those mentioned above, the participant's account is vested as follows:

- The portion of the participant's account arising from the participant's own contributions will be fully vested upon initial contribution.
- The portion of the participant's account arising from contributions made by the Company will be vested according to the following schedule:

### **Note 1 - Description of the Plan (Continued)**

#### ***Payment of Benefits***

In-service withdrawals from a participant's elective deferral account are permitted upon reaching 59½. Hardship withdrawals may be taken from any account without respect to earnings. The amount of hardship distribution cannot exceed the amount to meet the immediate financial hardship. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various annual installment options in accordance with the Plan Document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### ***Forfeitures***

A participant who leaves the employ of the Employer forfeits any non-vested balance at the earlier of the end of five consecutive one-year breaks in service or if the participant receives a complete distribution of their accounts. Non-vested balances forfeited are used to reduce subsequent Employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeitures totaled \$312,134 and \$155,896, respectively. For the year ended December 31, 2024, forfeitures totaling \$41,302 were used to reduce administrative expenses. Additionally, during 2024, forfeitures of \$250,000 were utilized to offset the 2023 employer true-up. Subsequent to year-end in 2025, \$48,397 was utilized to offset the 2024 employer true-up.

#### ***Transfers***

Along with this Plan, the Company also sponsors a contributory savings plan for salaried employees. If employees change their hourly or salary status during the year, their account balances are transferred to the corresponding plan.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Basis of Presentation***

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

### *Note 2 - Summary of Significant Accounting Policies (Continued)*

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Administrative expenses are paid by the Plan (see Note 7), except for those expenses that the Company, in its discretion, chooses to pay from time to time. Expenses paid by the Company are excluded from these financial statements. Administrative fees for loans are charged against the participant's account when each loan is extended. Expenses incurred by mutual funds and collective trust funds are included within their net asset value and not separately reported on the Plan's financial statements.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### ***Unit Values***

Individual participant accounts for the collective trust funds are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units which are valued daily. The fund earns interest and dividends which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the funds are converted to units by dividing the amounts of such transactions by the unit value as last determined, and the participant's accounts are charged or credited with the number of units properly attributable to each participant.

#### ***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Subsequent Events***

The Employer has evaluated subsequent events through October 15, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during the evaluation.

### **Note 3 - Information Certified by the Trustee and Custodian**

Plan investments are held by the Plan's trustee and custodian, Fidelity Management Trust Company ("Fidelity"). Fidelity has certified to the fair value of investments as of December 31, 2024 and 2023 and investment transactions for the year ended December 31, 2024. Investment transactions including interest and dividends and net appreciation in fair values are complete and accurate. Information including in the supplemental schedule of assets (held at end of year) and notes receivable from participants have also been derived from information certified by Fidelity.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and this supplemental schedule.

The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants may direct contributions to any of the investment options that consist of shares of mutual funds and common/collective trusts sponsored by Fidelity.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Units in Stable Value Common/Collective Trusts:* Valued at the NAV of units of the underlying investments of the common/collective trusts. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of its underlying investments held by the fund less its liabilities. The stable value funds are open-end commingled pools dedicated exclusively to the management of assets of defined contribution plans. The investment objective is to seek preservation of capital and a competitive level of income over time. To achieve its investment objective, the trust funds invest in underlying assets (typically fixed income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements) and enter into “wrapper” contracts issued by a third party. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **Note 6 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict that could have an impact on investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **Note 7 - Related-Party Transactions and Exempt Party-In-Interest Transactions**

Fidelity Management Trust Company, the trustee and custodian of the Plan, and its affiliates, manage certain mutual funds and collective trust funds held by the Plan. Transactions with such investments qualify as party-in-interest transactions that are allowable under ERISA. During the Plan year ended December 31, 2024, \$94,874 of administrative expenses were incurred by the Plan to Fidelity and other service Plan providers. As discussed in Note 1 under Other Income, receipts of revenue credits and payments of the credits qualify as party-in-interest transactions. Notes receivable also qualify as exempt party-in-interest transactions.

### **Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### **Note 9 - Tax Status**

The Internal Revenue Service ("IRS") has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed Fidelity of such in a letter dated June 30, 2020. The plan administrative committee/plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
