Notes to Financial Statements

---

**(1) Description of the Plan**

The following brief description of the United Food and Commercial Workers Local 152 Health and Welfare Fund (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a multiemployer, defined benefit health and welfare fund which was established in accordance with an agreement and declaration of trust, as amended, between United Food and Commercial Workers ("UFCW") Local No. 152 (the "Local") which represents retail meat cutters and other members employed primarily in the retail grocery industry in southeastern Pennsylvania, southern New Jersey, Delaware and Maryland. Beginning in March 2019, the Plan agreed to provide dental benefits to eligible members and dependents of the UFCW Local No. 27. The Trustees have contracted Tri-State Administrators, Inc. ("Tri-State") as third-party administrator.

The Plan is administered by a Board of Trustees, comprised of representatives of the Local and the Association. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Eligibility** - Participants eligibility varies according to the terms of the contributing employers' collective bargaining agreement ("CBA").

**Contributions** - All contributions to the Plan are made by participating employers in accordance with their collective bargaining agreements with the Local. The collective bargaining agreements require monthly contributions to the Plan at fixed rates based upon hours worked and employee classification. Employer contributions are determined by individual collective bargaining agreements with the Local Union. COBRA participant contributions are determined by the Plan's consultant in accordance with COBRA regulations. Certain employers are required to make additional contributions in accordance with their collective bargaining agreements if there is a deficit in the net assets of the Plan.

**Benefits** - Benefits are funded through employer contributions and through participants' contributions under the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

The Plan provides medical, hospital, prescription, dental, vision, disability income, educational assistance, legal and life insurance benefits. Dental, vision and life insurance benefits are provided under contracts between the Plan and several insurance providers. All other benefits are self-insured.

The Plan permits participation by employees represented by labor organizations other than the Local Union, as such labor organizations are approved from time to time by the Board of Trustees (the "Trustees").

**(2) Summary of Significant Accounting Policies**

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Adoption of New Accounting Standard** - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that is subject to the guidance in ASC 326 is employers' contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

**(2) Summary of Significant Accounting Policies (Continued)**

**Use of Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported ("IBNR"), eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Certain investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information principally provided by the Plans custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employers' Contributions Receivable** - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on a percentage of the participating employers' monthly payroll for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. The Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. As of December 31, 2024 and 2023, the Plan recorded a credit loss allowance of \$762,999 and \$367,840, respectively, for employers' contributions receivable.

**Rebates Receivable** - Rebates receivable represent amounts due from benefit service providers for rebates, which will be received during the next year, and for refunds of overpayments that occurred prior to or during the years ended December 31, 2024 and 2023. Rebates totaling \$9,395,143 and \$7,344,805 have been classified as a reduction to benefits paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

**Property and Equipment** - Property and equipment employed in operations are recorded at cost and depreciation is computed using the straight-line method over the estimated useful life of the asset. Gain or loss, if any, is recognized upon the disposal of property and equipment and the asset and related accumulated depreciation are removed from the accounts.

**Long-Lived Asset Impairment** - The Plan reviews the carrying value of property and equipment for impairment whenever events and circumstances indicate that the carrying value of an asset may not be recoverable from the estimated future cash flows expected to result from its use and eventual disposition. In cases where undiscounted expected future cash flows are less than the carrying value, an impairment loss is recognized equal to an amount by which the carrying value exceeds the fair value of assets. The factors considered by management in performing this assessment include current operating results, trends, as well as the effects of obsolescence and other economic factors. For the years ended December 31, 2024 and 2023, the Plan recorded no impairment charges against the carrying value of property and equipment.

**Payments of Benefits** - Premiums paid are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement.

**Leases** - Leases are categorized at their inception as either operating or financing leases. Operating right-of-use assets and liabilities are recognized at the lease commencement date based on the present value of the lease payments over the lease term. Leased assets represent the Plan's right to use an underlying asset for the lease term, and lease liabilities represent the Plan's obligation to make lease payments arising from the lease. The lease term may include options to extend or terminate the lease when it is reasonably certain that the Plan will exercise that option. Lease expense for lease payments is recognized on a straight-line basis over the lease term. The Plan uses a secured incremental borrowing rate as a discount rate for present value of the lease payments when the rate implicit in the contract is not readily determinable.

**(2) Summary of Significant Accounting Policies (Continued)**

**Administrative Expenses** - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Subsequent Events** - The Plan has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.

**(3) Benefit Obligations**

**Postretirement Benefits** - The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to participants' service rendered through December 31, 2024. Postretirement benefits include future benefits expected to be paid to or for: (1) currently retired or terminated participants and their beneficiaries and dependents and (2) active participants and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing plan assets. Prior to an active employees' full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The above figures were prepared by the Plan's consulting actuaries and are based upon their latest actuarial valuation as of December 31, 2024. The actuarial assumptions and techniques are related primarily to participant data, reasonable expectations and represent an estimate of anticipated experience under the Plan. Actual results could differ from those assumptions.

The discount rate, trend, and claims curves were updated to reflect actual and anticipated experience. The discount rate reflects the market value of high-quality, long-term bonds using the Citigroup above median double A curve as of December 31, 2024. The retiree contributions were also updated.

**(4) Fair Value Measurements**

Financial Accounting Standards Board ("FASB") Accounting Standards Codifications ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1**-Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2**-Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**-Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers Between Levels** - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. **(6) Benefit Administrators Agreements**

The Plan has an agreement with Horizon Blue Cross and Blue Shield of New Jersey (the "Provider"). The current contract expires May 31, 2025. Payments by the Plan to the Provider are based upon the amount of claims paid by the Provider during the preceding month plus a claims' administration charge. The Plan has a deposit with the Provider in the amount of \$2,438,771 and \$2,819,097 as of December 31, 2024 and 2023, respectively in accordance with the agreement. The benefit administrator fees paid to the Provider were \$4,187,614 and \$3,817,808 for the years ended December 31, 2024 and 2023, respectively.

The Plan has an agreement with Express Scripts, Inc. (the "Provider"). The current contract expires December 31, 2024, with automatic renewal for successive one year renewal terms. Payments by the Plan to the Provider are based upon the amount of claims paid by the Provider during the preceding month plus a claims' administration charge. The benefit administrator fees paid to the Provider were \$1,454,452 and \$1,634,995 for the years ended December 31, 2024 and 2023, respectively.

These agreements specify that in the event of termination of these agreements, the Plan is liable for all claims incurred prior to the date of termination plus the claims' administration charge and other charges. The Provider will continue to administer payment for services incurred prior to termination, provided the request for benefits is received within eighteen months after the date the charges for services were effective.

**(7) Commitments**

The Plan has a contract with Tri-State Administrators, Inc. for monthly administrative services expiring December 31, 2024, with consecutive one-year automatic renewals unless terminated by either party by written notice at least ninety days advance notice. Several employees of Tri-State Administrators, Inc. are participants in the UFCW 152 Health and Welfare Fund. The fees paid to the Administrator are \$36.13 per participant in year one of the contract and increase annually to \$39.09 per participant in 2024. During the years ended December 31, 2024 and 2023, Tri-State Administrators, Inc. fees incurred were \$4,784,305 and \$4,446,122 for monthly administrative services, respectively. In addition, for the years ended December 31, 2024 and 2023, the Plan incurred \$152,723 and \$129,565, respectively, of additional administrator fees for special projects. The total administrator fees for the year ending December 31, 2024 and 2023 were \$4,937,028 and \$4,575,687, respectively.

**(8) Related Party and Party in Interest Transactions**

The Fund is reimbursed by the Retail Meat Pension Fund, a related benefit fund for their proportionate share of salary expense which amounted to \$125,000 and \$-0- for the years ended December 31, 2024 and 2023, respectively.

**(9) Termination of the Plan**

Although it has not expressed any intention to do so, the Plan may be terminated by the Board of Trustees, by unanimous vote, subject to collective bargaining agreements and applicable law. Upon termination of the trust, it shall be divided in accordance with the Board of Trustees determination and applicable law. In no event shall any assets of the Trust revert to any employer or union.

**(10) Tax Status**

The Plan has received an exemption letter from the IRS dated December 5, 2016, stating that the VEBA trust established under the Plan was in compliance with the applicable requirements of the provisions of Section 501(c)(9) of the IRC. No federal or state income taxes have been recorded in 2023 for unrelated business taxable income. The Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(11) Risks and Uncertainties**

**Investment Risk** - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**(11) Risks and Uncertainties (Continued)**

**Actuarial Assumptions** - Plan benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, healthcare cost trend rate and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Concentration of Credit Risk** - The Plan maintains cash accounts at high credit-quality financial institutions. Cash accounts at these financial institutions are insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000. From time to time, the Plan may have amounts on deposit in excess of FDIC limits. Management believes the Plan is not exposed to any significant credit risk on its cash accounts. As of the years ended December 31, 2024 and 2023, the Plan had cash balances in excess of federally insured limits of \$40,000,000 and \$30,370,000, respectively.
