Notes to Financial Statements

(1) Description of the Plan

The following brief description of the UFCW Local 152 Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a multiemployer, defined contribution profit sharing pension plan covering participants employed in the food service industry whose employers executed collective bargaining agreements with the United Food and Commercial Workers Union Local 152, AFL-CIO (the "Local Union") which represents food industry employees in southern New Jersey, southeastern Pennsylvania, and northern Delaware. The Plan is administered by a Board of Trustees (the "Trustees") having equal representation by the employers and the Local Union. The Trustees have contracted Tri-State Administrators, Inc. ("Tri-State") as the third-party administrator, and John Hancock Retirement Plan Services, LLC ("John Hancock") as the Plan's recordkeeper and investment custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - All contributions to the Plan are made by participating employers and elective 401(k) participant contributions. Participating employers' contributions rates are determined by the individual collective bargaining agreements. The Plan permits participants to contribute contracted wage increases as elective 401(k) contributions. Employees are generally eligible to participate after completion of one year, but are eligible no later than after completion of two years, of continuous service.

Investment Elections - Participants self-direct all contributions among available investment funds.

Vesting - Participants are 100% vested in their account balances at all times.

Participant Accounts - Each participant's account is credited with the participant's contributions, the participant's employer's contributions and allocations of investment earnings (losses), and charged with benefit payments made and an allocation of administrative expenses paid by the Plan. Administrative expenses are withdrawn quarterly through a fee determined by the Board of Trustees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are entitled to direct the investment of their account balance to the options provided by the Plan. All investments in the Plan are participant-directed investments.

Payment of Benefits - Upon termination of service due to retirement, disability, or death, a participant may elect to receive either a lump sum amount or in installments in accordance with provisions of the Plan. The Plan provides that if a participant's employment is terminated prior to normal retirement, death, or permanent disability and such participant is not reemployed in the food industry within two years, the participant's accrued benefit shall be paid to him or her. In the event of the death of a participant, benefits will be paid to the participant's beneficiary in accordance with the participant's benefit election. The Plan also allows for hardship distributions subject to Plan provisions.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes to Financial Statements

(2) Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition - Certain investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive contracts held by the Plan are recorded at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employers' Contributions Receivable - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on a percentage of the participating employers' monthly payroll for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. The Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. As of December 31, 2024 and 2023, the Plan recorded a credit loss allowance of \$12,869 and \$10,830, respectively, for employers' contributions receivable.

Participants' Contributions Receivable - Participants' contributions receivable are stated at the amount the Plan expects to collect from participants pursuant to their elective deferrals to the Plan.

Payments of Benefits - Benefits are recorded when paid.

Administrative Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events - The Plan has evaluated subsequent events through October 10, 2025 the date on which the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codifications ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1-Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(3) Fair Value Measurements (Continued)

Level 2-Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3-Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

(4) Group Annuity Contract With New York Life Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with New York Life Insurance Company (NYLIC) totaling \$22,030,327 for 2024 and \$23,202,696 for 2023. NYLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by NYLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

(5) Related Parties and Parties in Interest

The Plan has four related entities; the UFCW Local 152 Health and Welfare Fund (the "Health and Welfare Fund"), the UFCW Local 152 Retail Meat Pension Fund (the "Retail Meat Pension Fund"), the UFCW Local 152 South Jersey Pension Fund, and the Local Union. The Plan has common trustees with these related entities.

During the years ended December 31, 2024 and 2023, participants with an account balance were assessed an annual fee of \$53 totaling \$312,324 and \$304,711, respectively. The Plan utilizes these amounts to pay for administrative expenses.

(6) Commitments

The Plan has a contract with Tri-State Administrators, Inc. for monthly administrative services expiring December 31, 2024, with consecutive one-year automatic renewals unless terminated by either party by written notice at least ninety days advance notice. Several employees of Tri-State Administrators, Inc are participants in the UFCW 152 Savings Plan. The fees paid to the Administrator are \$4.80 per participant in year one of the contract and increase annually to \$5.84 per participant in 2024. During the years ended December 31, 2024 and 2023, Tri-State Administrators fees incurred were \$281,578 and \$273,351 for monthly administrative services, respectively. In addition, for the years ended December 31, 2024 and 2023, the Plan incurred \$5,726 and \$17,453, respectively, of additional administrative fees for special projects. Additionally, during the years ended December 31, 2024 and 2023, other fees included in record keeping and administration expense were paid to John Hancock in the amount of \$9,435 and \$-0-, respectively.

(7) Tax Status

The Plan obtained a its latest tax determination letter on December 8, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

(8) Plan Termination

Although it has not expressed any intent to do so, the Board of Trustees have the right under the Plan to discontinue its operations at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Board of Trustees may determine.

(9) Risks and Uncertainties

Investment Risk - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Concentration of Credit Risk - The Plan maintains its cash balances in high credit quality financial institutions. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 for each participant's non-contingent interest. At times, such cash balances may be in excess of participant insured limits.
