Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of The Innovation Institute, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of the Plan

The following brief description of The Innovation Institute, LLC 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan and is sponsored by The Innovation Institute, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was originally adopted by the Company effective February 1, 2012, and was amended and restated effective January 1, 2023.

Effective May 31, 2024, the Plan was formally amended for the merger of the Hospitality Business Network Solutions 401(k) Profit Sharing Plan into the Plan. The total value of \$317,397 was transferred into the Plan effective May 31, 2024.

Eligibility

The Plan covers all employees of the Company, except collectively bargained employees, nonresident aliens, and Far West employees with variable hours. Employees become eligible to participate in the Plan when they have attained age 21 and can enter the Plan immediately upon meeting eligibility requirements. Long-term part-time employees who met eligibility requirements under SECURE 2.0 are also eligible to participate in the Plan.

Contributions

Contributions consist of employee elective deferral contributions (including pre-tax and Roth deferrals), Participant rollover contributions, employer matching contributions, and nonelective employer contributions. Participants may contribute up to 100% of eligible compensation subject to annual limitations set forth in Section 402(g) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to maximum allowed by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Eligible employees are automatically enrolled with a 6% salary deferral upon meeting the eligibility requirements, unless they voluntarily elect not to participate in the Plan or elect an alternative salary deferral percentage.

The Company has elected to contribute a discretionary matching contribution whereby Participants in the Plan who have completed one year of service may receive 50% of the Participant's salary deferrals not to exceed 1% of the Participant's compensation. The Company may also choose to make a discretionary nonelective Company contribution and/or a qualified nonelective Company contribution. Discretionary profit-sharing contributions were made in the amount of \$321,349 for the year ended December 31, 2024.

Participant Accounts

Each Participant's account is credited with the Participant's contributions, Company matching contributions, allocations of the Company's additional discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings, account balances, or specific Participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance.

1. Description of the Plan (cont.)

Notes Receivable from Participants

Participants may borrow from their vested fund accounts a maximum equal to the lesser of (a) \$50,000 reduced by excess (if any) of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the loan is made, or (b) 50% of their vested account balance. The maximum loan term is five years, except loans issued for the purchase of a primary residence in which case the note receivable term may exceed five years. The loans are secured by the balance in the Participant's account and bear a reasonable rate of interest equal to the prime rate plus 1% as defined by the Plan. Principal and interest are paid through payroll deductions. Participants may only have one loan outstanding at a time.

Benefit Payments

Participants are eligible to receive a distribution from their accounts upon retirement, death, or separation from service with the Company. Distributions are paid in the form of lump sums, substantially equal installments, or partial withdrawal payments, and are either paid directly to the Participants or rolled over to another qualified retirement plan. If a terminated Participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account designated by the Company. Under certain qualifying circumstances, hardship withdrawals are also permitted under the Plan. The Plan also provides for in-service withdrawals for Participants who have attained age 59½.

Vesting

Participants are immediately vested in the value of their salary deferrals, and rollovers, plus related investment earnings. Any Company discretionary matching contributions and Company nonelective contributions vest according to the following schedule:

A Participant will become fully vested in Company matching contributions and any Company non-elective contributions, regardless of length of service, in the event of death or disability.

Forfeited Accounts

Non-vested account balances of terminated employees are forfeited upon the earlier of the complete distribution of the vested portion of the Participant account, or the last day of the Plan year in which the Participant incurs five consecutive 1-year breaks in service. Forfeited non-vested accounts totaled \$39,656 and \$90,882 at December 31, 2024 and 2023, respectively. Forfeitures can be used to reduce any Company contributions or pay reasonable Plan expenses. Forfeitures were used to offset Company contributions of \$97,274 and pay Plan expenses of \$35,150 for the year ended December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income (Loss) Recognition

The investments of the Plan are reported at fair value, with the exception of fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount Participants normally would receive if they initiate permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date (the exit price). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

Contributions

Contributions from Plan Participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments and the Plan administrator deems the Participant loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to Participants are recorded when paid.

Plan Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan document. Certain other administrative expenses of the Plan are paid by the Company. Investment fees are paid by the Plan in the form of reductions of net investment income earned by Plan Participants.

3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate account - Valued at net asset value (NAV) as a practical expedient to estimate fair value based on the last reported sales price of the underlying investments held and the number of units held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments at fair value as of December 31, 2024 and 2023 are made up entirely of pooled separate accounts, which are measured at the NAV as a practical expedient. Certain investments that were measured as such are not classified in the fair value hierarchy. The Plan has no assets at December 31, 2024 and 2023 that are classified in the fair value hierarchy.

5. Investment Contract with Insurance Company

The Voya Fixed Accounts are fully benefit-responsive guaranteed investment contracts with Voya. Voya maintains the contributions in general accounts. The accounts are credited with earnings (losses) on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Voya makes this guarantee, and although Voya may credit a higher interest rate, the credited interest rate will not fall below the lifetime guaranteed minimum of 3%.

As described in Note 2, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by Voya, represents contributions made under the contracts, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Participants are probable of occurring.

6. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by Benetech, Inc. The Internal Revenue Service (IRS) has opined and informed Benetech, Inc. by a letter dated June 30, 2020, stating that the Pre-Approved Plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants would become 100% vested in their Company contributions, which were not already 100% vested.

8. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, and party rendering service to the Plan, the Company, and certain others. Usual and customary fees were paid for recordkeeping and investment management services, which qualify as party-in-interest transactions. All Plan investments are managed and provided by Voya. Voya is the contract holder and certifying entity as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from Participants are also defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

10. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

11. Subsequent Events

Management has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued. Management has determined that no significant events, except as noted below occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.

Effective July 31, 2025, all Plan assets were transferred from Voya Retirement Insurance and Annuity Company (“Voya”) to John Hancock Retirement Plan Services (“John Hancock”). The transfer was completed in accordance with Plan provisions and applicable regulatory requirements.
