Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Arc/Barc 403(b) Tax Deferred Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 - Description of the Plan

The following description of the Arc/Barc 403(b) Tax Deferred Annuity Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective December 15, 1998 by Arc Broward, Inc. and Barc Housing, Inc. (collectively the Company or Employer) and is the sponsor of the Plan. The Plan is a defined contribution plan covering eligible employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). It permits participants to defer a portion of their compensation, subject to statutory limits, and to direct the investment of their contributions among the investment options offered by the Plan.

Prior to the current plan year, the Plan was funded solely through annuity contracts issued by Lincoln National Life Insurance Company, qualifying under IRC Section 403(b)(1) (the "Annuity Contract").

Plan Amendment and Restatement

Effective February 27, 2024, the Plan was amended and restated prospectively to expand the available investment options to include mutual fund custodial accounts qualifying under IRC Section 403(b)(7) (the "Custodial Account"), in addition to the existing Annuity Contracts. The amendment was adopted to provide participants with a broader range of investment choices and to align the Plan with current market practices for 403(b) arrangements under a Combination Custodial Account and Annuity Contract plan.

The restatement was implemented prospectively; therefore, no prior period financial information has been restated. Balances held under the Annuity Contract as of the restatement date remained in place. Beginning on and after February 27, 2024, new contributions and any participant-directed transfers may be allocated among both the Annuity Contract and the newly added Combination Custodial Account and Annuity Contract in accordance with participant investment elections. The opening balance of the Combination Custodial Account and Annuity Account at the amendment date was \$4,944,441, and a corresponding reclassification was made from the Annuity Contract balance.

Although certain participant account balances were transferred from the Annuity Contract into the Combination Custodial Account and Annuity Contract following the restatement, not all existing balances were transferred. As of December 31, 2024, the Plan continued to hold investments under both the Annuity Contract and the Combination Custodial Account and Annuity Contract.

Plan Amendment and Restatement (cont'd)

The prospective restatement described above did not result in any reclassification or restatement of prior year balances and had no effect on total net assets available for benefits as of the beginning of the year. The Plan's fiduciaries evaluated the impact of adding mutual fund custodial options and determined that the expanded investment structure provides participants with greater diversification opportunities.

As of December 31, 2024, approximately 6% of Plan assets remained invested in the Annuity Contract and 94% were invested in the Combination Custodial Account and Annuity Contract. The fiduciaries have reviewed and updated the Plan's investment policy to address the differing risk and return characteristics of these investment types.

Custodian and Administration of the Plan

The custodian of the Plan is the Lincoln National Life Insurance Company (the Custodian). The recordkeeper of the Plan is Lincoln Financial Group, an affiliate of the Lincoln National Life Insurance Company. The administrator of the Plan is the Company. The custodian holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees of the Company that are eighteen (18) years or older, except for nonresident aliens with no U.S. source of income, are considered eligible for participation in the Plan.

An eligible participant can enter the Plan immediately upon meeting the eligibility requirements. Entry date is the first date of the month coinciding with or next following the date you satisfy the eligibility conditions.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan. Salary deferral agreements shall be made, terminated, or changed according to procedures and limitations set up by the Plan Administrator and the Plan Document.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Special catch-up contributions are permitted for participants who are 50 or older with 15 years of service completed during the plan year.

Contributions (cont'd)

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may make a discretionary employer matching contribution as a percent of eligible compensation deferred by participants. Non-resident aliens who do not receive any compensation from U.S. sources and certain highly compensated employees are not eligible to receive a discretionary employer matching contribution under the Plan. A participant who is an employee regularly scheduled to work less than 20 hours per week and has otherwise satisfied all conditions to receive a discretionary employer matching contribution must be credited with 1,000 hours of service during the plan year and be employed on the last day of the plan year to receive an allocation of the discretionary employer matching contribution. During 2023, the Company matched 50% of participant contributions up to 4% of eligible compensation (maximum match of 2%).

Effective July 1, 2022, the Plan was amended to permit participants to make Roth deferrals. The Plan was also amended to include all elective contribution sources for matching contributions, including any Roth deferrals and catch-up contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are 100% vested in their individual deferral, Roth, rollover and discretionary employer matching contributions and the allocated earnings thereon.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Participants may also withdrawal an amount at age 59 ^{1/2} if certain criteria are met.

Plan Loans

Under the terms of the Plan, participants may enter into a loan agreement directly with Lincoln National Life Insurance Company (Lincoln). Plan loans are issued directly from Lincoln and not directly from a participant's account. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of (a) 50 percent of their pre-tax, or (b) \$50,000 reduced by the participants highest outstanding loan balance in the previous twelve months. Loans must have a definite repayment period of 3 to 5 years for a general-purpose loan and 6 to 20 years for the purchase of a primary residence; however, a loan minimum of \$10,000 is required for 15 to 20-year loans. The loans are collateralized by a portion of the balance in the individual participant's account and are held in specific funds with Lincoln. The interest rate will be determined quarterly and will be the Moody's Corporate Bond Yield monthly average for the calendar month two months prior to the first day of each calendar quarter, rounded down to the next 0.25%. As of December 31, 2024 and 2023, loans collateralized by participant accounts were approximately \$162,000 and \$106,000, respectively. The loan collateral is considered a Plan asset and is included in the caption "Investments, at contract value" in the accompanying Statements of Net Assets Available for Benefits.

Each participant may not have more than 2 loans outstanding at any time.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments consist of mutual fund custodial accounts and insurance annuity contracts.

Custodial Accounts: Mutual fund investments held in custodial accounts are reported at fair value based on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by its investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Annuity Contracts: These contracts are issued by Lincoln National Life Insurance Company and are reported at contract value, which represents contributions plus credited earnings less any withdrawals, as this amount approximates fair value and is the basis for transactions with participants. See Note 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The addition of the Custodial Accounts represents a prospective change in the Plan's investment structure during the year. The Plan's investment balances at December 31, 2024 were as follows:

Investment Valuation and Income Recognition (cont'd)

Investment income for the year ended December 31, 2024 consisted of interest and credited earnings from the Annuity Contracts totaling \$22,910, and net appreciation (including dividends and realized/unrealized gains) on Custodial Account investments totaling \$485,620.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

Note 3 - Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net depreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance Company, a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedules, including assessing whether the supplemental schedules are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 - Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits as follows:

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts (PSAs): Pooled separate accounts are valued at the net asset value of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Lincoln, is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. Investment strategies of these investments are to offer differing types of alternative platforms with differing levels of risk to the Plan. There are no unfunded commitments or redemption restrictions.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value hierarchy tables are not presented for investments measured at fair value on a recurring basis given that all investments at fair value are measured at NAV as the practical expedient.

Note 5 - Guaranteed Investment Contracts

The Plan entered into a fully benefit-responsive guaranteed investment contracts with Lincoln. Lincoln maintains the contributions in general accounts. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 7 - Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Lincoln. Participant loan and distribution processing fees are paid to Lincoln by participants. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

Note 8 - Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

Note 9 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 10 - Tax Status

The Plan uses a pre-approved plan document sponsored by Lincoln. Lincoln received an opinion letter from the IRS, dated March 31, 2017, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

Note 11 - Subsequent Events

Management has evaluated events and transactions for subsequent events that would impact the financial statements for the year ended December 31, 2024, through October 15, 2025, the date the financial statements were available to be issued.
