NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Visionet Systems Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Visionet Systems Inc. (the "Company"). To be eligible to participate in the Plan, an employee must have attained the age of 21 and have completed six months of service. The assets of the Plan are maintained in a trust managed by Mid Atlantic Trust Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and was established effective January 1, 2004.

Contributions

Participants may elect to defer 1% to 92% of eligible compensation in 1% increments. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits participants to roll over certain amounts from another qualified retirement plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

The Company has a safe harbor contribution where it matches employee contributions equal to 100% of the participant's pre-tax and Roth deferral contributions that do not exceed 3% of his or her compensation (as defined by the Plan) and 50% of the participant's pre-tax and Roth deferral contributions that exceed 3% of his or her compensation not to exceed 5%. Additional amounts representing a Profit-sharing contribution may be contributed at the discretion of the Company. No such additional Profit-sharing contributions were made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions as well as an allocation of Plan earnings and Plan expenses incurred by or attributable to a particular participant based on use of a particular feature. Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Allocation of Investments

Participants make an election designating the proportion in which contributions are to be allocated among the specific assets, funds or other investments permitted under the Plan (participant-directed investment program). Participants may change their allocations and make transfers among funds.

Vesting

Participants are immediately vested in their contributions, the employer matching contributions and rollover contributions plus actual earnings thereon. Profit sharing contributions to the Plan and any earnings that they generate become 100% vested when the employee has completed three years of credited service.

Forfeitures

A participant who terminates employment and is less than 100% vested, forfeits the non-vested portion of his or her account. Forfeitures are used to pay administrative expenses or reduce contributions of the Company. During the year ended December 31, 2024, no forfeitures were applied against contributions of the Company and there were no forfeited balances as of December 31, 2024 and 2023.

Notes Receivable from Participants

Eligible participants may borrow up to 95% of one half of their vested account balance, not to exceed \$50,000. A participant may only have one loan outstanding at any time. The terms of the loan cannot exceed five years, unless proceeds are used to purchase a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at the prime rate plus 1% on the date of the note. Principal and interest are paid through payroll deductions and monitored by the Plan Administrator. The loans are considered party-in-interest transactions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive partial payment, installment payment, or a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for in service withdrawals due to hardship or upon attainment of age 59 ½. Required minimum distributions in accordance with the Internal Revenue Code also apply.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of Plan assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

All non-investment administrative expenses of the Plan are paid by the Company.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mid Atlantic Trust Company has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i, schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to measure and maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Mutual funds are valued at unadjusted quoted market prices, which represent the net asset value of the shares held by the Plan at year end. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of Mid Atlantic Trust Company. Mid Atlantic Trust Company is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, with the approval of the Board of Directors and subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Plan is a prototype non-standardized Profit sharing plan sponsored by Paychex, Inc. ("Paychex"). Paychex has obtained an opinion letter on the prototype plan dated August 30, 2020 stating that the form of the Plan is acceptable under Section 401 of the IRC. Generally, the Plan Administrator and the Plan may rely on the opinion letter received by Paychex as to the form of the Plan qualifying under the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's investment fund options provide participants with a variety of investment alternatives with differing levels of risk and income potential. Investment securities are exposed to various risks, such as significant world events, interest rates, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in the values of investments could occur in the near term and that such changes could materially affect participants' account balances and the reported amounts in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2025, the date these financial statements were available for issuance. Management is not aware of any material subsequent events which would require recognition or disclosure in the accompanying financial statements.
