We have performed audits of the financial statements of Jetro Cash & Carry Enterprises, LLC Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Jetro Cash & Carry Enterprises, LLC Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan, established on February 2, 1985 is a participant-directed defined contribution plan covering JRD Unico, Inc. (the “Company” or the “Employer”) to provide benefits to eligible employees as defined in the Plan document. Employees who have completed one year of service and have attained age 18 are eligible to participate in the Plan. The Recordkeeper of the Plan is JPMorgan Chase N.A., which outsourced the Trustee function to Empower Trust Company, LLC for the years ended December 31, 2024 and 2023 (collectively, the “Trustee”). The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Contributions**

Each year, participants may contribute to the Plan amounts not less than 1% of compensation, as defined by the Plan, up to a maximum percentage pursuant to the Plan document. Such contributions are excluded from the participant’s federal taxable income until received as a withdrawal or distribution from the Plan. Participants may also contribute amounts representing rollover distributions from other qualified plans. Contributions are subject to certain limitations. A participant may change their contribution percentage daily and may cease contributions at any time. During 2024, the maximum annual 401(k) pre-tax contribution limit was \$23,000, and the maximum annual catch-up contribution for participants aged 50 and older was \$7,500.

The Company is not required to make contributions to the Plan. If the Company elects to make contributions, the amount of contributions made by the Company for any given year shall not exceed the maximum amount allowable as a deduction by the Company for federal income tax purposes. The Company may calculate the discretionary employer contribution based on any or all of the following three methods:

- a. Matching contribution equal to a percentage of a participant’s deferred compensation.
- b. Contribution equal to a percentage of a participant’s eligible compensation, as defined.
- c. An additional amount determined by the Company.

For the year ended December 31, 2024, the Employer decided to make a matching contribution of 66.6% of each employee’s first 6% of deferral contributions to the Plan, up to 4% of compensation. In 2024, the employer matching contributions totaled \$3,182,026. Additionally, the Company may make discretionary profit-sharing contributions and additional qualified non-elective contributions (“QNECs”). For 2024, there were no discretionary profit-sharing contributions, QNECs or employer match contributions made to the Plan.

##### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is charged or credited as applicable with the participant’s contribution, the account earnings (losses), an allocation of the Employer’s contribution and forfeitures of terminated participants’ non-vested accounts and administrative expense. Allocations of employer contributions and forfeitures are based on the participants’ eligible compensation or salary deferral. As a participant-directed plan, each participant’s investments determine their share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The value of each investment is determined by the Trustee on a daily basis.

### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

#### Vesting

Participants are immediately vested in their contributions, rollovers and QNECs, plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of continuous service. Participants become 100% vested in employer matching contributions after five years of continuous service as follows:

<u>Years of Service</u>	<u>Vesting %</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 or more	100%

Upon the participant's attainment of age 65, permanent disability, death, or the termination of the Plan, the participant's account will automatically become 100% vested in employer contributions.

#### Investment Options

Upon enrollment in the Plan, participants may direct the investment of their contributions in 1% increments into various investment options made available by the Employer under the Plan. Participants may change their contribution investment options daily and may transfer part or all of past investments to other funds daily. The Plan previously offered a self-directed brokerage option through Charles Schwab. This option was for investors who wanted to actively manage a greater choice of investments.

#### Notes Receivable from Participants

Participants may borrow from their vested fund account balance a minimum of \$1,000 and up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding Plan loan balance during the preceding year or (b) one-half of the value of their vested fund account. The maximum payment term allowed for any loan will be five years (unless the loan is for the purchase of a principal residence in which case the term may be longer) with interest fixed at the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) plus 1% at the time of the approval of the loan. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.75% and mature at various dates through December 2053. Principal and interest are paid ratably through payroll deductions. Participant loans are valued at their unpaid principal balance plus accrued interest.

#### Deemed Distributions

Deemed distributions are recorded at the discretion of the Employer when a participant ceases making repayments on a loan from the Plan. These amounts are no longer included in net assets available for benefits. As of December 31, 2024, there was \$146,933 of deemed distributions.

#### Benefit Payments

Upon termination of service due to death, disability or retirement, as defined in the Plan, participants are generally entitled to a fully vested lump-sum payment of their account balance. For termination of service due to other reasons, participants are entitled to the value of the vested interest in their account as a lump-sum distribution. As of December 31, 2024 and 2023, all employees who elected to withdraw from the Plan had been paid.

#### **Expenses of the Plan**

Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Certain Plan expenses are deducted from participant accounts, and the remainder of the Plan expenses are generally paid by the Employer.

#### **Forfeited Accounts**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. However, if the participant is re-employed and fulfills certain requirements, as defined in the Plan, the participant's account will be reinstated. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$170,863 and \$138,228, respectively. Unused forfeitures may be used to reduce administrative costs of the Plan. Any remaining amounts may then be used to reduce future employer matching contributions. For the year ended December 31, 2024, \$17,206 of forfeitures were used to offset administrative costs of the Plan and no forfeitures were used to offset employer matching contributions.

#### **Hardship and In-Service Withdrawals**

Hardship withdrawals by the Plan participants may be made upon written request and approval of the Trustee. If approved, the distribution is limited to the amount necessary to meet the financial need created by the hardship.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value except for the fully benefit responsive investment in the JPMorgan Stable Asset fund which is stated at contract value (see Note 5). Shares of mutual funds and common stocks are valued at quoted market prices which represent the net asset value ("NAV") of shares/units held by the Plan at year-end. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through the date these financial statements were issued, October 15, 2025.

### **NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments, cash and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in the fair value of the investments, dividends and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

### NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted market prices of shares or units held by the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5 – JP MORGAN STABLE ASSET FUND**

The JP Morgan Stable Asset Fund (the “Fund”) is a collective trust fund with underlying investments in investment contracts that are valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Fund seeks to maintain principal value, protect against market price volatility, obtain consistent income return and provide liquidity for benefit payments and withdrawals. The Fund invests primarily in investment contracts issued by insurance companies, banks and other financial institutions, and other instruments authorized by the JPMorgan Chase Stable Value Fund Declaration of Trust. Some alternative investment contracts are managed on an evergreen, or contract duration, basis. An evergreen contract has no predetermined maturity and the asset portfolio is managed to a target duration.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the Funds, plus earnings, less participant withdrawals and administrative expenses.

The Fund imposes certain restrictions on the Plan, and the Fund may be subject to circumstances that impact its ability to transact at contract value, as described in the following paragraphs. Fair value of the Fund was \$9,648,193 and \$9,709,924 at December 31, 2024 and 2023, respectively.

#### **Limitations on the Ability of the Fund to Transact at Contract Value**

Circumstances that impact the Fund - The Fund invests primarily in “wrap” contracts (also known as synthetic Guaranteed Investment Contracts (“GICs”)) issued by third parties. The Fund purchases a wrap contract from a high-quality insurance company or bank. The wrap contract amortizes the realized and unrealized gains and losses on the underlying bonds, typically over the duration of the bonds, through adjustments to the future interest crediting rate. The issuer of the wrap contract provides assurance that the adjustments to the interest crediting rate do not result in a future interest rate that is less than zero. An interest crediting rate less than zero would result in a loss of principal or accrued interest.

Participant-directed withdrawals in accordance with the Plan are payable at contract value even if the withdrawal is precipitated by an employer-initiated event, so long as the employee experiences a bona fide job loss. In the event of a spin-off or sale of a division where the employee does not experience a bona fide job loss, the issuer will make a clone contract available to the successor employer’s plan.

In the event that the Plan is terminated, there is a material adverse change to the provisions of the Plan, or the employer elects to withdraw from a contract in order to switch to a different investment provider, the amount withdrawn from the contract would be payable at fair value rather than contract value.

### **NOTE 6 – EXEMPT PARTY-IN-INTEREST**

At December 31, 2024, certain plan investments were managed by Reliance Trust and therefore these transactions qualify as party-in-interest transactions. In addition, the Plan provides loans to Plan participants that qualify as exempt party-in-interest transactions. JPMorgan Chase Bank N.A., the Recordkeeper, sponsors funds that the Plan invests in. Administrative expenses paid by the Plan to the Trustee and Recordkeeper during 2024 amounted to \$4,415.

### NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### NOTE 8 – TAX STATUS

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with a Cash or Deferred Arrangement (“CODA”) sponsored by Laiken Associates Inc. which received an opinion letter from the Internal Revenue Service (“IRS”), dated November 30, 2020, as to the Plan’s qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and accordingly no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan does not believe it has any uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s administrator believes it is no longer subject to tax examinations for years prior to 2021.
