## Independent Auditor's Report

To the Participants and Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of the San Antonio Academy Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from the qualified institutions as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matters***

#### ***Supplemental Information Required by ERISA***

#### **Note 1 – Plan Description**

The following description of the San Antonio Academy Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a 403(b) defined contribution retirement plan that is intended to be used by tax-exempt organizations described in Internal Revenue Code Section 501(c)(3). The Plan covers all employees of the San Antonio Academy of Texas, Inc. and MIV 2200, LLC (collectively, the “Organization” or “Employer”). The Plan, which commenced effective January 1, 1985, which was amended and restated effective January 1, 2022, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

##### ***Plan Custodians***

Empower Trust Company, LLC (“Empower” or the “Trustee”), Empower Annuity Insurance Company of America (“Empower Insurance”), and Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (“TIAA-CREF”) (collectively, the “Custodians”) are the Plan’s Custodians and maintain custody of all investments held by the Plan. Empower Retirement, LLC and TIAA-CREF (the “Recordkeepers”) maintain the Plan’s participant account balances and provide recordkeeping services to the Plan. Among other duties, the Recordkeepers receive contributions, hold and invest the fund assets in accordance with the direction of participants, and make distributions as directed by the Plan Administrator.

##### ***Eligibility and Plan Entrance Date***

Certain employees are not eligible to participate in the Plan, including students performing services for the San Antonio Academy of Texas while pursuing a course of study, part-time employees who are expected to work fewer than 1,000 hours in their first 12 months of employment, and individuals considered independent contractors, including those later reclassified as employees by the Internal Revenue Service (“IRS”). If an employee works 1,000 hours of service in a 12-month period, the participant will be eligible for the Plan the following year. Once the employee has worked 1,000 hours in a 12-month period the employee will remain eligible for the Plan even if they fail to work 1,000 hours in a subsequent 12-month period. All other employees are eligible to make elective deferrals immediately upon hire. Employees become eligible to receive matching and non-elective contributions once they complete 1,000 hours of service in a 12-month period. Eligibility for Employer contributions begins on the first day of the month following the completion of the 1,000-hour requirement.

##### ***Contributions***

Participants may elect to contribute, on a before-tax or Roth basis, up to 100% of their eligible compensation, up to the maximum amount permitted for deferral annually under the IRC, which was \$23,000 for 2024. Participants who reach the age of 50 on or before the end of a Plan year are allowed to make additional before-tax catch-up contributions of up to the maximum amount permitted annually under the IRC, which was \$7,500 for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

#### Note 1 – Plan Description (continued)

##### *Contributions (continued)*

Each year, on January 1, participants with a deferral rate greater than 0% will have their deferral contribution rate increased by 1% until the rate reaches a maximum of 6% of eligible compensation, unless they elect otherwise.

The Organization may make discretionary matching contributions, as determined by the Employer. During 2024, the Employer made discretionary matching contributions in an amount equal to 100% of the first 3% that each eligible participant contributed to the Plan. In addition, the Employer made a 4% non-elective profit-sharing contribution. Employees must be employed on the last day of the Plan year in order to receive profit-sharing contributions. Contributions are subject to certain limitations.

##### *Participant Accounts*

Each participant account is credited with the participant's contributions, Employer's contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately vested in their contributions and the Organization's contributions plus earnings thereon.

##### *Participant-Directed Investments*

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The funds vary in type of investment, rates of return, and investment risk.

##### *Payment of Benefits*

Upon termination of service due to death, disability, retirement, or other separation from employment, a participant may elect to receive their vested account balance as a lump-sum payment, installments, or an annuity, subject to the Plan's distribution options. If a participant's vested account balance exceeds \$5,000, they may elect to maintain their balance within the Plan. If a participant's vested account balance is greater than \$1,000 but less than \$5,000, it is subject to an automatic rollover into an Individual Retirement Account ("IRA") unless the participant elects otherwise. Hardship withdrawals are permitted as defined by the Plan, and in-service withdrawals are available upon attainment of age 59 ½.

#### Note 2 – Summary of Significant Accounting Policies

##### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP"). Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts.

#### **Note 2 – Summary of Significant Accounting Policies (continued)**

##### ***Basis of Accounting (continued)***

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

##### ***Reclassifications***

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 financial statements presentation. These reclassifications had no effect on changes in net assets available for benefits.

##### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

##### ***Administrative Expenses***

Charges for withdrawals for payment of benefits to participants and the Plan's recordkeeping fees are paid by the Plan and are reflected in these financial statements as Plan administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and are included in net appreciation of fair value of investments. All other expenses of the Plan are paid by the Employer.

#### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Non-Benefit-Responsive Investment Contract** – valued using a discounted cash flow model that considers recent fee structure changes, duration, and current market interest rates for similar instruments. Because the valuation is based on unobservable assumptions, these contracts are classified as Level 3 within the fair value hierarchy.
- **Pooled Separate Account** – The Teachers Insurance and Annuity Association of America (“TIAA”) Real Estate Pooled Separate Account is valued at the NAV per accumulation unit of the investment. The underlying real estate holdings or other real estate-related investments are valued principally by utilizing external appraisals. Although the underlying assets of the account cannot be quickly sold and converted to liquid assets, the TIAA general account provides the Plan with a liquidity guarantee. Transfers out of the pooled separate account are limited to one per quarter. There are no unfunded commitments or redemption notice periods. Unit values are published daily by TIAA-CREF.

#### Note 5 – Group Annuity Contracts with Insurance Company

##### *TIAA-CREF*

The Plan offers an investment option in group annuity contracts that are fully and unconditionally guaranteed by TIAA, a New York domiciled nonprofit legal reserve life insurance company, one of which is fully benefit-responsive while the other is not. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest and the potential for additional interest if declared by TIAA. Investments in the TIAA Traditional Annuity are secured by the general assets of TIAA and backed by the claims-paying ability of TIAA.

Fair value is the relevant measure for non-benefit-responsive investment contracts, and contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the Plan. Non-benefit-responsive investment contracts are reported at fair value and fully benefit-responsive investment contracts are reported at contract value. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

As an insurance company, TIAA is required to maintain contingency reserves to ensure it will be able to fulfill its contractual obligations to policyholders. The crediting interest rate is supported by the investment performance of a large, diversified portfolio, is correlated with the highest quality debt security yields, and is adjusted for contract liquidity. The crediting rate is determined, in part, by the net investment earnings rate of TIAA's assets less a charge for administrative expenses and an amount set aside for contingency reserves. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3%. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

TIAA issues various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of TIAA Traditional Annuity accumulations, which could impact the value realized upon exiting the contract.

##### *Empower*

The Plan holds a fully benefit-responsive group annuity contract, Empower Investments Fixed Account - Series Class II, with Empower Annuity Insurance Company of America. The Empower Investments Fixed Account - Series Class II is a general account product of Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, and prevailing market conditions. The interest crediting rate is reset quarterly.

The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount which would be received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

##### *Empower (continued)*

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (v) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. The group annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 6 – Related Party Transactions and Party-in-Interest Transactions**

Plan investments are managed by the Custodians; as such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

#### **Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### **Note 8 – Tax Status**

The Plan operates under an adoption agreement in connection with a Volume Submitter 403(b) Plan sponsored by Alliance Benefit Group of Houston Inc. ("ABG"). The IRS has determined and informed ABG by letter dated March 31, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


