We have performed audits of the financial statements of ProEnergy Service 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE A - DESCRIPTION OF PLAN**

The following description of the ProEnergy Service 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering all employees of ProEnergy Services, LLC (the “Company” or “Plan Sponsor”) who have two months of service and who are not excluded employees as defined in the Plan. Upon attainment of eligibility, employees who are in Division 1 are automatically enrolled on the first day of the following month at an automatic deferral rate of 6% unless a contrary election is made. Variable Employees (Division 3) will not be subject to automatic enrollment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan covers all employees of the Plan Sponsor’s controlled group of employers and affiliated services group unless specifically excluded in the Plan.

***Contributions***

Participants may contribute a portion of eligible pre-tax annual compensation, subject to certain Internal Revenue Service (“IRS”) limitations, which were \$23,000 for 2024. Participants may also make Roth 401(k) deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan up to an annual maximum of \$7,500 for the Plan year ended 2024. Participants have the option to automatically escalate their contributions by 1% each year. Automatic escalation takes effect on the anniversary of the entry date, beginning with the second anniversary following the date deferrals were first withheld. Participants are also automatically enrolled in automatic escalation upon initial participation in the Plan until they elect out of the automatic escalation feature. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributions plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds and a fixed annuity as investment options for participants.

The Company provides for a discretionary match of 50% of the first 6% of eligible base compensation that a participant contributes to the Plan. From time-to-time, the Plan Sponsor may make discretionary nonelective contributions separately from the standard employer matching contributions. No discretionary nonelective contributions were made for the Plan year ended December 31, 2024.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings and is charged with plan losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### ***Vesting***

Participants are vested in their contributions, plus actual earnings thereon. A participant will vest in Company matching and non-elective contributions according to their earned years of service. To earn a year of service, a participant must be credited with at least 1,000 hours of service during a plan year in accordance with plan provisions. The vesting schedule for Company contributions is as follows:

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their total vested account balance. As of December 31, 2024 and 2023, participant loans have maturities through 2033. The notes are secured by the balance in the participant's account and bear interest at a rate between 4.25% and 9.50%, which is commensurate with 1% over the prime rate published in the *Wall Street Journal* on the first business day of the month the note is originated. Principal and interest are paid ratably through weekly payroll deductions and allocated to participant's accounts according to current allocation elections. A participant may hold no more than two outstanding notes at a given time. Loan repayment terms range from 12 to 60 months with the exception of loans taken for the purchase of a primary residence in which case the repayment terms may be extended up to 180 months.

#### ***Payment of Benefits***

Upon termination of service for reasons other than death, a participant with a balance of \$5,000 or greater that has not reached normal retirement age must provide consent to distribute their account. However, the participant may also postpone their distribution until normal retirement age is reached. Balances less than \$5,000 including rollovers will be distributed without participant consent. If the amount of the distribution is \$1,000 or greater, and no election is made to either roll over or receive a distribution, the distribution will be directly rolled over to an IRA. If a participant terminates employment upon reaching normal retirement age, the participant will receive a distribution without consent unless their balance is greater than \$5,000 in which case the distribution may be postponed in accordance with the Plan. If a participant dies, the value of his or her account will be used to provide a death benefit to his or her beneficiary. The Plan allows for lump sum distributions and installment distributions. Upon termination of service, a participant may receive a distribution of his/her vested balance. In-service withdrawals may be made under certain circumstances and in accordance with the Plan's provisions. Participants who have attained age 59½ and continue to work may elect early withdrawal.

#### ***Forfeited Accounts***

Non-vested forfeitures of terminated participants are used to reduce administrative expenses and employer nonelective and matching contributions, as allowed by the Plan document. During the Plan year ended December 31, 2024, forfeitures of \$334,328 were used to offset employer matching contributions. Forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023, were \$45,464 and \$168,362, respectively.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

In preparing financial statements in conformity with U.S. GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and changes in net assets during the reporting period. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Fully benefit-responsive contracts held in the Key Guaranteed Portfolio Fund (the "Fund") are reported at contract value in the statements of net assets available for benefits. The Fund is a general account product comprised of high-quality fixed income securities. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of changes in net assets available for benefits is presented on a contract basis (See Note E).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Loan origination fees associated with notes receivable from participants are charged directly to the participant's account and

are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to be a safe harbor plan, which would amend certain provisions relating to the employer contributions.

#### **NOTE C - INFORMATION CERTIFIED BY CUSTODIANS**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America ("Empower") and Empower Trust Company, LLC, the custodians of the Plan, have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of assets (held at end of year) as of December 31, 2024.

#### **NOTE D - FAIR VALUE MEASUREMENTS**

Financial assets and liabilities are measured using a framework that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at active market and adjusted quoted prices of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - KEY GUARANTEED PORTFOLIO FUND**

In 2004, the Plan entered into an investment of the Fund with Empower which is a general account product backed by the issuer and has no maturity date. Empower maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The entire general account assets of Empower back these guarantees. These assets are primarily investment grade quality, fixed income bonds. The Plan owns a promise from Empower to pay interest at crediting rates, which are announced in advance and guaranteed for a specified period of time, as outlined in the group annuity contract.

Because the Fund is benefit-responsive for participant-initiated transactions, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund. Contract value, as reported to the Plan by Empower, represents contributions, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for the credit risk of the credit issuer or otherwise.

The contract value of the Fund at December 31, 2024 and 2023 was \$2,607,845 and \$2,968,192, respectively. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The interest crediting rate may not be less than zero percent.

The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 is 1.41% and for 2023 is 1.23%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (i.e., divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include but are not limited to (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) failure to qualify or becomes disqualified under Internal Revenue Code Section 401(a), as amended, or (4) deposits received by Empower in the preceding twelve months is less than \$25,000.

The Key Guaranteed Portfolio Fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Empower. Empower is a Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also has notes receivable from participants. These transactions qualify as parties-in-interest to the Plan and are exempt from prohibited transactions rules.

**NOTE G - TAX STATUS**

The Plan has adopted a prototype plan which has obtained its latest opinion letter dated June 30, 2020 in which the IRS stated that the underlying prototype plan, as then designed, was in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the respective taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
