Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of the Lifetime Brands, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers employees of Lifetime Brands, Inc. (the Company) who, as defined in the Plan, have completed 90 days of service and are at least 21 years of age. Once eligibility criteria are met, an eligible employee is automatically enrolled in the Plan at 3% of compensation and the percentage increases on January 1 of each year by 1% up to 12%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The trustee of the Plan is Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal or Trustee).

Contributions

Participant contributions consist of 401(k) salary deferrals in any amount up to 100% of compensation, as defined by the Plan, providing that such contributions do not exceed the maximum allowable individual contribution limit established by the Internal Revenue Service (IRS) each year. Employees at least 50 years of age during the calendar year are allowed to make additional catch-up contributions under IRS limits. In no event may participant pretax and after-tax contributions exceed any statutory limitations.

Effective January 1, 2009, the Company suspended its matching contributions and has not reinstated the Company's matching contributions for the year ended December 31, 2024. Participants can also roll over accounts from qualified retirement plans and individual retirement accounts into the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Employee Investment Options

Participants direct the investment of their contributions into any of the Plan's available investment options. Participants may also elect to transfer all or a portion of the total investment fund balance allocated to their accounts from one fund to another.

Vesting

Participants are immediately vested in their contributions and rollover contributions. Vesting in the Company's matching portion of their accounts, and earnings thereon, is as follows:

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates on outstanding loan balances range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. There were no delinquent notes receivable from participants as of December 31, 2024.

1. Description of the Plan (continued)

Payment of Benefits

The value of a participant's account is payable to the participant upon termination of employment, retirement, or disability, or to the participant's beneficiary upon the death of the participant as a lump-sum distribution. Participants also have the option to request that their benefits remain in the Plan until further notice (up to age 70½). The Plan also allows payment for an early retirement upon attaining age 55 and six years of service.

Forfeitures

Forfeited non-vested accounts are applied to reduce expenses related to the administration of the Plan and then to reduce the Company's contributions, if any. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$35,005 and \$10,403, respectively.

Hardship Withdrawals

In cases of serious financial hardship, as defined by the Plan, participants may be eligible to receive an emergency withdrawal from a certain portion of their vested account balance.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements are prepared on the accrual method of accounting.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the accompanying financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Administrative expenses related to the Plan are paid by the Plan to the extent not offset by the use of forfeitures.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Principal, the trustee of the Plan.

4. Fair Value Measurements

ASC 820 provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2024.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Common collective trusts and separate account – Common collective trusts and separate account are valued using the NAV, which is determined daily, is published, and is the basis for current transactions with the fund's investment manager or issuer.

4. Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan has adopted a pre-approved basic savings plan sponsored by the Trustee. On June 30, 2020, the IRS stated in an opinion letter that the pre-approved basic savings plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC), and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

5. Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the participants' accounts will be distributed in accordance with the provisions of the Plan.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported on the accompanying statements of net assets available for benefits.

8. Party-In-Interest Transactions

Certain mutual funds and the common collective trust are managed by the Trustee. Therefore, transactions related to these investments qualify as party-in-interest transactions.
