Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Community Access Unlimited, Inc. Health and Welfare Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

1. Description of the Plan

The following description of Community Access Unlimited, Inc. Health and Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

General

The Plan provides health and death benefits covering substantially all active employees of Community Access Unlimited, Inc. (the Plan Sponsor or Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan.

Benefits

The Plan provides health benefits (hospital, surgical, major medical), dental benefits, prescription drugs, group life, and accidental death and dismemberment benefits to full-time employees of the Plan Sponsor (scheduled to work at least 30 hours per week and completed three months of service) and to their beneficiaries and covered dependents. The Plan also provides legal assistance and tuition reimbursement to eligible employees.

Current health and prescription claims of participants and their dependents and beneficiaries are provided under group insurance contracts with Aetna and Express Scripts. The Plan Sponsor assumes the risk for the first \$125,000 of claims per individual and Aetna charges a premium based on an annually determined calculation. The Plan Sponsor contracted with Granular Insurance Company to assume the risk for any claims exceeding \$125,000 per individual under a stop-loss policy. Life and accidental death and dismemberment benefits are covered by a group-term policy with Cigna.

Dental coverage is provided through a Preferred Provider Organization (PPO) contract with Aetna and provides benefits for a maximum of \$3,000 for each participant per year.

Contributions

The Plan Sponsor's policy is to contribute amounts to the Plan as needed to fund claims. Participants contribute to the Plan dependent upon Plan choice and type of dependent coverage selected.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities, and the benefit obligations at the date of the financial statements, and changes therein. Actual results may differ from those estimates.

Payment of Benefits

Premiums paid by either the Company or the VEBA trust (the Trust) are recorded as premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of benefit obligations and net assets available for benefits.

During the Plan years ended December 31, 2024 and 2023, the Plan Sponsor paid insurance premiums on behalf of the Plan to provide health insurance benefits to eligible employees. In accordance with the terms of the trust agreement, the Trust will reimburse the Plan Sponsor for the insurance premiums paid for eligible employees. As of December 31, 2024, \$600,655 has been overpaid by the Plan. As of December 31, 2023, \$3,170,349 was not reimbursed by the Plan.

Plan Benefit Obligations

Plan obligations at December 31, 2024 and 2023 for health claims incurred by active participants but not reported at that date are estimated by reviewing the historical claims experience and actual claims history subsequent to the Plan year-end.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events occurred that would require recognition or disclosure in the financial statements.

Deposits with Insurance Companies

The Plan maintains deposits with insurance companies in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification 965-310-50-1, *Deposits with Insurers*. The purpose of these deposits is to ensure the availability of funds to cover claims and other obligations related to the Plan. As of December 31, 2024 and 2023, the balance of deposits amounted to \$40,000.

Medicare Prescription Drug, Improvement, and Modernization Act of 2003

The Plan is a single-employer plan that provides prescription drug benefits to its eligible participants. The Plan is subject to the provisions of the Medicare Prescription Drug, Improvement, and Modernization Act of 2003.

Refunds and Rebates

Refunds and rebates due from the Plan's pharmacy benefit manager are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$627,672 have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024.

3. Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the trustee, and Plan Sponsor. The Plan is also charged a general and administrative charge by the Plan Sponsor for servicing the Plan. The Plan is charged a flat fee of 3% of insurance premiums. For the year ended December 31, 2024, the administrative fee amounted to \$219,242. These expenses are reported on the statement of changes in benefit obligations and net assets available for benefits. Certain administrative expenses are paid by the Plan Sponsor on behalf of the Plan.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America, N.A., the trustee of the Plan, a qualified institution.

5. Claims Incurred but Not Reported

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

As of the date of the financial statements, there are certain claims incurred but not yet reported to the Plan, and some of these may not be reported for an extended period of time. Claims of this nature cannot be determined on an individual basis, but the aggregate amount of such claims has been estimated on the basis of past experience and subsequent claims reported by the claims administrator. Total estimated claims incurred but not paid are \$1,661,997 and \$2,154,139 at December 31, 2024 and 2023, respectively.

6. Fair Value Measurements

The Plan accounts for fair value measurements in accordance with FASB guidance. The guidance provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Exchange-Traded Funds - Exchange-traded funds are valued at their quoted market prices, which represent the net asset value (NAV) per share of the fund.

Interest-Bearing Cash - Interest-bearing cash accounts represent cash and cash equivalents that are valued at their stated face value or carrying amount, which approximates fair value due to their short-term nature.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee or their subsidiaries and affiliates. As described in Note 3, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. Tax Status

The Trust established under the Plan to hold the Plan's net assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) as a tax-exempt organization. The Plan obtained its latest determination letter on August 18, 2000, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of benefit obligations and net assets available for benefits.

The benefit obligations are reported based on certain assumptions pertaining to estimated reports of claims incurred but not reported, and all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
