## **Note 1. Description of Plan**

The following description of the Hanley Wood, dba Zonda 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***General***

The Plan is a defined contribution plan covering certain employees of HW Management, Inc. (the Company). The Plan covers substantially all full-time employees of the Company, except collectively bargained employees and temporary and seasonal employees working less than 1,000 hours per year. Employees are eligible to make elective deferrals after completing three months of service. Employees are eligible to receive Company matching contributions after completion of one year of service. Empower Trust Company, LLC (Empower) & Empower Annuity Insurance Company (EAICA) serve as the custodian and recordkeeper of the Plan. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

On March 1, 2024, the Plan was amended to include a related employer, Builder Homesite, Inc., to participate in the plan. The Builder Homesite, Inc. employees were given the option to roll over their plan assets to the Plan. For the year ended December 31, 2024, \$72,194 of notes receivable participant loans were transferred into the Plan as a result of the amendment.

### ***Contributions***

Participants may contribute up to 50% of their pre-tax or post-tax annual compensation as defined in the Plan. Participants who have attained age of 50 before the end of the Plan year may elect to make catch-up contributions. Participants may also contribute amounts representing rollover contributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Each year, this amount will automatically increase by 1% up to a maximum of 10% of eligible compensation. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

The Company provides a discretionary matching contribution equal to 25% of the participants elective deferrals that do not exceed 6% of the participant's compensation.

### ***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds, variable annuities, common collective trusts and a guaranteed investment contract as investment options for participants.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, Employer's contribution, and allocation of Plan earnings. Accounts are charged with benefit payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions and rollover contributions, if any, plus actual earnings thereon. Vesting in the Company's matching contributions is based on years of continuous service. Participants vest ratably over four years of credited service. Participants are fully vested upon attainment of normal retirement age as defined by the Plan, death or permanent disability and Plan termination.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to an amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the balance in each participant's account. The loan interest rate is 1% above the prime rate, which is commensurate with local prevailing rates as determined by the plan administrator. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service, death, disability, retirement or separation, a participant or his or her designated beneficiary may elect to receive a lump sum amount equal to the full value of the participant's account balance or installment payments for a fixed period not to extend beyond the participant's life expectancy. Active participants may withdraw their employee and vested Company contributions under the hardship provisions as defined by the Plan. In-service distributions are also permitted for participants who become disabled or who have attained age 59½.

***Forfeitures***

Forfeitures are used to reduce employer contributions and plan expenses. On December 31, 2024 and 2023, forfeited nonvested accounts totaled \$60,187 and \$2,768, respectively. During 2024, forfeitures of \$55,515 were used to reduce employer contributions and \$8 were used to reduce plan expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivable is recorded when received. Other interest income is accrued. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan agreement.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses charged to participant accounts are included in administrative expenses.

***Subsequent Events***

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Variable Annuity Accounts**

The initial value is the closing price reported on the active market on which the underlying mutual funds are traded, which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting-driven unit value is determined in a manner similar to a mutual fund calculation: dividing the net assets by the number of units outstanding.

**Pooled Separate Accounts**

The Plan invested in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilized the Net Asset Value (NAV) per share, as determined by EAICA, as the estimated fair value. Because quoted prices in active markets for identical assets are not available, these prices were determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics.

**Common Collective Trust Funds**

These funds are valued at the NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12-months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **Note 4. Fully Benefit-Responsive Investment Contract**

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. Guaranteed investment contract was \$6,305,503 and \$7,083,314 as of December 31, 2024 and 2023, respectively. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

#### **Note 5. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower and EAICA, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

#### **Note 6. Related-Party and Party-In-Interest Transaction**

Certain Plan investments are managed by Empower and EAICA, the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$167,227 to EAICA and Empower for participant transaction services during 2024. These transactions qualify as party-in-interest transactions under ERISA.

#### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**Note 8. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the non-standardized pre-approved profit-sharing plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated September 16, 2023 that the non-standardized pre-approved profit-sharing plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amount reported in the statement of net assets available for benefits.

**Note 10. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer’s general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$9,727 were not remitted within the required time period for the year ended December 31, 2024.
