INDEPENDENT AUDITOR'S REPORT

To the Administrator and Board of Directors' of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of On Your Mark, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of On Your Mark, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of On Your Mark, Inc. 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note B to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note A - Description of Plan

On Your Mark, Inc. (the “Organization”) established the On Your Mark, Inc. 401(k) Retirement Plan (the “Plan”). The Plan was originally effective as of July 1, 1999 and was amended by the Organization as of July 1, 2020. The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Organization who have one year of entry service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

The Plan provides for employee elective salary deferral contributions under Section 401(k) of the Internal Revenue Code (“IRC”). Participants have the option of having up to 90 percent of their annual pre-tax compensation “deferred” and contributed to the plan instead of being received currently, subject to the maximum annual limitation prescribed by the internal revenue service. (\$23,000 and \$22,500 for calendar years 2024 and 2023, respectively). Additional “catch up” contributions up to \$7,500 for both calendar years 2024 and 2023, respectively can also be made by participants age 50 and older.

Employer Contributions

The Organization makes non-elective contributions to each eligible employee. The Organization’s contribution matches the employee contribution dollar-for-dollar, up to 3% of the employee’s compensation plus \$.50 for every dollar contributed between 3% - 5% of compensation. Organization contributions for the year ended December 31, 2024 were \$314,530. The Organization may make elective profit-sharing contributions to the Plan as decided on a year-by-year basis at the discretion of the Organization’s Board of Directors.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Organizations contribution, (b) Plan earnings, and (c) forfeitures of terminated participants’ non-vested accounts and charged within allocation of investment losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their elective salary deferral contributions, rollover contributions, and the Organization’s non-elective matching contribution, plus actual earnings

thereon. Vesting in the portion of their accounts attributable to the Organization's elective contributions is based on years of continuous service, with increments of 20% between the second and sixth years. A participant is 100% vested after six years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant with vested balances over \$5,000 may elect to receive benefits in one of the following forms: (a) a lump sum amount equal to the value of his or her account; (b) monthly installments over a certain period not extending beyond the life expectancy of the participant or the joint life expectancy of the participant and a designated individual; or (c) the purchase of an annuity. For vested balances of \$5,000 or less, the vested balance is permitted to be automatically paid in a single sum. Participants are then required to comply with Federal laws pertaining to individual retirement account rollovers.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) participant funds. Loan terms range from one to five years with longer terms available for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate, plus one percent. This rate will be fixed for the duration of the loan except as otherwise required by law. Principal and interest are paid ratably through payroll deductions.

Plan Amendments

Effective April 1, 2023 the plan was formerly amended to incorporate the provisions of the CARES Act and the Setting Every Community Up for Retirement Enhancement (SECURE Act), including removing the minimum hours of service requirement and various distribution related provisions.

Risks and Uncertainties

The Plan provides for various investments with any underlying combination of stock funds, bond funds, fixed income securities, mutual funds, and other investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, including systemic market disruptions, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis. Investment income and contributions are recognized when received, and disbursements are recognized when made. Additionally, securities investments are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the plan in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management and the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures. Actual results could differ from management's estimates and assumptions due to risks and uncertainties. The Plan has no contingent assets or liabilities for any periods presented in these financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. At December 31, 2024 and 2023 notes receivable from participants was \$236,306 and \$249,238, respectively.

Investment Valuation

Investments in registered investment companies are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in common collective trusts are valued at fair value using the fund's net asset value as a practical expedient. See Note D for discussion of fair value measurements. Investments in stable value funds are comprised of guaranteed investment contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value is the amount participants would receive if they were to initiate a transaction under the terms of the plan, see Note E. Participant loans are valued at cost which approximates fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

For the year ended December 31, 2024, forfeited nonvested accounts totaled \$203. This amount was recorded in the general account.

Note D – Fair Value

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- ◇ Quoted prices for similar assets or liabilities in active markets;
- ◇ Quoted prices for identical or similar assets or liabilities in inactive markets;
- ◇ Inputs other than quoted prices that are observable for the asset or liability;
- ◇ Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. Shares in registered investment companies are valued at the daily closing price as reported by the fund held by the Plan at year end. Mutual Funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish the daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E – Stable Value Funds

In 2019, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Lincoln Life & Annuity Company of New York, totaling \$1,138,194 and \$849,163 as of December 31, 2024 and 2023 respectively. Lincoln Life & Annuity Company of New York maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The credited rate is based on a formula established by the contract issuer. The interest rate at December 31, 2024, was 2.30%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln Life & Annuity Company of New York, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

Note F - Plan Termination

Although it has not expressed any intention to do so, the Organization has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balances.

Note G - Tax Status

The trust established under the plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes.

Effective July 1, 2019, the Plan, adopted a Volume Submitter Profit Sharing Plan, for which an advisory letter was issued on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable in form as to compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and legal counsel believes that the Plan is currently designed, and currently being operated, in compliance with applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by Federal or State taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note H – Administrative Expenses

For year ended December 31, 2024 record keeping fees and investment advisory fees of \$80,731 were paid by the Plan while all other trust, accounting and other fees were paid or are to be paid by the Plan sponsor.

Note I – Parties In Interest

Certain plan investments are shares of the Lincoln Stable Value Account, which is affiliated with Lincoln Financial Group Trust Company, Inc. Lincoln Financial Group Trust Company, Inc. is the Trustee and recordkeeper, as defined by the plan, and qualifies as a party in interest.

Note K – Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued. There were no events that required disclosure.
