NOTE A.--DESCRIPTION OF PLAN

The following description of the Natural Factors Nutritional Products, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) and profit sharing plan originally established by Natural Factors Nutritional (the Company) effective January 1, 2007. Natural Factors Nutritional adopted the Storehouse Multiple Employer Plan effective February of 2015. Effective October 15, 2019, Natural Factors Nutritional was removed from the Storehouse Multiple Employer Plan and began operating under the Natural Factors Nutritional Products, Inc. 401(k) Plan. The Plan was amended effective January 1, 2022 to allow loans specified for the purchase of principal residence to have a 10-year payback term. The Plan document was restated and amended effective May 1, 2022 for the Cycle 3 restatement requirement and to change the QACA safe harbor match. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by the Company excluding union employees, non-resident aliens, hourly paid employees of Alaska Omega Nutrition and independent contractors and as of April 15, 2021, part time, seasonal or temporary employees that are scheduled to work less than 1,000 hours. Employees are eligible for participation in the employee deferrals and safe harbor match after completing six months of service and the attainment of age 21. Employees are eligible for the discretionary profit sharing contribution after two years of service and the attainment of age 21. The entry date is the first day of completion of eligibility requirements.

Contributions: The Plan is funded by eligible participant elective deferrals which may be up to 100% of pre-tax annual compensation, safe-harbor matching contributions and discretionary profit-sharing contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Also, all participants who are eligible to make elective deferral contributions may designate all or any portion of their deferrals as Roth elective deferral contributions. Contributions are subject to certain limitations set by law.

The Plan provides for automatic enrollment of all employees who do not make an affirmative election out of participation. Newly eligible employees are enrolled in the Plan at a salary reduction rate of 3% of eligible compensation. Each year thereafter, there is an automatic step-up in rate of 1% each subsequent January up to a maximum of 6% for all participants. Participants may elect to change or stop their payroll deduction at any time.

Contributions (Continued): The Company provides safe-harbor matching contributions on an annual basis of 100% for the first 3% of compensation, plus 50% of the employee's deferrals between 3% and 5% of compensation. The Company may make an annual discretionary profit sharing contribution and participants must be employed on the last day of the Plan year to be eligible. There was no discretionary profit sharing contribution for 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution, allocation of the Company's contributions, an allocation of plan earnings (losses), and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting: Participants are immediately vested in their accounts, including all employer contributions and actual earnings thereon.

Retirement: The normal retirement date is the first day of the month on or after the date the participant turns 65. Early retirement is not permitted.

Payment of Benefits: On termination of service including due to death, disability, or retirement, a participant may elect to receive a lump-sum. For terminated participants, if the balance of the vested accounts is \$1,000 or less, payment may be made in a lump-sum without the participant's consent. For terminated participants, if such balance is less than \$5,000 but greater than \$1,000, it will automatically be transferred to an IRA without other election. Hardship distributions are allowed in accordance with the provisions of the Plan. In-Service distributions are allowed at age 59½.

Notes Receivable from Participants: Participants may borrow from their accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. A participant may have one loan outstanding at a time. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within ten years. Under the terms of the Plan agreement, plan loans will bear a reasonable rate of interest. Principal and interest are paid through payroll deductions.

Investment Options: Participants direct their contributions and account balances in a variety of investment options among the investments offered under the Plan. The Plan sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

Forfeited Accounts: Forfeitures are the non-vested portion of a participant's account that are lost upon termination. At both December 31, 2024, and 2023, forfeited non-vested accounts totaled \$0. Typically, there are not forfeitures as participants are immediately 100% vested in all contributions.

Plan Expenses: Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid for directly by the Company and are excluded from these financial statements. Fees relating to administration of notes receivable from participants and for certain withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses including 12b-1 fees and revenue sharing fees, as applicable, are deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by investment advisors and custodian. See Note D for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued): Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when incurred. Delinquent notes receivable from participants are reclassified as benefit payments based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividend and interest income, interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (the trustee and custodian of the Plan).

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E.--FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan invests in the Principal Fixed Income Guaranteed Option ("PFIGO"), which is a fully benefit responsive investment offered under the Plan's group annuity contract ("GAC") issued by Principal Life Insurance Company ("PLIC" or the "Issuer"). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value of the Plan's investment in the Principal Fixed Income Guaranteed Option was \$1,989,483 and \$1,882,364 at December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan that is declared quarterly. The crediting rate is established by the contract issuer and may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract permits the insurance company to terminate the agreement with 30 days advance written notice prior to the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Under the Principal contract, in the event of an employer initiated liquidation or transfer, this contract will be subject to either a 12 month advance notice or a 5% surrender charge at the option of the employer. The participant's accounts will not be affected by any such charges.

NOTE F.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by the trustee and custodian, Principal Trust Company; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE G.--TAX STATUS

Effective May 1, 2022, the Plan adopted a non-standardized pre-approved profit sharing plan with cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan shall become fully vested and non-forfeitable.

NOTE I.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE J.--OPERATIONAL ERRORS

During the year ended December 31, 2023, it was discovered that certain employee deferrals were deducted but were not remitted to the Plan for one payroll. The error was discovered in 2024 and Plan management deposited the missed employee and employer contributions to the affected participants on August 15, 2024, and calculations were performed for lost earnings.

During the year ended December 31, 2024, it was discovered that one employee was not receiving employer matching contributions despite being eligible and contributing to the Plan. This error was discovered in 2025 by Plan management and a matching contribution of \$2,301 was made during 2025, which is included as a receivable on the statement of net assets available as of December 31, 2024.

NOTE K.--NON-EXEMPT TRANSACTIONS

Late Remittances

As reported on the supplemental Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain Plan contributions of \$109,617 for the year ended December 31, 2021, \$167,121 for the year ended December 31, 2022, and \$82,756 for the year ended December 31, 2023 were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company. During the year ended December 31, 2024, the Company made contributions to the affected participants' accounts to compensate for potential lost earnings resulting from the delays in the contributions for the nonexempt transactions that occurred during the year ended December 31, 2023, and will make contributions to the remaining affected participants' accounts during the year ended December 31, 2025.
