Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 – DESCRIPTION OF PLAN

The following description of Alleima USA LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: Effective July 1, 2021, related to Sandvik Inc.’s divestiture of the Sandvik Materials Technology division into a standalone company, the Sandvik Materials Technology 401(k) Plan was created. Effective August 31, 2022, the Plan Sponsor’s name was changed to Alleima US LLC, and the Plan name was changed to Alleima USA LLC 401(k) Plan, accordingly.

The Plan is a defined contribution retirement plan covering employees of Alleima USA LLC and its participating subsidiaries, affiliates and locations (collectively, the “Company” or the “Employer”). The Company is the sponsor of the Plan. Each employee covered under the Plan is eligible upon completion of 90 days of service and will be automatically enrolled in the Plan at 6%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. T. Rowe Price Trust Company (the “Trustee”) is the trustee of the Plan.

Contributions: Each year, participants may contribute from 2% to 75% of their annual compensation to the Plan on a pre-tax or Roth basis and 2% to 6% on an after-tax basis. Total participant contributions cannot exceed 75% of compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company contributes a matching contribution equal to 50% of the first 6% of a participant’s compensation.

For employees covered under the Collective Bargaining agreement between the Employer and Local 130, the Company also made an automatic contribution of 2% of eligible compensation to each eligible employee in the Plan. For all other employees, the Company also made an automatic contribution of 5% of eligible compensation to each eligible employee in the Plan. Additionally, employees who were accruing benefits in the Sandvik Pension Plan immediately prior to the freeze of that plan effective June 30, 2021 will receive an automatic contribution from the Company of 7% of eligible compensation from July 1, 2021 through June 30, 2026. Contributions are also subject to certain limitations imposed by the Internal Revenue Code. Catch-up contributions of \$7,500 are permitted for participants greater than 50 years old.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contributions and (b) Plan earnings / (losses), and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in all contributions plus earnings thereon.

Notes Receivable from Participants: Participants may borrow from their account in the Plan. A participant can borrow a minimum of \$1,000 or a maximum of \$50,000 or 50% of his or her vested account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest from 4.25% to 9.50% as of December 31, 2024 and 2023, which is commensurate with local prevailing rates as determined by the Plan administrator. All loans are amortized over no more than five years, except those loans used to purchase a primary residence.

Payment of Benefits: Upon separation from service with the Company due to death, disability, retirement or termination, Plan payments are made as soon as practical following a request from the participant or their beneficiary. A participant will receive a single lump-sum payment, unless the participant elects to receive installment payments. On termination of service due to death, disability, retirement, or separation from service, the normal form of benefit is a lump-sum payment equal to the value of the participant's account. Participants are also allowed to make withdrawals of their rollover contributions at any time. For participants who have attained the age of 59½, all or a portion of the participants' accounts are available for withdrawal at any time. In the event of financial hardship, as defined, a participant may have available for withdrawal all employee-directed pre-tax contributions. The minimum hardship withdrawal amount is \$500, and the number of hardships a participant may receive during the calendar year is two.

Forfeitures: Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Fees: Net investment returns reflect certain fees paid by the funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense on the statement of changes in net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (the trustee of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair values of the interest in the collective trust are based upon the net asset values of such funds, as reported by the trustee, which are used as a practical expedient to estimate fair value. The collective trust provides for daily participant-level transactions at contract value; however, plan-level redemptions from the fund are subject to advance written notice of up to 12 to 30 months, which may be shortened or waived at the trustee’s discretion. These redemption restrictions are standard provisions designed to protect remaining investors in the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain investments held by the Plan as of December 31, 2024 and 2023 are shares of mutual funds issued by an affiliate of the Trustee and a collective trust fund issued by the Trustee. Accordingly, these investments qualify as party-in-interest investments. Notes receivable from participants and the payment of investment management fees also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated August 19, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is designed and is being operated in accordance with the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. All years are open to tax examination.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025 which is the date the financial statements were available to be issued.

Effective October 1, 2024, the Plan was amended to qualify as a replacement plan under Section 4980(d) of the Internal Revenue Code Pursuant to this amendment, excess assets from the terminated Alleima Special Metals LLC Retirement Plan, totaling \$1,558,942 (unaudited), were designated for transfer to the Plan. These assets were deposited into a replacement suspense account in January 2025.
