INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor
The Tranzonic Companies Retirement Savings Plan
(formerly The Tranzonic Companies Salary Savings and Profit Sharing Plan)

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of The Tranzonic Companies Retirement Savings Plan (the "Plan") (formerly The Tranzonic Companies Salary Savings and Profit Sharing Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of The Tranzonic Companies Retirement Savings Plan (the “Plan”) (formerly The Tranzonic Companies Salary Savings and Profit Sharing Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Plan Name Change

Effective April 1, 2024, the plan name was changed from *The Tranzonic Companies Salary Savings and Profit Sharing Plan* to *The Tranzonic Companies Retirement Savings Plan*. A consolidation of EINs occurred reducing the number of participating employers to three. The Plan was amended periodically to comply with all applicable, recently adopted laws and regulations.

General

The Plan, which was established on October 1, 1984, is a defined contribution plan open to substantially all full-time employees of The Tranzonic Companies (the “Company”), excluding those covered by a collective bargaining agreement, leased employees, and non-resident alien employees, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors the investment performance.

During 2024, the Company acquired Bullen Midwest, Inc. d/b/a Nuance Solutions. Effective in 2024, the employees of the acquisition are able to participate in the Plan.

During 2024, the Company acquired all or substantially all of the assets of a) Supply Source Enterprises, Inc., b) Impact Products LLC and c) The Safety Zone, LLC and either the Company or a direct or indirect wholly owned subsidiary of the Company will hire certain employees of the acquired entities. The employees hired through the acquisition are able to participate in the Plan.

Eligibility

All employees of the Company, and participating employers, are eligible to participate in the Plan after completing on the first day of the month following the hire date. This includes pre-tax and after-tax (“Roth”) contributions, and employer matching contributions. Any employee who is covered by a collective bargaining agreement, is a leased employee, or is a non-resident aliens are not eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the plan document, subject to Internal Revenue Services (“IRS”) limitations for the Plan year. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. On April 1, 2024, the Plan was amended to include auto-enrollment provisions whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

The Company contributes a discretionary match of 40 percent of the first 8 percent of base compensation that a participant contributes to the Plan. Additional discretionary amounts may be contributed by the Company at the option of the Company. For the year ended December 31, 2024, there were no discretionary contributions to the Plan. Contributions are subject to certain IRS limitations.

Employees of one of the participating employers acquired in 2023 received a profit-sharing contribution equal to 3% of compensation which was vested at 100%. These employees were not eligible for the discretionary match during the 2024 plan year. Effective January 1, 2025, all employees from this participating employer will stop receiving the profit-sharing contribution and will be eligible for the discretionary match. Effective March 1, 2024, any new hires of the participating employer will be receiving the discretionary match instead of the profit-sharing contribution.

Participant Accounts

Each participant’s account is credited with the participant’s elective deferrals, rollover contributions, Company matching contributions, an allocation of the Company’s discretionary contributions, and an allocation of the Plan’s earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions to the Plan, plus any affiliated earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Prior to attaining two years of service, participants are not vested in the Company’s matching contributions and non-elective contributions. Participants are 20% vested in the Company’s matching contributions after two years of service. Vesting continues in increments of 20% until 100% vested after six years of credited service. Different vesting may apply under certain circumstances as defined in the Plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at the time of issuance, is set at the prevailing interest rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of a lump-sum distribution regardless of whether the participant elects to receive it, and if the vested account balance is greater than \$1,000, but less than \$5,000, a direct rollover distribution will be made to an individual retirement plan. In addition, the Plan allows for hardship distributions of at least \$500, up to the participant's vested account balance, if certain criteria are met.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce administrative expenses or to reduce future employer contributions. Forfeitures should be used no later than the end of the Plan year following the Plan year which the forfeiture occurred. During 2024, employer contributions and administrative expenses were reduced by \$136,028 and \$8,575, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$35,848 and \$42,256, respectively, and may be used to reduce future administrative expenses or future employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Benefit Payments

Benefit payments to participants are recorded when paid.

Plan Expenses

Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Income Taxes

In accordance with GAAP, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, the Plan did not have a liability for unrecognized tax benefits. The Plan is subject to routine audits by tax authorities; however, there are currently no ongoing audits for any tax periods.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Registered Investment Companies: Stated at their fund’s daily net asset value (“NAV”) which is the quoted price in an active market.

Common/Collective Trusts: Valued at the NAV of units held by the Plan at year-end, as determined by the issuer of the trust. The NAV is based on the fair value of the underlying assets in the trust less its liabilities and is used as a practical expedient to estimate fair value. The NAV is not publicly quoted on an exchange but is derived from observable inputs supporting the valuation of the underlying investments.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024, and 2023.

NOTE 4 – INFORMATION CERTIFIED BY TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participant’s account balances. These transactions qualify as party-in-interest transactions as well. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 6 – INCOME TAXES

The Plan adopted a pre-approved plan offered by Fidelity Management & Research Company, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

NOTE 9 – DELINQUENT PARTICIPANT CONTRIBUTIONS

For the year ended December 31, 2023, the Company did not remit certain participant contributions and loan repayments to the Plan on a timely basis, as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The amount of delinquent contributions previously reported for 2023 has been revised from \$351,897 to \$384,739. The adjustment reflects the actual amount of participant contributions and loan repayments that were not remitted timely during 2023. The revision does not affect the 2024 contributions or compliance with plan provisions.

Untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$384,739 and \$239,921 in 2023 and 2024, respectively. As of December 31, 2024, all participant contributions and loan repayments have been remitted to the Plan; however, lost earnings related to participant contributions and loan repayments totaling \$449,425 were not calculated and remitted. The Company will be compensating these participants for lost earnings by December 31, 2025.
