#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of N.S. International, LTD. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). 

### 1. DESCRIPTION OF PLAN

The following description of the N.S. International, Ltd. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### GENERAL

The Plan is a defined contribution plan covering all full-time employees of the Company who have completed a month of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan fiduciaries oversee the governance of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

#### CHANGE OF TRUSTEE

Effective July 1, 2024, Principal Life Insurance Company was replaced by ADP Retirement Trust, LLC as the Plan’s Directed Trustee.

#### CONTRIBUTIONS

Each year, participants may elect to contribute a portion of their pre-tax annual or after-tax (Roth) annual compensation, not to exceed limits established by the Internal Revenue Code, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common/collective trusts, and self-directed brokerage accounts as investment options for participants.

Each year, the Company may elect to make employer matching contributions for eligible participants with a month of service. When elected, employer matching contributions are made in an amount equal to a uniform percentage of each tier of a participant’s salary deferral. In 2024 and 2023, the Company contributed 75% of the first 5% of base compensation, 50% of the second 5% of compensation, and 25% of the third 5% of compensation, that a participant contributed to the Plan. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors to eligible participants who are age 21 or older, have completed a year of service, and are employed on the last day of the Plan year, as defined in the Plan. In 2024 and 2023, the Company did not make any profit sharing contributions to the Plan. Contributions are subject to certain statutory limitations.

##### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of the Company's matching contributions and profit sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service for matching contributions and is 100% vested after six years of credited service for profit sharing contributions.

##### NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan Administrator. No more than two loans may be outstanding at any time for any participant. Interest rates ranged from 5.25% to 10.50% per annum. Principal and interest are paid ratably through payroll deductions.

##### PAYMENT OF BENEFITS

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant who terminates with a balance under \$5,000 will receive an involuntary cash-out distribution. The Plan also permits withdrawals of active participants' elective contributions only in the amounts necessary to satisfy financial hardship as defined by the Plan agreement.

#### FORFEITED ACCOUNTS

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$38,022 and \$10,811, respectively. Forfeited accounts were used to reduce plan expenses, remaining forfeitures were used to reduce employer contributions. During 2024 and 2023, expenses were reduced by \$20,021 and \$31,140, respectively. During 2024 and 2023, employer contributions were reduced by \$1,242 and \$62,419, respectively.

#### RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### BASIS OF ACCOUNTING

The financial statements are presented on the accrual basis of accounting.

#### USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

INVESTMENT VALUATION AND INCOME RECOGNITION - continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024. There were no excess contributions for the year ended December 31, 2024.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Some administration fees of the Plan are paid from plan assets and allocated to participants. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

DATE OF MANAGEMENT'S REVIEW

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

MUTUAL FUNDS

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

COMMON/COLLECTIVE TRUST

Valued at the NAV of the units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

SELF-DIRECTED BROKERAGE ACCOUNTS

Valued at the daily closing price of the securities held in the account. Self-directed brokerage held by the Plan contain securities that are registered with the Securities and Exchange Commission. These securities are required to publish their daily NAV and to transact at that price. The securities held in self-directed brokerage accounts held by the Plan are deemed to be actively traded.

POOLED SEPARATE ACCOUNTS

Valued at the NAV of the units of the pooled separate accounts. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

#### 4. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by ADP Retirement Trust Services (ADP) and Principal Life Insurance Company (Principal).

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by ADP from July 1, 2024 to December 31, 2024 and Principal from January 1, 2023 to June 30, 2024. Both ADP and Principal are the investment custodians/directed trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Direct fees paid by the plan for the investment management services amounted to \$36,687 and \$47,799 for the years ended 2024 and 2023, respectively.

Certain Plan investments are managed by Integrated Investment Consultants from July 1, 2024 to December 31, 2024. Integrated Investment Consultants is the investment advisor as defined by the Plan and, therefore, the transactions qualify as party-in-interest. Direct fees paid by the plan for the investment advisory services amounted to \$8,898 and \$0 for the years ended 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in employer contributions.

#### 7. TAX STATUS

The Company has adopted a prototype plan that relies on the opinion letter of the prototype document. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.



