Opinion

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

The following description of the Stewart Employee Benefit Trust Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined benefit health and welfare plan that provides health benefits covering all eligible employees as well as former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions of The Stewart Companies (the Company), as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Company periodically deposits into the Plan such amounts necessary for timely payment of all claims and reasonable administrative expenses of the Plan. The Plan provides for stop loss reinsurance over a specified amount as per agreement with the reinsurance carrier. Premiums for stop loss reinsurance are paid by funds deposited in the Plan.

The Plan is contributory. Employees pay a flat rate for coverage for themselves and that of their dependents.

Benefits

The Plan provides health benefits (medical, dental, vision, and prescription drugs), life insurance, short- and long-term disability benefits, and accidental death and dismemberment. Benefits are provided to full-time employees and their dependents, upon completion of 90 days of active service with the Company. The Plan also provides continuation of certain benefits upon termination of employment through COBRA.

All medical and prescription drug benefits are self-insured. All other plan benefits are fully insured.

The Company provides health insurance benefits and pays the administrative fees incurred. The Company also provides life and accidental death and dismemberment insurance and short- and long-term disability insurance depending on the entity in which the employees are employed. The employees pay a portion of their medical and prescription drug coverage and all of their dental and vision coverage. Employees may also pay for buy-up short-term disability insurance and long-term disability insurance on a voluntary basis depending on the entity in which the employees are employed. All premiums are paid through payroll deductions.

Health claims are processed through the Highmark Blue Shield network.

The Plan utilizes a pharmacy benefit manager, which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred, but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by the Plan or the Company are recorded as insurance premiums and fees in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor.

Stop Loss Insurance

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The Company's stop loss year runs from October 1 to September 30. The self-insured retention for the Company was \$325,000 per covered person for the years ended December 31, 2024 and 2023. Premiums for stop loss insurance are included in insurance premiums and fees in the accompanying statement of changes in net assets available for benefits. There were stop loss refunds of \$211,021 and \$1,762,777 for the years ended December 31, 2024 and 2023, respectively.

Plan Benefit Obligations

Plan benefit obligations at December 31, 2024 and 2023 for health claims incurred by active participants, but not reported at that date, are estimated by the Plan's claims processing administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. Such estimated amounts are reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments.

Administrative Fees

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators and for other professional fees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

Note 2 - Summary of Significant Accounting Policies (continued)

Concentration of Credit Risk

The Plan maintains its deposits in one financial institution located in Pennsylvania. These deposits were insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 as of December 31, 2024 and 2023. At times, the Plan's cash account has exceeded the FDIC insurance limit.

Note 3 - Tax Status

The trust established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the IRS, and the plan sponsor believes the Plan, as amended, continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, active employees, discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for, or on account of, the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 5 - Risks and Uncertainties

The Plan's estimate of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 6 - Related Party Transactions and Party-In-Interest Transactions

The Plan pays an administrative support charge to the Company for providing certain accounting and administrative services. These transactions qualify as exempt party-in-interest transactions. Total fees incurred amounted to \$152,408 and \$105,180 for the plan years ended December 31, 2024 and 2023, respectively.

No other material events subsequent to December 31, 2024 were noted.


