### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Instituto Comercial de Puerto Rico, Inc. DBA ICPR Junior College Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Instituto Comercial de Puerto Rico, Inc. DBA ICPR Junior College Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS YEARS ENDED DECEMBER 31, 2024 AND 2023

---

### 1. GENERAL

Instituto Comercial de Puerto Rico, Inc. DBA ICPR Junior College Retirement Plan (the “Plan”) was adopted by Instituto Comercial de Puerto Rico, Inc. for the benefit of eligible employees. The Plan commenced on January 1, 1989 and the eligible employees were allowed to enroll beginning on the same date.

The Plan is a defined contribution plan which provides eligible employees, upon completion of one (1) year of service or for those that has never met the eligibility requirement, eligibility will be automatically after nine (9) years of service, the opportunity to make pretax contributions, in specific percentages, within guidelines established by the Instituto Comercial de Puerto Rico, Inc. Employee Benefits Committee. Participant contributions are immediately fully vested and may be divided at the participant’s discretion among the various investment options from 1% to 100%, with no limit on the number of options selected. The following investment options are available to Plan participants:

The investment options provide for a wide range of investment opportunities with varying degrees of risk.

Each year, participants may contribute an amount based on a percentage of their compensation from the amount reportable on the Employee’s Annual Withholding Statement, with certain exceptions as indicated by the Plan, not to exceed the maximum allowed for deferral by the Puerto Rico Treasury Department.

Employer contribution will be determined on an annual basis as determined by the Instituto Comercial de Puerto Rico, Inc. Employee Benefits Committee. Employer matching contribution has been determined to be a 50% of the employee deferral up to a maximum of 4% of the employee deferral.

The Plan also provides for a Profit Sharing Distribution to be determined on an annual basis by the Board of Directors or other governing authority of the Plan Sponsor. However, if no resolve is made, the amount should be determined to be the lesser of the 4% of each participant’s eligible plan compensation for such year, or 15% of the Plan Sponsor net earnings before taxes, whichever is less.

1. **GENERAL (Continued)**

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures are allocated as if they were Plan Sponsor contributions and are used to reduce such contribution, to reduce plan cost and expenses or to be allocated to participants' accounts. Vesting in the Plans Sponsor's matching portion of their account plus actual earnings thereon is based on the years of service as described below:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of Plan termination, participants will become 100 percent vested in their accounts.

The above information is intended as a general description of the Plan's operating guidelines. Reference should be made to the Plan document for more specific provisions.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Investment Valuation and Income Recognition

Investment are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments held during the year.

Income Tax Status

The Plan constitutes a qualified plan, exempted from income tax under the provisions of Section 1081.01 of the Puerto Rico Internal Revenue Code. The Plan is not a qualified plan under the Internal Revenue Code of the United States. In April 2015, the Plan received acknowledgment from the Puerto Rico Treasury Department regarding the notification of a Plan's amendment, effective January 1, 2011, and assertions as to lack of objection to the amendment and the understanding that the amendment will not affect the ruling issued on behalf of the Plan in October 5, 2004.

The Plan administrator and the Plan's counsel believe that the Plan is currently designed and being operating in compliance with the applicable requirements, therefore, they believe that the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2020.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Basis of presentation

The Plan's policy is to prepare its financial statements using the accrual basis of accounting.

### Plan Expenses

The Plan routinely incurs in expenses for the services of lawyers, actuaries, accountants, third party administrators, and other advisors. Some of these expenses may be paid directly by the Plan Sponsor while other expenses may be paid from the assets of the Plan. The expenses that are paid from Plan assets will be shared by all participants either on a pro-rata basis or an equal dollar basis. If the expense is paid on a pro-rata basis, an amount will be deducted from the participants account based on its value as compared to the total value of all participants' accounts.

### Payment of benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either by a lump-sum amount equal to the participant's vested interest in his or her account; or over an annuity over a specified period of time. Benefits are recorded when paid.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$28,513 and \$5,742, respectively. These accounts may be used to reduce future employer contributions, to reduce related plan cost and expenses or to be allocated to participant's accounts on an annual basis. During the year ended December 31, 2023, the Plan used \$7,236 from forfeitures to pay plan costs and expenses. No forfeitures were used during the year ended December 31, 2024.

### Benefits Payable

The Plan accounts for benefits payable in accordance with Accounting Standard Codification (ASC) 962-205-50-1. ASC 962-205-50-1 requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. At December 31, 2024 and 2023 there were approximately \$178,445 and \$125,585, respectively of net assets available for benefits due to participants who withdrew from participation in the plan.

### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and the reported amounts of certain additions and deductions during the reporting period. Actual results could differ from those estimates and assumptions.

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

### Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

### 3. INFORMATION CERTIFIED BY CUSTODIAN OF THE PLAN ASSETS (UNAUDITED)

### 4. FAIR VALUE OF ASSETS AND LIABILITIES

FASB ASC 820-10 "Fair Value Measurements" establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Basis of Fair Value Measurement:

- Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3 - Prices or valuations that required inputs that are both significant to the fair value measurement and unobservable.

#### 4. FAIR VALUE OF ASSETS AND LIABILITIES (Continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Cash and equivalents* - Valued at amortized cost, which approximates fair value.

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. RELATED PARTY TRANSACTIONS

Plan investments include shares of funds managed by Banco Popular de Puerto Rico. Banco Popular de Puerto Rico is the custodian and record keeper; therefore, these transactions qualify as party-in-interest transactions. The Administrative Committee, as Trustee, is considered a party-in-interest to the Plan. During the year ended December 31, 2023, the Plan paid Banco Popular de Puerto Rico \$7,494 in direct compensation fees \$6,640 in indirect compensation fees. During the year ended December 31, 2024, all administrative fees charged by Banco Popular de Puerto Rico were paid by the Plan Sponsor.

The Plan invest in various investment securities. Investment securities are exposed to various risk an interest rate, market, and credit risk. Due to the level associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
