Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the TESSCO Technologies Incorporated 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the TESSCO Technologies Incorporated 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the TESSCO Technologies Incorporated 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution and profit-sharing plan with a salary deferral arrangement, established May 1, 1991, for all employees of TESSCO Technologies Incorporated (the Company) except for nonresident aliens, independent contractors, leased employees, interns, temporary employees and employees covered under a collective bargaining agreement which provides retirement benefits. Eligible employees may enter the Plan on the first day of employment following the attainment of age 21. The Plan is subject to the provisions of ERISA and was most recently amended and restated effective January 1, 2022 to reflect statutory and regulatory changes as permitted by the Internal Revenue Service (IRS).

On April 11, 2023, the Company entered into a definitive merger agreement with another entity. On July 17, 2023, the transaction was finalized. The Plan is operating in accordance with Plan provisions set forth before the definitive merger agreement.

In September 2024, the Company notified its recordkeeper that the Plan would be merging into the (k)larity Plan, a pooled employer plan, effective January 1, 2025. Upon merger, all participants balances were to be moved from Charles Schwab Bank to Transamerica Retirement Solutions, LLC as part of the (k)larity Plan. The (k)larity Plan is a newly established pooled employer plan with an initial effective date of January 1, 2025. Funds were directed to be liquidated as of the liquidation date of December 31, 2024 and transferred to TransAmerica Retirement Solutions, LLC starting January 2, 2025 through the blackout period date of February 7, 2025. All funds including notes receivable from participants and contributions receivable as of December 31, 2024 were transferred to the new plan's custodian and recordkeeper in early January 2025, however, became assets of the Plan effective January 1, 2025.

Participant Contributions

Participants may contribute up to 90% of their annual compensation, as defined by the Plan agreement. Participant contributions are subject to Internal Revenue Code (Code) limits, which totaled \$23,000 for the year ended December 31, 2024. Participants may also contribute Roth elective contributions. Contributions may be further limited at the Plan's discretion for the Plan to comply with nondiscrimination limitations imposed by the Code. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Participants are permitted to make rollover contributions to the Plan.

Participant Contributions – cont'd.

Effective January 1, 2007 and prior to January 1, 2018, the Plan had an automatic enrollment provision whereby an eligible employee who did not elect to contribute a specific percentage of their compensation would be automatically enrolled to contribute 3% of their current compensation to the Plan. Each employee had the right to elect not to contribute to the Plan.

Effective January 1, 2018, if a participant meets the eligibility requirements on or after January 1st, an eligible employee will be automatically enrolled to contribute 5% unless the participant elects not to contribute or elected to contribute another deferral rate.

Effective April 1, 2013 and prior to January 1, 2016, if a participant's deferral rate was not at least 6% (pre-tax and Roth combined) and the participant was hired prior to October 1st of the preceding year, the participant's deferral election would be automatically increased as of each April 1st by 1% of compensation per year up to a maximum of 6%, unless the participant had elected not to contribute to the Plan, elected to contribute another deferral rate, or opted out of automatic increase.

Effective January 1, 2016, a participant's deferral elections (pre-tax and Roth combined) are to be automatically increased as of each April 1st by 1% of compensation per year up to a maximum of 10%, if the participant was hired prior to October 1st of the preceding year, unless the participant elected not to contribute to the Plan, elected to contribute another deferral rate or opted out of automatic increase.

Company Contributions

The Plan agreement provides for Company contributions equal to a discretionary percentage of participant contributions, not to exceed 6% of annual compensation. Company contributions, if any, are submitted quarterly for all eligible participants.

Participants are eligible to receive quarterly Company contributions if they are contributing to the Plan and are employed on the last day of the calendar quarter. During the year ended December 31, 2024, the Company made contributions equal to 50% of participants' contributions, not to exceed 2.5% of participant compensation. Matching contributions are calculated on a quarterly basis. Prior to July 17, 2023, matching contributions were made one-half in shares of Company common stock using the quoted market value of the shares at each contribution date and one-half in participant directed investment. Effective July 20, 2023, matching contributions are made in all participant directed contributions upon the corporate transaction and removal of Company stock from the Plan.

Company Contributions – cont'd.

In addition, the Plan agreement allows an additional discretionary Company contribution in the form of a profit-sharing contribution. Participants are eligible to receive profit sharing contributions if they are participating in the Plan, are 21 years of age, have obtained one year of service, and are employed on the last day of the Plan year. No profit-sharing contributions were made to the Plan for the year ended December 31, 2024.

Participant Accounts

Participant contributions, withdrawals, and non-stock Company contributions are participant-directed and are credited according to the available investment options selected by each participant. Prior to July 17, 2023, the non-participant directed Company contributions were made in shares of Company common stock. Participants had the option to reallocate the non-participant directed portion of their account at any time to any of the other investment options. Upon the corporate transaction, all Company stock was sold and reallocated based on participants future investment allocations or the qualified default investment alternative (QDIA). Any earnings, losses, and administrative expenses are allocated to participant accounts based on the proportion of each participant's account balance to the total of all account balances within the respective fund. The benefit to which the participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000. Notes must not be made available to highly compensated employees in an amount greater than the amount made available to other employees. Only one note can be outstanding at any given time. Notes are secured by the vested balance in the participant's account and bear interest at rates commensurate with commercial rates in the local lending area for similar type notes at the time of loan origination (prime rate plus 1%). Principal and interest are paid ratably through payroll deductions. Notes, except those used for the purchase of a primary residence, must be paid back within five years. Notes used for the purchase of a primary residence must be repaid over a period not to exceed fifteen years.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or attainment of age 59 ½, a participant or beneficiary, in the case of death, is entitled to a distribution of their vested account balance. Prior to retirement, distributions may be made either in a lump sum or direct rollover equal to the value of the participant's vested interest in his or her account. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Upon termination of service, participants with vested account balances of less than \$5,000 will be distributed without participant consent in accordance with the Plan agreement.

In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. Distributions are subject to the applicable provisions of the Plan agreement. As of December 31, 2024 and 2023, there are no assets of the Plan allocated to participants who had elected to withdraw from the Plan and have not received such amounts prior to year-end.

Vesting

Participants are immediately vested in their contributions plus earnings and losses thereon. Participants vest in Company contributions plus earnings and losses thereon, based on years of service, as defined by the Plan agreement, according to the following schedule:

Participants become fully vested in their accounts upon reaching age 65, death or permanent disability.

Forfeitures

Forfeitures of Company contributions are used to pay administrative expenses of the Plan or to reduce future Company contributions. For the year ended December 31, 2024, forfeitures used to reduce Company quarterly matching contributions totaled \$182,312. Forfeitures available to the Plan totaled \$0 and \$18,957 as of December 31, 2024 and 2023, respectively.

Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid by Charles Schwab Bank, the Custodian, with assets of the Plan, unless paid by the Company at its discretion. During the year ended December 31, 2024, the Company paid a portion of direct expenses. Loan and distribution fees are paid by the Plan participants that requested the loan or distribution. Investment-related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term, and these changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Fair Value Measurement – cont’d.

Interest in common/collective trust: Valued at the net asset value (NAV), as a practical expedient, calculated on a daily basis by the administrator of the trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

4. PLAN TERMINATION

The Company has the right under the Plan to discontinue contributions to the Plan and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions. As of January 1, 2025, the Plan merged into the (k)larity Plan. (Notes 1 and 7) however no plan termination is deemed to have occurred for the plan.

5. PARTY-IN-INTEREST TRANSACTIONS

Prior to July 17, 2023, the Plan invested in Company stock. The Plan allows participants to take out loans against their vested account balances. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. INCOME TAX STATUS

The Plan received a determination letter from the Internal Revenue Service dated August 1, 2023, stating that the Plan is qualified under Section 401(a) of the Code, and therefore, the related trust is exempt from taxation. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan is tax exempt and has no unrelated business income tax, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any tax periods in progress.
