## 1. DESCRIPTION OF PLAN:

The following description of the Klosterman Baking Company (Company) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Klosterman Baking Company Profit Sharing Plan was first adopted on July 1, 1970. The Klosterman Baking Company as well as Klosterman Baking Indiana, LLC (formerly KBI, Inc.), Klosterman Baking Ohio, LLC (formerly KBO, Inc.), Klosterman Baking Cincinnati, LLC (formerly Klosterman Baking Cincinnati, Inc.), Hearth Grains Bakery, LLC, Klosterman Organic Baking, LLC, Whitehall Klosterman, LLC (formerly Whitehall Inc.), KBCB, LLC, KBC Buyer, LLC, and Klosterman Transportation Services, LLC (formerly Klosterman Transportation Services, Inc.), are participating employers in the Plan. The defined contribution plan covers substantially all employees who are not participants in union sponsored plans of the above named companies.

Effective with the collective bargaining agreement dated February 23, 2019 with the BCTGM Local No. 57, eligible employees of KBO, Inc. who are employed at the Springfield, Ohio location and are covered by this collective bargaining agreement, may make deferral contributions to the Plan. However, these participants are not eligible to participate in any Company contributions to the Plan.

### General

The Plan is a defined contribution plan covering all eligible employees of the Company who have attained age 18 and have one month of service. Participants are eligible to receive employer contributions when they attain age 18 and have one year of service in which they have completed at least 1,000 hours of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

The Company may contribute a discretionary match as well as a discretionary non-elective profit sharing contribution to the Plan on an annual basis. The contributions of the Company to the Plan are determined by resolution of the Board of Directors. The Board of Directors approved a 1% non-elective profit sharing contribution for years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, the Company set a discretionary matching contribution amount based on participants' years of service with the Company as follows:

One to five years of service	50% of first \$1,000 contributed by the participant
Six to ten years of service	60% of first \$1,000 contributed by the participant
Ten or more years of service	70% of first \$1,000 contributed by the participant

Participants may contribute eligible pre-tax and after-tax Roth compensation to their 401(k) account based on a minimum or maximum contribution uniformly established by the Company for any pay period or any year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Prior to January 1, 2024, certain participants could also elect to contribute unused flex credits to the 401(k) Plan. Flex credit contributions were comprised of 50% Company matching contributions which were awarded quarterly and 50% employee contributions which were awarded weekly. Effective January 1, 2024, participants may no longer elect to contribute unused flex credits to the 401(k) Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

**Participant accounts**

Each participant's account is credited with the participant's contributions and related Company discretionary match and discretionary non-elective profit sharing contributions, if any, as well as allocations of Plan earnings. Allocations of Plan earnings are based upon the performance of the investment funds chosen by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their employee contributions and rollover contributions, plus actual earnings thereon. Vesting in the Company match, flex match, and discretionary profit sharing contributions is based on years of continuous service. A participant is 100% vested after six consecutive years of service, as follows:

Forfeitures of non-vested balances of withdrawn participants are used to reduce Company contributions.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits**

In addition to normal retirement benefits commencing at the age of 60, the Plan provides for full benefits upon death or disability. If an employee is terminated for any other reason, benefits will be based upon the vested percentage of the participant's account. A participant eligible for benefits may elect to receive payments: (a) in a lump sum, (b) in annual installments over a specified number of years not in excess of fifteen, or (c) by the purchase of a single life annuity contract or a qualified joint and survivor annuity. Additionally, prior to termination from employment, a participant may withdraw all or a portion of his or her vested account balance at their election upon reaching age 59½. The Plan allows hardship distributions if certain financial requirements are satisfied. Upon termination, if the participant's vested interest in his or her account is between \$1,000 and \$7,000 and the participant does not direct the plan administrator to

make the distribution directly to him or her or into a selected Individual Retirement Account (IRA), then the lump-sum distribution will be rolled over into an IRA established by the plan administrator in the participant's name.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$76,511 and \$92,144, respectively. In 2024, the Company used \$91,835 from forfeited nonvested accounts to reduce Company contributions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### **Subsequent events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

### **3. INFORMATION CERTIFIED BY TRUSTEE:**

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024 and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

**5. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS:**

Certain Plan investments are shares of mutual and money market funds managed by Fidelity Investments. Fidelity Investments is an affiliate of Fidelity Management Trust Company, trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Company pays directly any other fees related to the plan's operations.

**6. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. TAX STATUS:**

The Plan adopted a non-standardized pre-approved profit sharing plan designed by Fidelity Management Trust Company. The plan document has received a favorable opinion letter from the IRS dated June 30, 2020, stating that the plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, the Plan is exempt from taxation. The Plan has since been amended; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

**8. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

These late remittances constituted nonexempt prohibited transactions. Management anticipates remitting lost earnings during 2025 to correct for these late remittances.
