We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### 1. Description of Plan

The following description of airSlate, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan, established January 1, 2018, that covers substantially all employees of airSlate, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). T. Rowe Price was the former custodian and recordkeeper of the Plan, however, the Plan transferred their assets on March 1, 2024 to ADP Retirement Trust Services, LLC who now serves as both the custodian and recordkeeper of the Plan.

airSlate, Inc. adopted the Instapage 401(k) Plan effective January 1, 2024. Effective March 1, 2024, the Plan merged with the airSlate, Inc. 401(k) Plan. All Plan assets were transferred to the airSlate, Inc. 401(k) Plan by November 25, 2024.

##### Eligibility

The Plan is available to substantially all Company employees, except employees who are union employees, non-resident aliens, residents of Puerto Rico, and other non-benefit eligible employees as defined by the Plan. Employees become eligible to make elective deferrals and to receive employer matching contributions upon attaining age 21. Employees become eligible for non-elective contributions upon attaining age 21 and completing at least 1,000 hours of service within a consecutive 12-month period following their hire date. If the 1,000 hours of service requirement is not satisfied during this initial period, eligibility is instead determined by completing one year of service, as defined by the Plan.

For employees who were employed on January 1, 2024, the service requirement and/or entry date requirement may be waived, allowing those employees to receive non-elective contributions earlier. The waiver applies to any eligible employee employed on January 1, 2024, unless otherwise specified by the Plan.

##### Vesting

Participants are immediately vested in their own contributions and rollover contributions. A participant is 100% vested in employer non-elective contributions after six years of credited vesting service, as defined by the plan document. A participant is 100% vested in employer matching contributions after two years of credited vesting service, as defined by the plan document. Participants become fully vested in all contributions upon death, disability, or attainment of normal retirement age, as defined by the Plan.

#### **Contributions**

Participants may voluntarily defer up to 90% of eligible compensation, as defined by the Plan.

The Plan may provide a flexible discretionary matching contribution and a discretionary non-elective employer contribution. For the year ended December 31, 2024, the Company matched 50% of each participant's deferral contribution up to 6% of the participant's compensation. There were no non-elective contributions for the year ended December 31, 2024.

Contributions are subject to the limitations established by the Internal Revenue Code (the Code).

#### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses, and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable are secured by the vested balance in the participant's account.

#### **Investments**

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan currently offers investments in various mutual funds.

#### **Payment of Benefits**

Participants shall become eligible to receive their vested account balances in a lump-sum, substantially equal payments, or partial withdrawal upon normal retirement (age 65), death, or disability. The Plan also allows for hardship withdrawals.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Accordingly, actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of the common collective trust are valued at the underlying net asset value (NAV) of the units held by the Plan at year-end. The common collective trust seeks to provide stability of principal while earning income consistent with money market rates over the long term. See Note 8 for a summary of fair value measurements.

Common collective trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the trust. Advanced written notice of either 12 or 30 months may be required in certain circumstances.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### **Administrative Expenses**

Certain administrative expenses are paid directly by the Company and are excluded from these financial statements.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

#### **Subsequent Events**

Management has considered transactions or events occurring through October 15, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

#### 3. Income Tax Status

The Plan has adopted a non-standardized pre-approved plan designed by ADP, LLC. The Internal Revenue Service has informed ADP, LLC by an advisory letter dated October 6, 2020, stating that the non-standardized pre-approved plan, as then designed, was in compliance with the applicable requirements of the Code. Although the Plan has been amended since receiving the advisory letter, the Plan administrator and the Plan's tax counsel believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date. The Plan is subject to the provisions of the ERISA.

#### 4. Information Prepared and Certified by Custodians

Information included in the financial statements and supplemental schedule relating to investments, investment transactions, notes receivable from participants, net appreciation in fair value of investments, and interest and dividends were obtained by management and agreed to or derived from the information certified by the custodians as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits;
- Note 8 in the Notes to the Financial Statements; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

#### 5. Parties-in-Interest Transactions

Certain plan investments are units of mutual funds managed by the Plan's custodians; therefore, these transactions qualify as party-in-interest transactions. The Plan incurred administrative expenses with the custodians, amounting to \$16,957 for the year ended December 31, 2024.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 8. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024:

*Mutual funds:* Valued using market quotations.

*Common collective trust:* Valued at the market approach based on the NAV of the units held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
