**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the UCF Athletics Association, Inc. 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of the UCF Athletics Association, Inc. (the “Association” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may elect to contribute at least 3% and up to 75% of pre-tax and post-tax annual compensation, as defined by the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Association makes discretionary contributions to the Plan based upon the participants’ eligible compensation. For the year ended December 31, 2024, the Association made a discretionary non-elective contribution equal to 5% of eligible compensation. Participants direct the investment of their contributions and the Association’s contribution into various investment options offered by the Plan. Contributions are subject certain limitations.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Association’s contributions, (b) Plan earnings, and (c) forfeitures of Association contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are vested immediately in their contributions and rollovers plus actual earnings thereon. Participants are vested in the Association’s contribution portion of their accounts based on years of service. A participant is fully vested after two years of credited service. Participants become immediately 100% vested in the Association’s contribution portion of their accounts upon death, disability, or the attainment of normal retirement age, as defined in the Plan.

Assets Pledged as Collateral: Participants are permitted to obtain loans directly from The Variable Annuity Life Insurance Company (VALIC), Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively “TIAA-CREF”). The minimum amount of a loan is \$1,000 and the maximum is the lesser of \$50,000, or 1) 45% of the participant’s combined TIAA-CREF accumulation attributable to this Plan; or 2) 90% of the participant’s CREF and TIAA Real Estate accumulation; or 3) 90% of the participant’s TIAA Traditional Annuity account. As loan payments are made, the collateral is adjusted accordingly on a periodic basis. The collateral is held in the VALIC Fixed Accounts and TIAA Traditional Account. The interest rate charged is variable based on the Moody’s Corporate Bond Yield. As of December 31, 2024 and 2023, the amount of Plan assets held as collateral for loans issued to participants were \$116,169 and \$155,377, respectively.

Payment of Benefits: Upon termination of service, retirement, disability or death, participants may receive a distribution equal to their vested account balance. Distributions may be paid in the form of a lump-sum payment or annual installments. The participant’s contributions may also be withdrawn for certain hardship situations.

Forfeitures: Forfeitures of Association contributions are used to offset future Association contributions or administrative expenses of the Plan.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Association and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contracts, are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit risks and global pandemics. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Reclassification of Prior Year Presentation: Certain prior year amounts have been reclassified for consistency with the current year presentation. Such reclassifications had no effect on the reported statements of net assets available for benefits or changes in net assets available for benefits.

### **NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by VALIC, TIAA and CREF, including information certified by TIAA as agent for TIAA Trust, N.A..

### **NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*TIAA-CREF Variable Annuity Contracts:* The fair values of TIAA-CREF variable annuity contracts are determined by obtaining quoted prices on the NASDAQ Stock Market (Level 1 inputs).

*TIAA Traditional Annuity Contracts (GRA):* Investments in certain TIAA Traditional Annuity contracts (GRA) are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to these investments that could impact the value realized upon exiting the contract. Contract value is deemed to approximate fair value based on the following valuation techniques:

- Theoretical transfer (exit value) - observation of recent participant transactions (purchases, sales and settlements) at contract value, and
- Discounted cash flow - comparison of historical and current yields of highly rated corporate bonds to historical and current crediting interest rates of the contracts, taking into consideration the liquidity restrictions applicable to the contracts.

There were \$2,905 purchases in and \$8,166 sales out of Level 3 investments during the year ended December 31, 2024.

The discounted cash flow valuation technique utilizes an appropriate risk-adjusted market discount rate that correlates closely with TIAA Traditional Annuity’s historical crediting rates for each contract type. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate, as described in Note 5. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period.

In determining the reasonableness of the methodology, management evaluates a variety of factors, including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (e.g., crediting rates) as compared to available market data (e.g., treasury yields) to substantiate the embedded risk premium.

*VALIC Variable Annuity Contracts:* The fair values of participation units held in variable annuity contract subaccounts of the VALIC Separate Account A are based on the net asset values reported by VALIC as of the financial statement dates and recent transaction prices. The net asset values of the subaccounts are updated daily based upon the investment performance of the underlying mutual fund they invest in less a deduction for charges. VALIC Separate Account A, which is structured as a unit investment trust, is comprised of numerous subaccounts which each invest in a single mutual fund managed either by an affiliate of VALIC or by an independent third party. Participants direct their investments to certain underlying “subaccounts” of the VALIC Separate Account A available to them under the Plan. Each subaccount provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to plan participants. Each contract is fully unconditionally guaranteed by TIAA. The TIAA Traditional Annuity is offered through Group Supplemental Retirement Annuity (GSRA). The GSRA has no liquidity restrictions and is considered to be benefit-responsive.

Participants who chose to allocate a portion of their retirement savings to the TIAA Traditional Annuity make contributions that purchase a specific amount of lifetime income based on the contractual rate of interest guaranteed by TIAA's claims paying ability. The TIAA Traditional Annuity also provides an opportunity for participants to receive additional amounts, which the TIAA Board of Trustees may declare on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12 month "declaration year" that begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities; they are not guaranteed for future years. Together the guaranteed minimum and additional amounts make up the crediting interest rate. The guaranteed interest rate for TIAA Traditional Annuity contracts is between 1.00% and 3.00%.

When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

There are no conditions specified in any of the contracts under which participant withdrawals and transfers would be restricted or made at a value other than contract value or the annuity or lump-sum benefit, as defined in the contracts. The contracts do not provide any provisions that would allow the Issuer to terminate the contracts between the Issuer and the participants.

The Plan also holds a fully benefit-responsive traditional investment contract with VALIC that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. VALIC maintains the contributions in its general account. The interest crediting rate may be subject to change periodically based upon contract provisions, and it may not be less than 1%. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's investment contracts with TIAA and VALIC specify certain conditions under which distributions from the contracts would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contracts limit the circumstances under which TIAA and VALIC may terminate the contracts. Examples of circumstances which would allow TIAA and VALIC to terminate the contracts include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, TIAA and VALIC could terminate the contracts at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The contract value of these fully benefit-responsive investment contracts was \$1,367,933 and \$1,039,481 at December 31, 2024 and 2023, respectively.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the association has the right under the Plan to permanently discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Association contributions.

**NOTE 7 – TAX STATUS**

Since the Plan is maintained under Section 403(b), rather than Section 401(a), there is no IRS program pursuant to which an individual determination letter may be obtained for the Plan. Although the Plan has not received a favorable determination letter, plan management believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Some administrative expenses of the Plan are paid directly by the Association. The Plan’s investments are issued by VALIC and TIAA-CREF, and therefore, these transactions and the Plan’s payment of fees to VALIC and TIAA-CREF qualify as party-in-interest transactions. TIAA Trust, N.A. acts as the custodian for the mutual funds held by the Plan as of December 31, 2024 and 2023. Notes receivable from participants also reflect party-in-interest transactions.
