Board of Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of White Management Corporation 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of White Management Corporation 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Operations

White Management Corporation 401(k) Plan (the Plan) is a defined contribution profit-sharing plan covering eligible employees of White Management Corporation and its Affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Accounting

The financial statements are reported using the accrual basis of accounting in which revenue is recognized when earned or otherwise available, and expenses are recognized when incurred.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in the statements of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2 RISKS AND UNCERTAINTIES

Investments – The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 3 DESCRIPTION OF PLAN

The following brief description of White Management Corporation 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is financed by employer and employee contributions and investment income. Participants may elect to defer either a flat dollar amount or a percentage of their compensation each year, subject to limitations prescribed by law. Effective January 1, 2021, the Plan adopted Safe Harbor provisions. Under these provisions, the employer will make Safe Harbor matching contributions on behalf of all eligible contributing employees equal to 100% of the amount they contribute to the Plan for each Plan year up to the first 3% of Plan compensation plus 50% of the amount they contribute between 3% and 5% of Plan compensation. Participants will be eligible to receive employer safe harbor contributions regardless of how many hours they work during the year or whether they terminate during the year. Additionally, a discretionary amount may be contributed each year as determined by the employer. There were no discretionary contributions for the plan years ending December 31, 2024 and 2023.

Each participant's account is credited with the participant's contributions and allocations of employer contributions, and Plan earnings net of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Employees are eligible to make salary deferrals and for safe harbor matching contributions after they have reached twenty-one (21) years of age and have completed a "year of service", defined as one thousand (1,000) hours. The initial eligibility computation period for the service requirement is one (1) year of service commencing on the date on which an employee first performs an hour of service and ending on the first anniversary thereof. Each subsequent computation period shall commence on the first day of the Plan year which commences prior to the first anniversary date of the employee's employment commencement date and each subsequent Plan year thereafter. Effective January 1, 2024, employees are eligible to make salary deferrals and for safe harbor matching contributions after they have reached twenty-one (21) years of age and have completed a "year of service," defined as twelve (12) months. Discretionary employer matching contributions and non-elective contributions for a Plan year will be allocated to participants upon the completion of 1 hour of service.

Participants are immediately vested in their employee contributions plus actual earnings thereon in addition to safe harbor matching contributions. Vesting in the employer discretionary contribution portion of each individual participant's account, plus actual earnings thereon, is based on years of vesting service.

NOTE 3 DESCRIPTION OF PLAN (Continued)

Vesting in the Plan is on a graduated basis as follows:

The non-vested portion of terminated participants' account balances are considered forfeited by the terminated participants and may be allocated based on the disposition methods as defined in the plan document. For the years ended December 31, 2024 and 2023, forfeitures were not allocated. Forfeitures available for use were \$19,434 and \$24,234 at December 31, 2024 and 2023, respectively.

The terms of the Plan specify that upon termination of service due to death, disability, or retirement, payments to participants will be made as follows:

- a. If the benefit amount is \$5,000 or less, the Trustee has the discretion to pay the amount in full.
- b. If the benefit amount is greater than \$5,000, either full, installment or partial amounts may be withdrawn as defined in the Plan document by participant election.

The Plan also permits hardship withdrawals and in-service distributions upon meeting certain requirements as defined in the Plan document.

All investments are directed by Plan participants. Participants may choose among twenty-five fund accounts.

Although it has not expressed any intent to do so, White Management Corporation and Affiliates has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

NOTE 4 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board authoritative guidance on fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money Market Accounts: Valued at cost which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Insurance Company General Account: Reported at fair value as determined by the insurance company.

Insurance Company Pooled Separate Accounts: Reported at fair value, which has been determined based on the unit values held by the Plan (separate accounts). Unit values are recorded at the net asset value of the underlying investments and are determined by dividing the Plan's net assets at fair value by its units outstanding at the valuation dates.

All assets have been valued using a market approach, except as noted above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan adopted the amendment and restatement of the prototype plan effective November 1, 2024, which obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 6 SUMMARY OF INFORMATION CERTIFIED BY PLAN TRUSTEE

The total fair value of investments held in trust was \$6,483,558 and \$5,747,079 at December 31, 2024 and 2023, respectively.

The Trustee, Voya Retirement Insurance and Annuity Company, has supplied the Plan's administrator with certifications as to the completeness and accuracy of information regarding investment assets, transactions, and income (including interest and dividends) presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the statements of changes in net assets available for benefits, for the plan years then ended.

Effective November 1, 2024, the Plan switched over to a new plan through Human Interest. The new Trustee, Matrix Trust Company, has supplied the Plan's administrator with a certification as to the completeness and accuracy of information regarding investment assets, transactions, and income (including interest and dividends) presented in the accompanying statement of net assets available for benefits as of December 31, 2024 and the statement of changes in net assets available for benefits for the year then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

A party-in-interest is defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Plan assets are used to pay some expenses for administration of the Plan and the remaining administrative expenses are paid by White Management Corporation. Payments to such service providers by the Plan qualify as party-in-interest transactions.

Certain Plan investments were pooled separate accounts and a guaranteed investment contract managed by Voya. Voya was the trustee as defined by the Plan through October 31, 2024, and therefore, these transactions qualify as party-in-interest transactions. The investments managed by Voya represent 0% and 25% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively.

NOTES TO FINANCIAL STATEMENTS

NOTE 8 PLAN CHANGES

During 2020, the Plan changed some provisions to comply with the requirements of the Further Consolidated Appropriations Act, 2020, including the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) provisions, the Coronavirus, Aid, Relief and Economic Security (CARES) Act, and the Consolidated Appropriations Act, 2021 (CAA), and corresponding guidance. The Plan has implemented certain requirements, among others, that allow certain eligible individuals to suspend required minimum distributions, delay the commencement date for required minimum distributions, and allows participants to take qualified COVID-19 related distributions up to \$100,000 from the Plan within the applicable time periods as defined in the relevant sections of Applicable Law. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

NOTE 9 PLAN AMENDMENTS AND RESTATEMENT

Effective December 1, 2023, the Plan adopted the amendment and restatement of the Benefit Plans Administrative Services LLC prototype plan.

In addition, the Plan was retroactively amended to change the eligibility for one participant so that she could participate in the plan at 20 years of age instead of 21 years of age for the 2023 Plan year.

Effective November 1, 2024, the Plan adopted the restatement of the Human Interest prototype plan.

In addition, the Plan was retroactively amended to change participant eligibility to have completed a “year of service,” defined as twelve (12) months instead of one-thousand (1,000) hours effective January 1, 2024.

NOTE 10 SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.
