Note 1. DESCRIPTION OF THE PLAN

The following description of the Cask NX LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering eligible employees of Cask NX LLC (the Company). There are no age or service requirements to participate in the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute up to 100% of regular compensation in the form of salary deferrals, subject to an annual limit specified in the Internal Revenue Code. New participants are automatically enrolled in the Plan at a 4% deferral rate unless they affirmatively elect otherwise. There are no annual automatic deferral rate increases with respect to such enrollments. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollover contributions").

The Plan includes a provision for Company safe harbor matching contributions which are equal to 100% of each participant's contributions up to 4% of the participant's eligible compensation for each pay period. The Company may also make discretionary non-elective contributions to the Plan. No discretionary non-elective contributions were made to the Plan in 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, and an allocation of the Company's non-elective contributions. The Company's non-elective contributions are allocated based on participant compensation. Each participant has an individual investment account and is credited with the earnings from that account.

Note 1. DESCRIPTION OF THE PLAN (continued)

Benefits

Upon termination of service, attainment of normal retirement age, disability or death, the participant will receive the value of the vested interest in his or her account as a lump-sum distribution or other distribution methods elected by the participant.

Vesting

Participants are immediately vested in their own contributions, the Company's matching contributions, the Company's non-elective contributions, and earnings thereon.

Notes Receivable from Participants

Participants may borrow a maximum of the lesser of 50% of their vested account balance or \$50,000. Notes receivable from participants bear a reasonable rate of interest determined by the plan administrator which was determined to be prime plus 2% for 2024 and 2023. The interest rate is fixed for the duration of the loan. Additionally, all loans are secured by the participant's vested interest in the Plan. Loans to participants must be repaid within 5 years or 30 years if the loan qualifies as a home loan, as defined by the Plan. At December 31, 2024, the interest rates on participant loans ranged from 5.25% to 10.50%. At December 31, 2023, the interest rates on participant loans ranged from 5.25% to 10.50%.

Investments

The Plan allows participants to direct their account balance to any combination of a variety of investment funds. The number of such funds and the type of investments therein may be changed at any time by the Plan. Participants may change their investment options at any time.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 2. SUMMARY OF ACCOUNTING POLICIES

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balance.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments

The Plan's investments, with the exception of the guaranteed interest contract, are stated at fair value.

The Plan's investment in the guaranteed interest contract is stated at contract value as determined by the trustee. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Notes Receivable from Participants

Notes receivable from participants are stated at the principal balance outstanding plus accrued interest. Delinquent participant loans are reclassified as distributions in accordance with the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company.

Note 3. FAIR VALUE MEASUREMENTS

FASB ASC 820-10 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 Fair Value Measurements

Fair values are based on publicly quoted prices in active markets for identical assets. The fair value of investments in shares of registered investment companies and pooled separate accounts is based on the publicly quoted net asset value of the shares held by the Plan at year-end. The fair value of investments in shares of common/collective trusts is based on the value of the underlying investments held, which is published daily on the Principal Financial Group websites.

Level 2 Fair Value Measurements

Fair values are based on observable inputs other than publicly quoted prices in active markets for identical assets.

Level 3 Fair Value Measurements

Fair values are based on unobservable inputs used for valuing the asset.

Note 4. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan's investment in the guaranteed interest contract consists of investments in the Principal Fixed Income Guaranteed Option (PFIGO). The PFIGO is a fully benefit-responsive group annuity contract issued by the Principal Life Insurance Company (PLIC). PLIC maintains the contributions in a general account.

The PFIGO is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract. The crediting rate is currently reset on a semiannual basis. A 5% surrender charge may apply under certain circumstances involving significant or total reductions in the Plan's investment in the contract.

Certain events may limit the Plan's ability to execute transactions at contract value with the issuer (e.g., premature termination of the contract by the Plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives, among others); however, the Plan Administrator has determined that those events that would limit the ability of the Plan to transact at contract value with plan participants are not probable of occurring.

Note 5. INFORMATION PREPARED AND CERTIFIED BY A QUALIFIED INSTITUTION

Note 6. PARTY-IN-INTEREST

Certain expenses of the Plan are paid for by the Company. The Company is the sponsor of the Plan and, therefore, these transactions qualify as party-in-interest. The most significant of these costs paid by the Company are the salaries for the employees responsible for plan administration and fees paid to a third-party administrator.

Principal Trust Company is the Plan record-keeper and manages certain investments for the Plan. Principal Trust Company is also the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services are considered party-in-interest transactions.

Note 7. FEDERAL INCOME TAX STATUS

The Plan is operated under the terms of a standardized prototype plan. The prototype plan received a determination letter from the Internal Revenue Service dated June 30, 2020, indicating that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype plan has been amended since receipt of the determination letter. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and that, therefore, the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for an uncertain position if it is not more likely than not that the position would be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 8. SUBSEQUENT EVENTS

Subsequent events were evaluated for accrual and disclosure through October 15, 2025, which is the date the 2024 financial statements were available to be issued.
