Report on the Financial Statements

We have performed audits of the financial statements of Suveto Buyer, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). A. DESCRIPTION OF THE PLAN

The following description of Suveto Buyer, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The plan is a defined contribution plan sponsored by Suveto Buyer, LLC (the Company) for the benefit of its employees. The Plan includes other adopting employers who are members of the same controlled group. Other adopting employers include Mallards Hance Veterinary, LLC dba Woodland Animal Hospital, Sunset Hance Veterinary, PLLC dba Sunset Boulevard Animal Clinic, Guide Dog Veterinary Management, LLC, Hance Mission Veterinary, Inc. dba Mercy Pet Clinic, Arrowhead Animal Hospital, PC dba Arrowhead Animal Hospital, Calico Veterinary Lending, LLC, Calico Veterinary Advisors, LLC, Arvada Vet, LLC dba Arvada Veterinary Hospital, AFPH, LLC dba Aspen Family Pet Hospital, Berthoud Animal Hospital, LLC dba Berthoud Animal Hospital, BLDR Vet, LLC dba Boulder Veterinary Hospital, BVH, LLC dba Broomfield Veterinary Hospital, FRVC, LLC dba Front Range Veterinary Clinic, LVC, LLC dba Laurel Veterinary Clinic, Harbor Veterinary, LLC, and Best Friends Veterinary Care – Long Island. Effective March 1, 2022, the Plan was restated to allow employees who are at least 21 years of age to be eligible to participate in the plan after completing 30 days of service. Prior to the restatement, employees were eligible to participate in salary deferral contributions and receive employer matching contributions on January 1st or the same day of the month occurring in each successive 3-month period after obtaining one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Principal Life Insurance Company is the Plan's custodian (Principal).

Contributions

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan, up to IRS maximum limits. Salary deferral contributions can be made on a pre-tax basis or directed towards a Roth (after-tax) account. Participants who are projected to be age 50 or older by the end of a calendar year may also make catch-up contributions. The Plan includes an automatic enrollment feature for those participants who do not specifically elect a percentage of pay, including zero, to defer. Employee rollover contributions are also permitted.

The Plan was amended effective January 1, 2021, and restated effective March 1, 2022, to allow for safe harbor contributions. The Employer will match 100% of each participants' contributions up to 4% of eligible compensation.

Participant Accounts

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the funds offered by the Plan and may change the allocation daily. Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

A. DESCRIPTION OF THE PLAN - continued

Vesting and Forfeitures

Participants are vested immediately in their contributions and Company safe harbor contributions plus actual earnings thereon. Participants become fully vested in other Company contributions based on the schedule below or upon reaching normal retirement age as defined in the Plan document, death, or disability. Forfeited accounts can be used to reduce Company contributions or administrative expenses, at the discretion of the employer.

Notes Receivable from Participants

The Plan does not permit new loans, however the Administrator may, in a uniform and nondiscriminatory manner, accept rollovers of loans into the Plan. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions or paid directly by the participant. All loans are covered by promissory notes.

Payment of Benefits

If the vested portion of a participant's account does not exceed \$5,000, the participant's entire vested account shall be distributed as of the earliest of his retirement date, date of death, or date of termination. Accounts greater than \$1,000 but less than \$5,000 in value, unless elected differently by the participant or his beneficiaries, will be directly rolled over to an individual retirement account with an affiliate of Principal. Accounts less than \$1,000 in value will be paid out fully to the participant or his beneficiaries. If the account balance is greater than \$5,000, a participant can also choose to receive a lump-sum distribution, roll over their account to another qualified plan or individual retirement account, request a partial withdrawal, or defer receiving payments until age 70 ½. In-service distributions of fully vested accounts are permitted for participants reaching age 59 ½.

B. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

B. SUMMARY OF ACCOUNTING POLICIES - continued

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes D and E for discussion of investment valuation.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Investment-related expenses are included in net depreciation in fair value of investments.

C. INFORMATION CERTIFIED BY PRINCIPAL

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

D. INVESTMENTS MEASURED USING THE NET ASSET VALUE PER SHARE PRACTICAL EXPEDIENT

Investments held by the Plan include collective investment trust funds and pooled separate accounts. There have been no changes in the methodologies used to value collective investment trust funds and pooled separate accounts at December 31, 2023.

Collective investment trust funds and pooled separate accounts are stated at fair value as determined by the issuer of the collective investment trust funds and pooled separate accounts on the fair market value of the underlying investments, which is valued at net asset value (NAV) as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Accounting Standards Codification Topic 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan holds no Level 2 investments.

Level 3 Fair Value Measurements

Fair values are based on unobservable inputs used for valuing the asset. Unobservable inputs are those that reflect the Plan's own assumptions about assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances. G. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

H. TAX STATUS

The Plan operates under a non-standardized adoption agreement in connection with a prototype basic savings plan sponsored by the Plan's third-party administrator. The Internal Revenue Service advised on June 30, 2020, that the prototype plan constitutes a qualified plan under section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Generally accepted accounting principles requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income examination for tax returns filed more than three years ago.

I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Rising inflation, fluctuating tariff rates, and international military conflicts have led to volatility in financial markets and have affected, and may continue to affect, the market price of the Plan's assets. The potential economic impact brought by, and the duration of these events is difficult to assess or predict and will depend on future developments that are highly uncertain and cannot be predicted.

J. PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$242,636 of administrative fees to Principal in 2024. The Plan incurs additional expenses related to general administration, record keeping and trust administration. These expenses and certain accounting and auditing fees related to the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for these services. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain plan investments are issued and managed by Principal. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

K. SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.
