### **Independent Auditor's Report**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Standard Meat Company 401(k) Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan by a qualified institution that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of, and for the year ended, December 31, 2024, stating that the certified investment information, as described in **Note 3** to the financial statements, is complete and accurate.

**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Standard Meat Company 401(k) Plan & Trust, formerly Standard Meat and DOS Project 401(k) Plan & Trust (the “Plan”), provides only general information. Participants should refer to the Plan agreement for more complete information regarding the Plan’s provisions.

General

The Plan, established November 1, 1996, and restated effective January 1, 2022, is a defined contribution plan available to all employees of Standard Meat Company, LLC, DOS Project, LLC, and SMICE, LLC (collectively the “Company”) who have reached 18 years of age and completed six months of service. Participation in the Plan is voluntary. The effective date to enroll in the Plan is the first day of each month following the date an employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Syracuse Food Group, LLC dba Syracuse Sausage Company, was acquired by Standard Meat in 2022 and became a participating employer in the Plan by amendment effective January 1, 2023. This amendment also added a provision for hardship withdrawals from deferral sources only. The name of the Plan was changed effective January 1, 2023, to Standard Meat Company 401(k) Plan & Trust.

Contributions

Participants may contribute up to 100% of annual compensation, including bonuses, on a pre-tax and Roth basis, subject to the Internal Revenue Code contribution limitation. The dollar limitation, which is adjusted annually for cost-of-living fluctuations, was \$23,000 in 2024 and \$22,500 in 2023. Participants 50 years of age or older may make additional catch-up contributions. These participants may contribute an additional \$7,500 and \$7,500 in 2024 and 2023, respectively. The Company matches 100% of participant salary deferrals up to 3% of compensation and 50% of participant salary deferrals between 3% and 5% of compensation. The total matching contribution will not exceed 4% of Plan compensation. Participants may also transfer distributions from other qualified defined benefit or contribution plans into the Plan once they are eligible to participate in the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and earnings on their investments and is charged with an allocation of administrative expenses if paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants’ Investment Options

Participants direct their salary deferral contributions and the Company’s matching contributions to investments made available and determined by the Plan administrator. Participants may change investment options via phone, paper document, or online access.

Vesting

Participants are 100% vested in their contributions and the Company's Safe Harbor match. Other Company contributions plus actual earnings thereon are vested as follows:

Plan Administration

For the years ended December 31, 2024 and 2023, Standard Retirement Services performed certain Plan administrative duties such as Form 5500 preparation, compliance testing, preparation of annual statements and distribution and loan transaction processing. Certain other administrative functions are performed by officers and employees of the Company; however, such officers and employees receive no compensation from the Plan.

Payment of Benefits

Upon termination of service, permanent disability, death, or becoming subject to a qualified domestic relations order, a participant may receive the amount equal to the value of the participant's vested interest in his/her account in a lump-sum payment. Benefits are recorded when paid. The full value of a participant's account becomes available upon retirement at age 65.

Termination of the Plan

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in account balances.

Administrative Expenses

Expenses of the Plan, to the extent not paid by the Company, may be paid out of the assets of the Plan provided that such expenses are consistent with ERISA. Such expenses include, but are not limited to, expenses for bonding required by ERISA, expenses for recordkeeping, and other administrative services, fees, and expenses of the Trustee.

Forfeitures

Non-vested balances of terminated participants are used to reduce the amount of required Company contributions. Non-vested balances relating to forfeitures from terminated participants for the years ended December 31, 2024 and 2023 were \$50 and \$0, respectively.

Benefit Withdrawals

The full value of a participant's account becomes available upon retirement, permanent disability, or death. Termination of employment for any other reason entitles the participant to only the vested portion of the account. Distributions are paid in lump sums. At the end of 2024 and 2023, there were \$0 and \$18,490, respectively, of funds that had been requested for withdrawal from the Plan that had not been paid. Refer to Note 6 for reconciliation of financial statements to Form 5500 for benefit payments.

Loans to Participants

Participants may borrow from their accounts a minimum of \$500 and up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance. Participants may have no more than two loans outstanding at any one time. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Loans must be repaid within a five-year period, except for loans used to acquire or construct a dwelling that is, or will be, used as the participant's principal residence. Such loans carry a 15-year repayment period.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on a cash basis. Dividends are recorded on the ex-dividend date.

The Putnam Stable Value 35 fund primarily holds investments in fully benefit-responsive insurance contracts that allow the Plan to make withdrawals at contract value to meet benefit-responsive requirements.

The Plan presents in the Statements of Changes in Net Assets Available for Benefits, the net appreciation in the fair value of investments, which consist of realized gains or losses, and the unrealized appreciation on investments.

Benefit Payments

Benefits are recorded when paid.

Parties-in-Interest

Parties-in-interest are defined under Department of Labor regulations as any fiduciary to the Plan, any party rendering services to the Plan, the employer, and certain others. As such, for the years ended December 31, 2024, and 2023, transactions conducted with Standard Meat Company, LLC, or DOS Project, LP, or their affiliates, Standard Retirement Services or their affiliates, or Charles Schwab Trust Bank or their affiliates would qualify as exempt party-in-interest transactions. No fees for custodial services were paid for the years ended December 31, 2024 and 2023. Record-keeping fees of \$107,520 and \$95,097 were paid to Standard Retirement Services during 2024 and 2023, respectively.

**NOTE 3: INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the information certified by the Trustee.

**NOTE 4: INVESTMENTS**

According to the Financial Accounting Standards Board, participant loans are to be classified on the Statements of Net Assets Available for Benefits as notes receivable from participants and measured at their unpaid principal balance, plus any accrued but unpaid interest. According to the Department of Labor, participant loans are considered an investment. They are measured at their fair value and must be included as supplemental information in the Schedule of Assets Held for Investment Purposes at the End of the Year. **NOTE 5: TAX STATUS**

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, complied with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code; therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal

Revenue Service and Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**NOTE 6: RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

Benefit claims that have been processed and approved for payment by the Plan but have not been paid are reported as a liability on Form 5500. However, accrual-based financial statements prepared under generally accepted accounting principles report benefit distributions when paid, so a reconciliation must be included within the audited financial statements.

**NOTE 7: RISKS AND UNCERTAINTIES**

Investment securities the Plan invests in are subject to various risks, such as market, credit, and interest rate risks. Due to the level of risk associated with such securities, it is at least reasonably possible that changes in the near term could materially affect participants' unit values and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 8: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- *Level 1 Inputs* – Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

- *Level 2 Inputs* – Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These might include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability (such as interest rates, volatilities, prepayment speeds, credit risks, etc.) or inputs that are derived principally from, or corroborated by, market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3 Inputs* – Unobservable inputs for determining the fair values of assets or liabilities that reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

A description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. There have been no changes in the methodologies used at December 31, 2024 or 2023.

In general, fair value is based upon quoted market prices, where available. If such quoted market prices are not available, fair value is based upon internally developed models that primarily use, as inputs, observable market-based parameters. Valuation adjustments may be made to ensure that financial instruments are recorded at fair value. These adjustments may include amounts to reflect counterparty credit quality and the Plan's creditworthiness, among other things, as well as unobservable parameters. Any such valuation adjustments are applied consistently over time. The Plan's valuation methodologies may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While management believes the Plan's valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

The following is a description of the valuation methodologies used for instruments measured at fair value:

*Common/Collective Trust Funds* – These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is classified within Level 2 of the valuation hierarchy because the NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments, which are traded on an active market.

*Mutual Funds* – These investments are valued at the NAV of shares held by the Plan at year end. The mutual funds are classified within Level 1 of the valuation hierarchy.

**NOTE 9: SECURE 2.0 ACT**

The SECURE 2.0 Act was enacted on December 29, 2022. It builds upon the SECURE Act of 2019 and includes provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. It includes the following provisions that went into effect in 2023 or are effective for plan years beginning after December 31, 2023. Some of the provisions are required to be adopted by 401k Plans, others can be adopted at the Plan Sponsor's discretion. The Plan has not made a determination as of December 31, 2024, regarding adoption of the voluntary provisions.

Required Minimum Distribution (RMD) - Mandatory

The age at which individuals must begin taking withdrawals from their retirement accounts increased from 72 to 73, effective January 1, 2023. Individuals who turned 72 before 2023 are still subject to the previous rule. The penalty for missing an RMD was also reduced from 50% to 25%. This provision is mandatory.

Hardship Distribution Certification - Voluntary

Plan sponsors can allow retirement plan participants to certify that they have experienced a hardship and can therefore withdraw funds from their account.

Disaster Relief - Voluntary

Section 331 provides permanent rules relating to the use of retirement funds in the case of a federally declared disaster. The permanent rules allow up to \$22,000 to be distributed from employer retirement plans or IRAs for affected individuals. Such distributions are not subject to the 10% additional tax and are taken into account as gross income over three years. Distributions can be repaid to a tax-preferred retirement account. Additionally, amounts distributed prior to the disaster to purchase a home in a qualified disaster area but was not so used on account of the qualified disaster can be recontributed, and an employer is permitted to provide for a larger amount to be borrowed from a plan by affected individuals and for additional time for repayment of plan loans owed by affected individuals. This provision is effective for disasters occurring on or after January 26, 2021.

Roth Catch-up Contributions – Mandatory

Catch-up contributions made by participants whose wages exceeded \$145,000 in the previous year will be treated as Roth contributions. The amount is adjusted for inflation. This provision is effective for plan years beginning after December 31, 2026, and is mandatory.

Student Loan Payment Matching Contributions – Voluntary

401(k), 403(b), and governmental 457(b) plans can count student loan payments as elective employee contributions for the purpose of triggering matching contributions. This provision is effective for plan years beginning after December 31, 2023, and is voluntary.

Emergency Distributions – Voluntary

Taxpayers can choose to pay back emergency distributions over a three-year period, starting the day after the distribution. This provision is effective for distributions made after December 31, 2023. This provision applies to Plans that provide for emergency distributions and is voluntary. The Plan does not provide for emergency distributions.

Domestic Abuse Distributions – Voluntary

Participants can self-certify that they have experienced domestic abuse and withdraw up to \$10,000 (indexed) or 50% of their retirement account, whichever is less. This provision is effective for distributions made after December 31, 2023.

**NOTE 10: SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. The Company opened another plant in Fort Worth, Texas, in the historical Stockyards District. This plant went into production in June 2025. Approximately twenty-three existing employees moved over to this plant. Employees will be added as production volume dictates.

**NOTE 11: NONEXEMPT TRANSACTIONS**

For the years ended December 31, 2024 and 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances were identified on the Schedule of Delinquent Participant Contributions, which totaled \$260,760. Untimely remittances of \$585,914 were identified on the Schedule of Delinquent Participant Contributions in a prior year and were corrected during the year ended December 31, 2024. The Company will be compensating participants for lost earnings resulting from the delay in contributions.
