### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Compass, LLC 401(k) Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Compass, LLC 401(k) Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

The firm of D.H. Scott & Company, LLP, which audited the Plan for the year ended December 31, 2023, was acquired by Platform CPAs, LLP effective November 15, 2024.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Compass LLC 401(k) Plan & Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Compass, LLC (the Company) 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a safe harbor defined contribution plan available to all employees of the Company who have 1,000 hours of service in one year. Employees whose employment is governed by a collective bargaining agreement in which retirement benefits were subject to good faith bargaining are not covered by the Plan. Non-resident aliens and reclassified employees are also not covered by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

Participants may elect to contribute up to \$23,000 plus an additional \$7,500 if the participant reaches age 50 or older during the plan year. The employer will make a safe harbor matching contribution up to 5% of compensation. For the year ended December 31, 2024, the Company recorded safe harbor matching contributions of \$467,985, with \$19,506 paid subsequent to year end.

The employer may make discretionary profit sharing or matching contributions to the Plan.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, and Company's matching contribution, and allocation of plan earnings. Allocations are based on participant investment direction. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Forfeited Accounts**

Forfeited balances of terminated participants' non-vested accounts may be used for the Plan expenses or used to reduce future employer contributions. At December 31, 2024 and 2023, forfeitures available to offset future employer contributions or to cover the Plan expenses were \$17,741 and \$3,940, respectively. During the year ended December 31, 2024, there were \$1,871 of forfeitures used to offset employer contributions.

### **Vesting**

Participants are vested immediately in their voluntary contributions, employer safe harbor contributions, and actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service. A participant is vested 100% after six years of credited service.

### **Investment Direction**

Participants can direct all contributions to the account of their choice of available investments. If the participant makes no such direction, the trustee will allocate their contributions to a default investment portfolio based on age.

### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account either in a lump-sum amount or in periodic withdrawals. Distributions of \$5,000 or less shall be distributed in lump-sum.

**NOTE 1 - DESCRIPTION OF PLAN (continued)**

**Notes Receivables from Participants**

Participant loans are allowed under the Plan in amounts not less than \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance, whichever is less. Participants are limited to two outstanding loans from their account at one time. Notes are secured by the balance in the participant's accounts and bear interest at rates ranging from 4.25% to 9.75%. Principal and interest are repaid through monthly payroll deductions.

**Retirement**

Normal retirement age under the Plan is the later of 62 years of age or the fifth anniversary of the Plan year in which the participant commenced participation in the Plan. Early retirement age is 55 years of age.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting with the exception of benefits which are recorded when paid.

**Noninterest-bearing Cash**

Noninterest-bearing cash represents amounts held in the Plan's custodial accounts that are not invested in specific investment options. Such balances generally arise from contributions received, pending investment transactions, or pending benefit payments. These amounts are not interest bearing and are carried at cost, which approximates fair value.

**Investment Valuation**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Fully benefit-responsive investment contracts are recorded at contract value. Contract value is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan for these investments. See Note 5.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Loans that are past due and meet the criteria for deemed distributions under IRS rules continue to be reported as participant loans receivable until formally written off. During the year ended December 31, 2024, the Plan had \$7,326 of delinquent loans classified as deemed distributions. Once formally written off, delinquent loans are reclassified as distributions to participants and removed from loans receivable.

**Payment of Benefits**

Benefits are recorded when paid.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

### **Income Recognition**

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis and interest income from notes receivable from participants is recognized when paid, primarily semi-monthly. Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments.

### **Administrative Expense**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

## **NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor Rules and Regulations and disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the trustee, Equitable Financial Life Insurance Company, for the period of January 1, 2024 to October 28, 2024, and John Hancock Life Insurance Company for the period of October 28, 2024 to December 31, 2024, and were not subjected to any auditing procedures performed:

- All investments and notes receivable from participants shown in the accompanying statements of net assets available for benefits.
- Net investment income from the investments, as shown in the accompanying statement of changes in net assets available for benefits, including net appreciation (depreciation) in fair value of investments and interest income on notes receivable from participants.

## **NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quote prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 4 - FAIR VALUE MEASUREMENTS (continued)**

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds	Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In prior years, the Plan maintained a fully benefit-responsive investment contract with Equitable Life Insurance Company ("Equitable"). During 2024, the Equitable contract was terminated and a new fully benefit-responsive investment contract was established with John Hancock Life Insurance Company, the Plan's new custodian. The contract value was \$333,901 and \$322,320 at December 31, 2024 and 2023, respectively. Contributions are maintained in a general account, credited with earnings on the underlying investments, and charged for participant withdrawals and administrative expenses. Under the Guaranteed Interest Option (GIO), the issuer is contractually obligated to repay principal and credit a specified interest rate guaranteed to the Plan. The crediting rate is determined based on a formula established by the issuer and is reviewed monthly for potential reset.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY (continued)**

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value presents the sum of all amounts allocated or transferred to the account plus the amount of any interest credited less all amounts that have been withdrawn, including charges to or transfers from the account.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

All allocations to, and transfers to and from, the GIO are to be made solely at the discretion of the individuals covered by the Plan without any direction or influence from the employer. The plan sponsor must give the issuer at least 60 days advance written notice of any noncompliance with this condition. The plan sponsor must provide the issuer with any amendment to the Plan or its investment policy, any communication by the plan sponsor to the individuals covered by the Plan concerning the GIO, or any change in the manner in which the Plan is administered. The plan sponsor must provide any such document to the issuer at least 60 days before its effective date.

If the conditions above are not complied with or if the plan sponsor fails to remit as contributions all amounts maintained with respect to the Plan or to use the allocation method approved by the issuer, or if the issuer determines and so notifies the plan sponsor by written notice that an amendment to the Plan, the Plan's investment policy, or any change in the manner in which the Plan is administered would materially and adversely affect the flow of monies to or from the GIO, then the issuer will have the right to decline further requests for transfers to or from the GIO, and/or deem that a termination of Plan participation under the contract has occurred and that the plan sponsor has requested the issuer to make payment in accordance with termination provisions of the contract. If the issuer terminates the contract with the Plan under any of these conditions, they could settle at an amount different from contract value. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

**NOTE 6 - PLAN MERGER**

During the year ended December 31, 2024, the Company merged with Options in Supported Living, LLC and effective October 31, 2024, the Options Safe Harbor 401(k) Plan (Options Plan) was merged into the Plan. As a result of the merger, all assets and participant account balances of the Options Plan were transferred to the Plan. The merger was completed in accordance with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and applicable Internal Revenue Code requirements.

Assets transferred from the Options Plan to the Plan included investments at fair value of \$2,328,458 and notes receivable from participants of \$42,698, for total assets transferred of \$2,371,156 as of the merger date. The net assets transferred are included in the statement of changes in net assets available for benefits for the period from October 31, 2024 through December 31, 2024, representing the period subsequent to the merger during which the transferred assets were part of the Plan.

Participants of the Options Plan became participants in the Plan, with account balances, investment elections, and vesting percentages maintained in accordance with the provisions of the Options Plan and the merger agreement.

#### **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **NOTE 8 - RELATED PARTY TRANSACTIONS & PARTIES IN INTEREST**

FASB ASC 850 requires the disclosure of significant transactions with related parties. There were no related party transactions for the years ended December 31, 2024 and 2023. The Department of Labor (DOL) also requires transactions with parties-in-interest to be disclosed.

A party-in-interest, as defined by the DOL, is anyone who provided services to the Plan during the Plan year. The DOL provides a reporting exemption if the services provided are necessary to the Plan. Platform CPAs, LLP, Principal Life Insurance Company, Equitable Life Insurance Company, John Hancock Life Insurance Company and Associated Pension Consultants provided administrative services to the Plan.

#### **NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE 10 - INCOME TAX STATUS**

The Company adopted a Prototype Non-standardized Profit Sharing Plan with a Cash or Deferred Arrangement (CODA), which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). While the prototype plan has been amended since receiving the letter, the plan administrator believes the Plan has been operated in accordance with the applicable provisions of the IRC. The Plan is qualified under Section 401(a) of the IRC and is exempt from federal income tax under provisions of Section 501(a) of the IRC, and from applicable state tax, as state law conforms to the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan is subject to routine audits by taxing jurisdictions. In general, the Plan's returns are subject to examination by federal tax authorities for a period of three years beginning with the later of the due date of the return or the date they are filed. There are currently no examinations in progress.

**NOTE 12 - CHANGE IN CUSTODIAN**

During the year ended December 31, 2024, the Plan changed its custodian from Equitable to John Hancock. This change was made to improve administrative services, investment options, and recordkeeping efficiency.

All Plan assets, including cash, investments, and participant account balances, were transferred to the new custodian in accordance with plan provisions. The transfer was completed without interruption to participant accounts or investment.

**NOTE 13 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.



