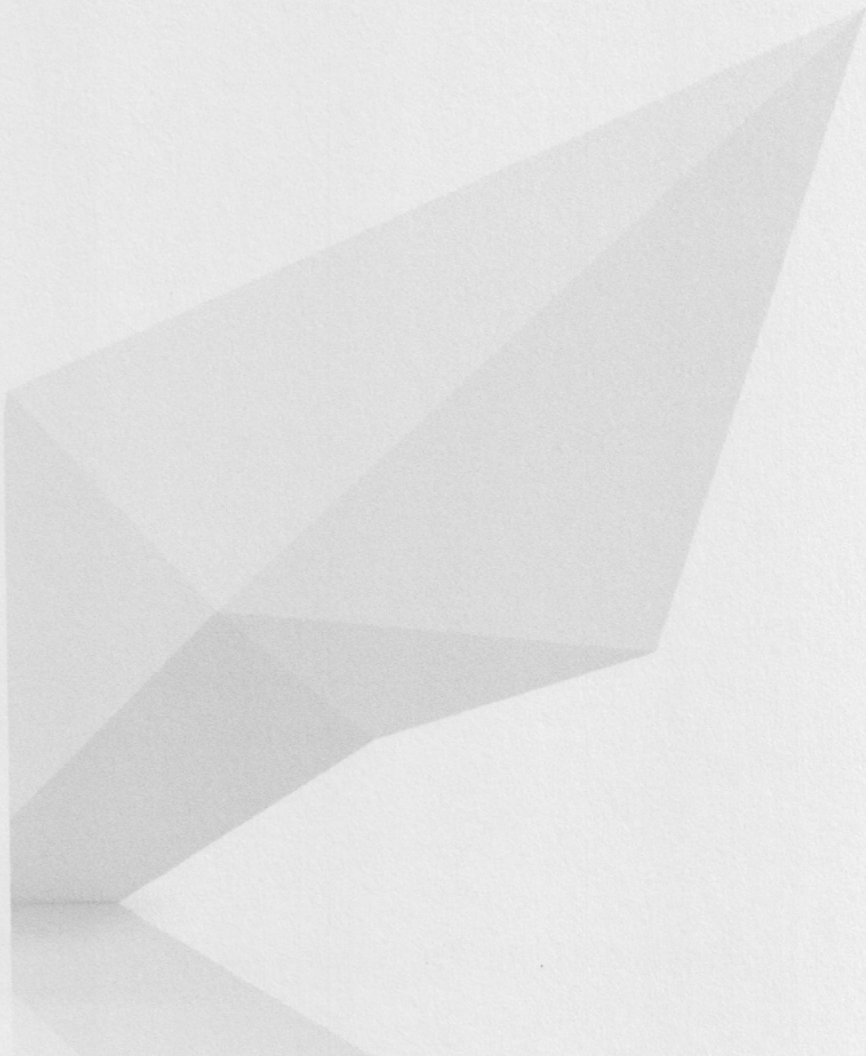

### Note 1: Plan Description and Basis of Presentation

The following description of Scott's Recreation Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information.

#### General

The Plan covers employees of Chambers Leasing d/b/a SR1 Companies (the Company). The Plan was established, effective January 1, 2021, to provide eligible employees the opportunity to participate in the ownership of the Company and to accumulate funds for their retirement in a defined contribution plan.

The Company is the sponsor of the Plan. The ESOP component of the Plan currently operates, in relevant part, as a leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC). The 401(k) component of the Plan is designed to comply with Section 401(k) of the regulations under the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. An ESOP Trustee Committee administers the Plan.

The ESOP component of the Plan purchases Company common shares from the Company using proceeds from contributions and holds the stock in a trust established under the Plan.

On June 15, 2021, the Plan purchased 100,000 shares of Company common stock using the proceeds from a note from the Company, totaling \$2,355, and start-up contributions of \$2,645. The borrowing is to be repaid by fully deductible Company contributions to the trust fund and dividends on the Company common stock. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lender has no rights against shares of common stock once they are allocated under the provisions of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the Plan year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

1. The accounts of employees with rights in allocated common stock (allocated), and the accounts of employees with the rights in the 401(k) component of the Plan (allocated), and
2. Common stock not yet allocated to employees (unallocated).

### Note 1: Plan Description and Basis of Presentation (Continued)

#### Eligibility and Participation

Employees of the Company, except for those employees working under a collective bargaining agreement, leased employees, employees who had received payments in a capacity other than as an employee and were reclassified as employees, or nonresident aliens, who complete a year of service or become qualified part-time employees, as defined in the Plan document, are eligible to participate in the Plan. The Plan entry dates are the earlier of the first day of the Plan Year or July 1 following the date on which such requirements are met.

#### Contributions

Each year, participants may contribute to the 401(k) component of the Plan up to 100% of their eligible pretax annual compensation, as defined by the Plan, not to exceed the limits of the IRC. Participants can also make Roth deferral contributions, which are contributions based on after-tax compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company may, in its sole discretion, make matching contributions to the Plan. For the year ended December 31, 2024, the Company contributed 100% of the first 3% and 50% of the next 2% of compensation that a participant contributed to the Plan up to a maximum of 4% of compensation. The Company made discretionary matching contributions of \$305,062 during the year ended December 31, 2024. The Company may also, at its sole discretion, make profit sharing contributions to the Plan. The Company did not make profit sharing contributions in 2024. Participants direct the investment of 401(k) contributions into various investment options offered by the Plan.

The Company is required to make ESOP contributions on an annual basis to cover the principal and interest due on the term loan. The Company may make ESOP component discretionary contributions. The Company ESOP contribution for the year ended December 31, 2024, totaled \$102.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

A separate individual account is established for each participant for the ESOP and 401(k) components of the Plan.

Each participant's ESOP account is credited as of the last day of each Plan year with an allocation of the shares of the Company's common stock released by the Trustee from the unallocated account, Company discretionary ESOP contributions, plan earnings, and forfeitures of terminated participants' non-vested accounts. Allocations of Plan earnings are based on the value of Plan assets at the beginning of the Plan year, less forfeitures and withdrawals made during the Plan year. Company contributions, forfeitures, and shares released from the unallocated account are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Only those participants that are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Plan income (loss) is allocated to each participant's account based on the participant's share of Company stock.

#### Participant Accounts (Continued)

Each participant's 401(k) account is credited with the participant's contributions, Company discretionary matching contributions, if any, Company profit sharing contributions, if any, and allocations of 401(k) investments earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their 401(k) component elective deferral contributions, rollover contributions, Company profit sharing contributions made after February 1, 2021, and Company matching contributions, plus actual earnings thereon. Vesting in the Plan's 401(k) component discretionary contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service with the Plan. Participants vest 20 percent per year of service starting with two years of service and are 100 percent vested after six years of service.

Vesting in the ESOP component of the Plan is based on the number of years of continuous service. Participants vest 100% after three years of service.

If participants terminate due to death, disability, or normal retirement, as defined by the Plan, they automatically become 100% vested in their entire account balances as of their termination date.

#### Forfeitures

Forfeitures of the Company ESOP discretionary contributions may be first used to pay expenses associated with the Plan, restore unvested participants' benefits to their ESOP and 401(k) accounts following a re-hire, and then allocated among the remaining eligible participants as if they were additional Company contributions.

Forfeitures of the Company 401(k) discretionary matching contributions may be used to pay Plan expenses or reduce discretionary matching contributions. Forfeitures and asset holding account balances totaled \$0 at December 31, 2024 and 2023. There were no forfeitures used to reduce Company discretionary matching contributions during the year ended December 31, 2024.

#### Payment of Benefits

Distributions due to termination of service, death, disability or normal retirement age are paid to a participant in the form of lump-sum payments for the value of the participant's vested interest in his or her account in the 401(k) component of the Plan. In addition, hardship distributions out of the participant's vested 401(k) account are permitted if certain criteria are met. The Plan also allows for in-service distributions from the vested portion of the 401(k) account upon attaining age 65 provided certain conditions are met.

#### Payment of Benefits (Continued)

Distributions due to termination of service, death, disability or normal retirement age for balances in the participant's ESOP component account will be made in substantially equal annual installments over a period not to exceed five years. Distributions are made in cash or in the form of Company common shares, plus cash for any fractional share. Any distributions in stock will have a simultaneous put back to the Company in exchange for cash. 177 shares of Company stock were distributed during the year ended December 31, 2024.

If the participant's vested ESOP or 401(k) account balance is less than \$7,000, the Plan administrator may automatically distribute the balance as a lump-sum distribution without consent.

Under the provisions of the Plan, the Plan is obligated to repurchase participant shares, which have been distributed under the terms of the Plan, as long as the shares are not publicly traded or if the shares are subject to trading limitations.

#### Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55, with at least 10 years of participation in the Plan, may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify will have the amount to which an election has been made transferred to their 401(k) account, or the Company may elect that such amount be distributed to the participant. The 401(k) account must offer at least three investment alternatives.

#### Voting Rights

Shares of Company stock in the Plan are voted by the Trustee only in such a manner as directed by the ESOP Trustee Committee. However, with respect to any corporate matter that involves the voting of such shares that constitutes a merger, consolidation, recapitalization, reclassification, liquidation, dissolution, and sale of substantially all assets of the Company, or such other transactions which may be prescribed by regulation, each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account in confidence and is notified by the Trustee prior to the time that such rights are to be exercised. Allocated shares for which no direction is received shall be voted by the Trustee in its discretion. The Trustee may vote any unallocated shares in its discretion.

#### Put Option

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

No shares of the Company's common stock have been distributed to any participant and accordingly, the Company has no current obligation to repurchase any shares from participants.

#### Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to compliance with ERISA and Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, all account balances will become fully vested, and the ESOP Trustee Committee shall direct the Trustee to pay all liabilities and expenses and to sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan. A complete discontinuance of contributions by the Company shall constitute a termination.

#### Notes Receivable From Participants

Participants may borrow from their 401(k) fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and must bear interest at rates which are commensurate with local prevailing rates. Note terms cannot exceed five years, unless the proceeds are used in the purchase of a primary residence of the participant, in which case the administrator may permit a longer repayment term of up to 30 years. Principal and interest are paid ratably through bi-weekly payroll deductions. Participants may have only one loan outstanding at any one time.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Management considers the fair value of the investment in Chambers Leasing d/b/a SR1 Companies stock to be a significant estimate. Actual results may differ from these estimates.

#### Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock and other investments ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid. See Note 1.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair value of the shares of Company common stock is determined based on an annual independent appraisal. See Note 6 for discussion of fair value measurement.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are netted with the amount of the loans disbursed. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants will be charged directly to the participant's account and are netted with amounts of loan disbursements and benefit payments. Investment-related expenses are allocated proportionally to Plan participants based on their respective balances and are included in net investment income.

#### Payment of Benefits

Benefits are recorded when paid.

### Note 3: Tax Status

The IRS has determined and informed the Company by a letter, dated May 19, 2022, that the Plan is qualified and, therefore, the Trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan and Trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the Trust was tax-exempt as of the financial statement date.

### Note 4: Administration of Plan Assets

The ESOP component of the Plan's assets, which consist principally of Company common stock, are held by the Company ESOP Trustee Committee, Trustee of the Plan.

Company contributions related to the ESOP component of the Plan are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which is reimbursed to the Trustee through contributions as determined by the Company.

The assets of the 401(k) component of the Plan are held by John Hancock Life Insurance Company, the Custodian of the Plan, who invests cash received, interest and dividend income and make distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### Note 6: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described, as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 6: Fair Value Measurements (Continued)

*John Hancock Stable Value Fund:* The John Hancock Stable Value Fund invests in a variety of investment contracts issued by insurance companies and other financial institutions. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There were no unfunded commitments as of December 31, 2024 or 2023. Were the Plan to initiate full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Company common stock:* The fair value of the Company common stock held by the Plan is valued at fair value based upon an independent appraisal. The appraisal was based on income valuation techniques consistent with the prior years. The appraisal incorporated the following valuation methodology: Discounted cash flow method. For the appraisal, the appraiser utilized forecasted cash flows and terminal values which were present valued to determine the enterprise value of the Company. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves the Trustee's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the reviewed financial statements and internal financial statements of the Company. The appraiser prepares a preliminary report, which the Trustee and Plan management review in detail and discuss, and the Trustee approves.

### Note 7: Note Payable

On July 1, 2021, the Plan entered into a \$2,355 term loan with the Company. The proceeds of the loan were used to finance the purchase of 47,100 shares of Company common stock. Unallocated shares are collateral for the loan. Shares will be released from collateral and allocated to participants when principal and interest payments are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payment, divided by the total of this year's payment, plus all future years' principal and interest payments. In total, 1,209.11 shares were released and allocated for the Plan year ended December 31, 2024. The note payable is due in forty equal annual installments of \$101.91, including interest at 3%, through December 2059. The outstanding balance of the note payable as of December 31, 2024 and 2023, was \$2,187 and \$2,223, respectively.

### Note 8: Information Prepared and Certified by the Custodian

Certain financial information included in the Plan's financial statements and supplemental schedule regarding the Plan's investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, has been derived from information certified as complete and accurate by John Hancock Life Insurance Company, the Custodian of the Plan, in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The financial information certified by John Hancock Life Insurance Company as of and for the year ended December 31, 2024, consists of investments at fair value of \$3,683,877, notes receivable from participants of \$39,889, net appreciation in the fair value of investment of \$401,125 and interest income on notes receivable from participants of \$2,139. The certified financial information as of December 31, 2023, consists of investments at fair value of \$2,550,309 and notes receivable from participants of \$9,393.

### Note 9: Related-Party Transactions and Party-in-Interest Transactions

The Plan invests in Company common stock and receives contributions from the Company. These are related party and party-in-interest transactions under ERISA. As noted in Note 7, the Plan also has a note payable to the Company.

John Hancock Life Insurance Company is defined as the Custodian by the Plan and, therefore, transactions with the Custodian qualify as party-in-interest transactions. John Hancock Life Insurance Company, is the recordkeeper of the Plan. Recordkeeping fees paid during the year ended December 31, 2024 are included in administrative expenses. Investment management fees paid to the Custodian during the year ended December 31, 2024 are included in administrative expenses.

Valmark Advisers, Inc. is an investment advisor to the Plan and is paid by the Plan for those services. Investment advisor fees paid by the Plan during 2024 are included in Plan expenses.

The Angell Pension Group Inc. provided third party administrative services to the Plan and was paid by the Plan for those services. Third party administrative services fees paid by the Plan during 2024 are included in Plan expenses.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
