### Note 1 - Plan Description

The following description of Michigan Surgery Specialists, P.C. 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution 401(k) profit-sharing plan and trust covering all eligible employees of Michigan Surgery Specialists, P.C. (the "Company"). All employees of the Company who have completed at least three months of service with the Company are eligible to participate in the Plan, except for those excluded specifically within the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan allows participants to defer a portion of their compensation up to the maximum currently allowed by law and the Internal Revenue Code. Participants may also make contributions in the form of a rollover of funds from another qualified plan. Participants' deferred compensation is treated as a participant elective contribution, allocated to participant elective accounts, and 100 percent vested at the time of contribution.

Effective January 1, 2020, the Company amended its plan to allow for a safe harbor matching contribution. See the plan document for more details. There were safe harbor employer match contributions made, net of forfeitures, of approximately \$379,000 and \$256,000 for the plan years ended December 31, 2024 and 2023, respectively. The employer may also make discretionary profit-sharing contributions, to be determined by the Company annually. There were no such contributions made for the plan years ended December 31, 2024 and 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

The Plan offers certain participants the option to establish and maintain self-directed brokerage accounts, which provide individuals the opportunity to invest in a wide range of publicly traded investments beyond those available in the core investments of the Plan.

#### **Vesting**

Participants are immediately vested in employee salary contributions, employer safe harbor matches, and rollover contributions and any income or loss thereon. Vesting in the Company's contributions, plus actual earnings thereon, is based on years of service. An employee is considered to have one year of service for the purpose of vesting upon completion of 1,000 hours of service at any time during a plan year. Participants vest in all contributions made by the Company 20 percent after two years of service and an additional 20 percent after each subsequent year of service until fully vested.

#### **Benefit Payments**

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum payment, installments, or an annuity equal to the vested balance of a participant's account.

**Note 1 - Plan Description (Continued)**

***Forfeitures***

If a participant is not fully vested on his or her termination date, nonvested amounts are forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled approximately \$43,000 and \$74,000, respectively.

***Party-in-interest Transactions***

Certain plan assets were in investment funds managed by Empower Annuity Insurance Company of America; Empower Annuity Insurance Company; and Empower Trust Company, LLC (collectively, the "Custodians"); therefore, these transactions qualified as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net depreciation of fair value of investments.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

The Custodians hold the Plan's investments and participant notes receivable, other than the self-directed brokerage accounts, and execute related investment transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year, other than the related balances and activity of the self-directed brokerage accounts, are based solely on information certified by the Custodians.

The Plan's investments in self-directed brokerage accounts totaling \$3,374,483 and \$2,964,165 at December 31, 2024 and 2023, respectively, and related investment gains of \$350,433 and \$579,050 for the years ended December 31, 2024 and 2023, respectively, were not certified.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require that certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 5 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Common Collective Trust Fund**

The common collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

**Self-directed Brokerage Accounts**

Self-directed brokerage accounts include various investments in publicly traded securities, which are valued at the quoted prices reported in active markets. Interest-bearing cash is valued at fair value based on its outstanding balance.

#### Note 6 - Investment Contract

The Plan has a benefit-responsive unallocated contract with Empower Annuity Insurance Company of America (Empower). Empower maintains plan contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting. When establishing interest crediting rates for this product, Empower considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
