## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Southeast Orthopedic Specialists 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

## Notes to Financial Statements

---

### 1. **Summary Plan Description:**

The following description of the Southeast Orthopedic Specialists 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan was initially established on January 1, 2006, and restated January 1, 2022. The Plan is a 401(k) defined contribution plan covering all employees of Southeast Orthopedic Specialists, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective February 15, 2024, the Plan was amended to allow participant loans. Loans are available to all eligible participants and are subject to the terms and conditions outlined in the Plan document.

#### *Eligibility*

Employees who have completed 3 months of service and are age 21 or greater are eligible to participate in the Plan. Eligible employees may enroll in the Plan on the first day of the quarter following the date that eligibility conditions are met.

#### *Contributions*

Participants may elect to make salary deferral contributions in any percentage of their compensation up to the maximum amount allowed by the Internal Revenue Service (“IRS”). In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes safe harbor matching contributions equal to 100% of 3% of eligible compensation. The Company may also elect to make a discretionary profit-sharing contribution to the Plan. Employees must meet (1) year of service to be eligible for the profit-sharing contribution. The Company did not make any discretionary profit-sharing contributions for the Plan year ended December 31, 2024.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, allocations of Company contributions, and Plan earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant’s account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant’s account.

#### *Investment Options*

Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan offers a selection of pooled separate accounts, a money market, and a guaranteed investment contract as investment options for participants.

**1. Summary Plan Description (Continued):**

*Notes Receivable from Participants*

Participants are permitted (1) outstanding loan at a time. Participants may borrow a minimum of \$1,000, up to 50% of their vested contributions and related earnings, not to exceed \$50,000. The loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions over a 5-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time that may up to a maximum of 30 years. Generally, notes receivable from participants include interest at 1% above the prime rate.

*Vesting*

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, safe harbor contributions, and actual earnings thereon. Vesting in the Company's profit-sharing and safe harbor contribution portion of their accounts plus actual earnings thereon is based on years of continuous service with 1,000 hours for a year of crediting service. All employer contributions become fully vested in the event of death, disability, or reaching the normal retirement age while under the Company's employment.

Participant vesting in employer discretionary profit-sharing contribution is as follows:

*Payment of Benefits*

On termination of service due to death, disability, or retirement or other reasons, a participant may elect to receive a lump-sum distribution equal to the vested balance in the individual participant's account in accordance with Plan provisions. Additionally, hardship withdrawals and certain other in-service withdrawals are also permitted by the Plan if certain criteria are met. Participants may elect to receive an in-service distribution after attaining the age of 59 ½. Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

*Administrative Expenses*

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. Administrative expenses paid by the Plan for trustee, recordkeeping and investment advisory services are allocated to participants proportionally based on the value of their account balances. Administrative expenses recorded in the Plan pertaining to distribution transaction fees are deducted directly from the applicable participant's account.

Management fees and operating expenses charged to the Plan for investments in pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**1. Summary Plan Description (Continued):**

*Forfeited Accounts*

Forfeitures of non-vested participant balances may be used to pay Plan expenses and reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,086 and \$68,083, respectively. The Plan used forfeited nonvested accounts totaling \$68,173 to reduce employer contributions during the Plan year 2024.

**2. Summary of Accounting Policies:**

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are presented at fair value, except fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relative measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

*Notes Receivable from Participants*

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are treated as a distribution to the participant based upon the terms of the Plan document. The loans are secured by the balance in the participants' accounts.

*Payment of Benefits*

Benefits are recorded when paid.

**2. Summary of Accounting Policies (Continued):**

*Risks and Uncertainties*

The Plan invests in a combination of investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**3. Fair Value Measurements:**

Financial Accounting Standards Board, Statement of Accounting Standards Codification Topic 820 ("ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Money market:* Valued at the amounts of cash balances on deposit, which approximates fair value (Level 1 inputs).

*Pooled separate accounts:* The value of the units held in pooled separate accounts is based on the net asset value ("NAV") of the units as a practical expedient to estimate fair value. NAV is determined by the security prices of the underlying investments which are listed on national securities exchanges and valued on the basis of year-end closing prices. While the underlying security prices are quoted prices, the NAV of a separate account is not publicly quoted.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Investment Contract with Insurance Company:**

The Plan invests in a guaranteed interest contract with Voya, which is a fully benefit-responsive investment contract. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Voya is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The credit rate is based on a formula established by Voya but may not be less than 1%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value of the guaranteed interest contract was \$946,840 and \$1,204,735 at December 31, 2024 and 2023, respectively.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: 1) participant termination, 2) removal from the Plan of one or more groups or classifications of participants, 3) partial or complete Plan termination or 4) Plan disqualification. In general, the following events would permit Voya to terminate the contract and settle at other-than-contract value: 1) the Plan's loss of its qualified status, 2) Plan termination, 3) uncured breaches of material obligations under the contract, or 4) advance notification by either party.

**5. Information Certified by the Plan's Custodian:**

The following investments included in the statements of net assets available for benefits as of December 31, 2024 and 2023 and the dividends and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 have been derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, custodian of the Plan, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

**6. Party-in-Interest Transactions:**

Certain Plan investments are in holdings managed by Voya Retirement Insurance and Annuity Company ("Voya"), the custodian of the Plan's assets and recordkeeper. Accordingly, transactions with Voya qualify as party-in transactions permitted under provisions of ERISA. Fees paid to Voya by the Plan for administrative expenses amounted to \$3,375 for the year ended December 31, 2024. Revenue received on investments managed by Voya related to revenue sharing may be applied to pay Plan expenses or allocated to participant accounts. During 2024, the Plan received \$57,391 in revenue sharing that reduced administrative expenses in the accompanying statement of changes in net assets

OneDigital Investment Advisors provide investment management and advisory services to the Plan. Accordingly, transactions with these companies qualify as party-in-interest transactions. During 2024, the Plan paid \$45,919 for investment management and advisory services.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$43,763 and \$0, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$3,440. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

**7. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

**8. Tax Status:**

The Plan was established under the Prototype Non-standardized Profit-Sharing Plan with CODA (the "Prototype Plan"). The Internal Revenue Service issued a determination letter dated June 30, 2020, stating that the Prototype Plan was in accordance with the applicable Plan designed requirements as of that date. The Plan as adopted and amended has not requested a determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement dates.

Management has evaluated the Plan's tax positions and concluded that as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of a liability (or asset) in the financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state or local tax authorities for tax years before 2021.

**9. Non-Exempt Transactions:**

The Company determined that during 2022 and 2023 it failed to remit employee deferrals within the appropriate time period totaling \$79,868 and \$80,536, respectively. Late or delinquent deferrals constitute prohibited transactions as defined by ERISA and are included in the accompanying supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions. Lost earnings related to the 2022 and 2023 late remittances have been calculated and remitted to the Plan.

**10. Subsequent Events:**

The Plan was amended effective January 1, 2025 to include safe harbor matching contributions equal to 100% of the first 3% of participant deferrals and 50% of participant deferrals between 3% and 5%. The safe harbor matching contribution will be calculated on an annual basis.

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be filed and has determined that, except as disclosed above, there were no material events requiring recognition or disclosure.
