The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AHMC 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We are required to be independent of AHMC 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about AHMC 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about AHMC 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



A. Description of Plan

The following description of the AHMC 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is sponsored by Alhambra Hospital Medical Center LP ("AHMC," the "Hospital," or the "Sponsor").

The Hospital established the Plan effective June 1, 2001. The Plan is a defined contribution plan wherein the Hospital has adopted the deferred compensation election under Section 401(k) of the Internal Revenue Code.

All employees of the Hospital are eligible to participate once they complete 90 days of service and are age 21 years or older. As of December 31, 2024, there were a total of 568 active participants.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Each participant may decide the amount of contribution on a before-tax basis or on an after-tax basis. The before-tax 401(k) savings contribution is subject to certain limits.

In 2024, participants could contribute up to the lesser of 60% of eligible compensation or \$23,000. Participants who attained age 50 by the end of the Plan year were eligible to make catch-up contributions up to \$7,500.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor makes matching contributions of 100% of the first 3% of eligible compensation of the participants each pay period, but not more than the actual contribution by the participants.

The Hospital may, at its discretion, contribute through the profit sharing feature of the Plan. The profit sharing contribution will be allocated to each eligible participant based on the ratio of the compensation.

The Hospital made contributions of \$1,210,463 for the year ended December 31, 2024.

A. Description of Plan (Continued)

3. Participant Accounts

Each participant account is credited with the participant's contribution, any matching contribution of the Sponsor, and an allocation of Plan earnings; each account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions made to these accounts are directed by the participant into a particular investment offered by the Plan, and the allocations between investments can be changed at will.

4. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the sponsor's portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of vesting service.

5. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the remaining vested balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through periodic payroll deductions.

6. Payment of Benefits

- a) A participant may apply for hardship withdrawal on his/her deferral contributions. Such a withdrawal is made on account of specific immediate and heavy financial need of the participant where such participant lacks other available resources.
- b) A participant may withdraw any part of his/her vested account at any time after s/he attains age 59 1/2.
- c) A participant may request a distribution due to disability, retirement, or termination of employment from the employer and any related employer.

7. Forfeited Accounts

At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$107,758 and \$33,946, respectively. These accounts are used to reduce future employer contributions and to offset the Plan's investment and administrative expenses. In 2024, participant forfeitures of \$69,392, and dividends of \$3,090 were added to forfeited non-vested accounts; employer contributions were reduced by \$0 from forfeited non-vested accounts; and net fees and adjustments of \$1,330 were added to such accounts.

B. Summary of Accounting Policy

The financial statements of the Plan are prepared under the accrual method of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Plan's investments in guaranteed interest accounts and pooled separate accounts are stated at fair value, which is based on the market value of the underlying assets of funds, as reported by Fidelity Investment Institutional Operations Company, Inc.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents.

Administrative expenses incurred in connection with the Plan are paid by the Plan, unless paid by the sponsor at its option.

Benefits are recorded when paid.

C. Investment Contract with Investment Company

In January 2006, the Hospital entered into an investment contract with Fidelity Management Company, Inc., which maintains the contributions in a pooled separate account. The account is credited with earnings on the underlying investments, and Plan withdrawal and administrative expenses are charged by Fidelity. The contract is included in the financial statements at fair value for interest in pooled separate accounts, as reported to the Plan by Fidelity, plus earnings, less Plan withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at fair value.

E. Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan not to make contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

F. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement, establishes a consistent framework for measuring fair value and expands disclosure requirements about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the FASB ASC 820 fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the net asset value (NAV) of shares held by the Plan at year end.

Money market fund: Valued at cost, plus earned interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

G. Revenue Credit Program Fee Refunds

The Plan participates in a revenue sharing program with the Plan's recordkeeper, whereby participant investments in certain funds are issued a revenue credit quarterly. These credits are allocated to participants' accounts as a refund of fees, and they may exceed the regular fees assessed to participant accounts. For the year ended December 31, 2024, the issued credits totaled \$104,699.

I. Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The Plan adopted the Fidelity Pre-Approved Profit Sharing Plan which has obtained a favorable tax determination letter from the Internal Revenue Service. Therefore, the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

J. Party-In-Interest Transactions

The trustee is a party-in-interest with respect to the Plan. All investments are held with the trustee. Notes receivable from Plan participants and the related interest income are also considered party-in-interest transactions. The sponsors of the Plan are also considered parties-in-interest with respect to the Plan. Late transfer to the Plan for participant contributions and loan repayments is a prohibited transaction. In 2024, there were no late transfers.

K. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

L. Subsequent Events

In preparing these financial statements, Plan management has evaluated events for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.
