**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Risk Management Programs, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## Notes to Financial Statements

### Risk Management Programs, Inc. Retirement Plan

##### Note A - Description of the Plan

The following description of the Risk Management Programs, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan covering all eligible employees of Risk Management Programs, Inc. (the “Company”) who have attained age 18, except excluded employees such as employees covered by a collective bargaining agreement and other job titles specified in the Plan agreement. The Plan also covers full-time, non-union employees of its sister company Metis Services, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective July 1, 2004. The Trustee is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

##### Contributions

Each year, participants may contribute a percentage of their pretax annual base compensation, as defined in the Plan, up to \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants elect the investment options in which contributions are invested and may change their investment options daily. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Under the Safe Harbor Election, the Company will contribute a matching contribution of 200% of the employees’ deferrals up to 6% of the employee’s eligible compensation for all eligible employees. Employees are eligible to receive this contribution after they have completed six months of service. In addition to making any Safe Harbor contribution, the Company may, at its discretion, make qualified nonelective contributions to the Plan. The Company did not make any qualified nonelective contributions in 2024 or 2023. Contributions are subject to certain limitations.

##### Participant Accounts

Each participant’s account is credited with the participant’s contribution and Company Safe Harbor matching contributions, as well as allocations of Plan earnings (losses) and charged with participant distributions and an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance. Loans bear interest at the current prime lending rate plus 1% and must be repaid over a period not to exceed five years unless used to purchase the participant’s primary residence. Loans are secured by the participant’s account balance. Loans are repaid through payroll deductions including principal and interest. The principal portion reduces the receivable from participants and both principal and interest are transferred to the participant’s investment options as repayments are received.

###### Vesting

Participants are immediately vested in their voluntary contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's qualified nonelective plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

###### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals for participants who must receive required minimum distributions. In-service distributions may be made by employees who have attained the age of 59 ½. Hardship withdrawals are allowed to satisfy specific needs as defined by the Plan, after exhausting all other means available including in-service withdrawals and loans. For a termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

###### Forfeitures

During the year ended December 31, 2024, forfeitures totaling \$58 were added to the Plan's forfeiture account. In accordance with the provisions of the Plan, forfeitures may be used to reduce future employer contributions or to pay allowable plan expenses. There were no forfeited non-vested accounts during the year ended December 31, 2023.

##### Note B - Summary of Significant Accounting Policies

###### Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

###### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

###### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses have been recorded at December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefits are recorded when paid by the Plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation/reduction of fair value of investments.

**Note C - Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held, net appreciation in fair value of investments, interest and dividends as of and for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (the Trustee).

##### Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

##### Note E - Party-in-Interest Transactions

Certain Plan investments are managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are considered to be party-in-interest transactions because they are transacted with the Plan participants.

##### Note F - Tax Status

The Plan is an adoption of a Prototype Non-Standardized 401(k) Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, in which the IRS stated that the Prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, and the Prototype Plan has been amended since receiving the determination letter. However, the Plan's management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and therefore, the Plan and related trust continue to be tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

##### Note G - Plan Termination

Although the Company has not expressed any intention to do so, it has the right under the terms of the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note H - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and amounts reported in the financial statements.

#### **Note I - Subsequent Events**

The Plan management has evaluated all subsequent events through October 6, 2025, which is the date these financial statements were available to be issued.
